INDEPENDENT AUDITOR'S REPORT

To the Plan Oversight Committee
INTRUST 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of INTRUST 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from INTRUST Bank, N.A., the trustee of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTE A - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Document (including the Adoption Agreement) for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 1986, is a defined contribution plan covering employees of INTRUST Financial Corporation (IFC) and INTRUST Bank, N.A. (INTRUST) (collectively referred to as the Company). Effective January 1, 2023, employees become eligible to participate in the Plan on the first day of the month coinciding with or next following the attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants are automatically enrolled to make pre-tax contributions of 6% of their annual compensation as defined by the Plan. A participant may elect in writing not to contribute any amount or to make pre-tax and Roth after-tax contributions of more or less than 6% (but no less than 1%), not to exceed 75% of their annual compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain Internal Revenue Code limitations.

Participants direct the investment of their deferrals into various investment options offered by the Plan. These elections can be modified on a daily basis taking into account weekends and other days the Company or markets are closed.

All eligible plan participants receive a fixed safe harbor match of 100% of elective deferrals that do not exceed 6% of qualified compensation. The employer match will be immediately vested. In addition to the enhanced employer match, the Company also implemented an annual non-elective contribution (NEC) of 3% of qualified compensation for eligible, active participants on the last day of the plan year. Included in contributions receivable, the NEC receivable at December 31, 2024 and 2023 totaled \$854,320 and \$760,940, respectively. The Company does not make additional discretionary matching contributions.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts can be used to pay reasonable plan expenses or to reduce future employer contributions. During 2024, forfeitures utilized to reduce employer contributions totaled \$55,370. Unallocated forfeitures at December 31, 2024 and 2023 totaled \$11,375 and \$6,192, respectively.

Participant Accounts

Each participant's account is credited with the participant's deferral and an allocation of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from the Plan using their vested account balance as collateral. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Participant loans bear a reasonable rate of interest based on current external market rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions or another method approved by the plan administrator. A participant may only have one loan outstanding.

Vesting

Participants are immediately vested in their voluntary deferrals and matching contributions plus actual earnings thereon. Vesting in the NEC is on a three-year cliff vesting schedule as follows:

Payment of Benefits

On termination of service due to death, disability, retirement, or other reason, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested account, a partial distribution, or periodic installments, as defined by the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements of the Plan have been prepared using the accrual method of accounting and present the net assets available for plan benefits and changes in those net assets based on fair value.

Investments

All investments are stated at fair value, which is based on quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid. There were no withdrawals requested but unpaid at December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account shall be fully vested and nonforfeitable.

NOTE D - PLAN EXPENSES

Plan expenses including administration, consulting, and accounting services are paid by the Company and are excluded from these financial statements. Fees related to investment management and administration of notes receivable from participants are included in operating expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

NOTE E - TAX STATUS

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - CONCENTRATIONS

Four funds with the highest value comprised approximately 40% and 39% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

FASB ASC 820-10, Fair Value Measurement, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were used by the Plan.

Level 1 Fair Value Measurements

The Plan invests in the Federated Hermes Government Obligation Fund, which is a highly liquid money market fund and is considered to be a cash equivalent.

NOTE G - FAIR VALUE MEASUREMENTS (Continued)

The fair value of money market fund and mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The self-directed brokerage accounts consist mostly of stocks, the fair value of which is based on quoted market prices of the specific investments held by the Plan at year end.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - RELATED PARTY TRANSACTIONS

Plan investments are in custodial control and managed by INTRUST Bank, N.A., the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest.

The Plan issues notes to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party in interest transactions.

A member of the Plan Oversight Committee held a \$20,000 participant note, with an outstanding balance of \$2,880 at December 31, 2024.
