## NOTES TO FINANCIAL STATEMENTS December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of Hoffmann Brothers Heating & Air Conditioning 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Hoffmann Brothers Heating & Air Conditioning and affiliates (the Company). Charles Schwab Trust Bank (Charles Schwab) serves as the custodian and the record keeper is EPIC Retirement Plan Services (EPIC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

Employees are eligible to participate in the Plan upon reaching the age of 18 and who are not defined as part-time, temporary or seasonal employees. Part-time, temporary and seasonal employees are defined as employees whose regularly scheduled service is less than 1,000 hours of service in the relevant eligibility computation period. However, if any such excluded employee actually completes a year of service, then such employee will no longer be part of this excluded class. Participants become eligible on the first day of the quarter following the date the eligibility requirements are met.

#### **Contributions**

Employees are eligible to start making contributions immediately upon satisfying the eligibility requirement. Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan Agreement, not to exceed certain Internal Revenue Service (IRS) limitations. Salary deferral contributions can be made as pre-tax, Roth, or after-tax contributions or any combination thereof. Participants over the age of 50 are eligible for catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan provides for a safe-harbor matching contribution. The Company contributes an amount equal to 100% of employee deferrals (including any catch-up deferrals) up to 4% of compensation. The Company can also make non-safe harbor matching contributions during the year. The Company's safe-harbor matching contribution to the Plan was \$981,295 and \$927,899 for the years ended December 31, 2024 and 2023, respectively.

The Plan also provides for discretionary profit sharing contributions. Discretionary profit sharing contributions are determined annually by the Company and are allocated to certain classifications of eligible participants as defined in the Plan Agreement. Discretionary profit sharing contributions are allocated using a fixed percentage of eligible compensation. There is no service requirement, however eligible participants must be employed as of the last day of the Plan year. Discretionary profit sharing contributions were \$652,364 and \$619,506 for the years ended December 31, 2024 and 2023, respectively.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's safe-harbor matching contributions and an allocation of Company discretionary profit sharing contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Vesting**

Participants are immediately vested in their contributions, Company safe-harbor contributions, and rollover contributions. Vesting in the Company's discretionary profit sharing contributions portion of their account is based on years of service. A participant vests 20% each year after the second year of service and is fully vested after six years of service. Participants also fully vest upon reaching normal retirement age (age 59 1/2), death, or total and permanent disability.

#### **Forfeitures**

Forfeitures of nonvested benefits are used to pay administrative expenses related to the operation of the Plan. Remaining forfeitures, if any, are used to reduce any Company contributions. Forfeitures used to fund Company profit sharing contributions amounted to \$54,394 and \$48,245 for the years ended December 31, 2024 and 2023, respectively. Forfeitures used to pay administrative expenses amounted to \$3,800 and \$3,528 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$51,701 and \$44,726, respectively.

#### **Payment Of Benefits**

Upon termination of employment, retirement or death, a participant's vested balance may be distributed in a lump sum, installment payments, or partial payments.

**In-Service And Hardship Withdrawals**

Participants age 59 ½ or older can take an in-service withdrawal. A participant may also take an in-service withdrawal in the event of undue financial hardship.

**Administrative Expenses**

Plan administration, custody, and advisory fees are paid by the Plan. All other fees are paid by the Company.

**Reclassifications**

Certain 2023 amounts have been reclassified, where appropriate, to confirm to the presentation used in the 2024 financial statements.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year, and includes any realized gains and losses in securities that were bought and sold during the year.

**Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Investment Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Charles Schwab, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Charles Schwab that the information provided to the Plan Administrator related to the following information is complete and accurate.

#### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the standards are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Collective Trust Funds**

Valued at the net asset value (NAV) of units of bank collective trusts. The NAV, as provided by trustees of the funds, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Party In Interest Transactions**

The Plan pays EPIC, Moneta Group LLC, and Charles Schwab Trust Bank for various administrative services. These transactions qualify as party in interest transactions allowable under ERISA.

### **6. Risks And Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **8. Income Tax Status**

The Plan uses a pre-approved plan document sponsored by EPIC. EPIC received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
