Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Kroenke Sports 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Kroenke Sports 401(k) Savings Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-collectively bargained employees of Kroenke Sports & Entertainment, LLC and its subsidiaries, including Colorado Avalanche, LLC; Denver Nuggets Limited Partnership; KS LAX LLC; KSE Soccer, Inc.; Opera Shop; KSE Media Ventures, LLC; KSE Radio Ventures, LLC; World Fishing Network, LLC; Outdoor Channel Holdings, Inc.; The Outdoor Channel Inc.; Winnercomm, Inc.; SkyCam, LLC; CableCam, LLC; Intermedia Outdoors, Inc.; The Sportsman Channel, Inc.; W.T. Waggoner Estate; Q Creek Land & Livestock Company; Kroenke Land & Livestock Cattle Company; PV Ranch Company LLC; Broken O Land & Livestock LLC; Vaca Ranch LLC; Geronimo Ranch LLC; Cool Hand Vineyards LLC; Screaming Eagle Partners LLC; Ruby Land & Cattle Company LLC; TKG Management, Inc.; Western Skies Management, Inc.; J & J Grounds Maintenance, Inc.; Western Skies Realty Inc.; Maintenance & More Contracting, Inc.; and Canon Blanco, LLC.

The Plan is sponsored by Kroenke Sports Holdings, LLC (the "Company"). Employees are eligible to participate in the Plan and are eligible for employer discretionary matching contributions and profit-sharing contributions upon completion of three months of employment and upon attaining the age of 18. The Plan excludes employees covered by a collective bargaining agreement.

Administration

The Company is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Fidelity Management Trust Company (the "Trustee") functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 60 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 60 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

During 2023, the Company remitted certain employee deferrals and participant loan payments to the Plan after the time frame required by the Department of Labor. The Company remitted these contributions and lost earnings to the Plan in January 2024.

The Company may make discretionary matching contributions. Participants who have completed 12 months of service will be eligible to receive an allocation of the Company's discretionary matching contribution. Matching contributions are based on 50 percent of the first 6 percent of eligible compensation deferred by a plan participant. For the year ended December 31, 2024, discretionary matching contributions were \$2,646,692. The Company may also make discretionary profit-sharing contributions. No profit-sharing contributions were made to the Plan during the year ended December 31, 2024.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Participants may have a maximum of one note outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 10.5 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator. Loans have a maximum term of 5 years unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 10 years from the date of the loan origination. Participant notes receivable mature at various dates through September 2034. Principal and interest are paid ratably through monthly payroll deductions. Upon termination of a participant from employment, the participant's loan shall continue to be payable in accordance with the provisions of the participant's loan or be due in full.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings and losses, and forfeitures used to pay company contributions for terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in employer matching contributions made by the Company 100 percent after two years of service.

Service with predecessor employers is counted for vesting purposes. The Company's discretionary contributions, if any, vest according to the following schedule:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 59½ or, if later, the fifth anniversary date of the first day of the plan year during which the participant entered the Plan) while an employee, retirement due to disability, or termination of the Plan.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Note 1 - Plan Description (Continued)

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$155,989 and \$82,504, respectively. Forfeitures in amount of \$3,552 were applied to reduce plan fees during the year ended December 31, 2024.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Investments in mutual funds are reported at the last reported sale price at the end of the respective periods using quoted market values.

The common/collective trust fund is valued at net asset value per share (NAV) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

Various administrative costs are paid by the Company.

Revenue Sharing

The Plan has a revenue-sharing agreement where participants receive a credit against their expenses for investing in the Trustee's investment options. During the year ended December 31, 2024, the Plan received approximately \$203,523 in revenue credit from the Trustee, which is included in administrative expenses on the statement of changes in net assets available for benefits.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Assets Certified by the Trustee

Fidelity Management Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

The plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's auditors not to perform any auditing procedures with respect to the asset information certified by the Trustee except for comparing the information contained therein to information included in the financial statements and the supplemental schedule of assets held at end of year.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Note 4 - Fair Value Measurements (Continued)

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 6 - Related Party and Party-in-interest Transactions

Certain plan investments are mutual funds, which are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the asset trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. In addition, the Plan provides for participant notes receivable, which are also party-in-interest transactions that are exempt from the prohibited transaction rules.
