We have performed audits of the accompanying financial statements of INDAK MANUFACTURING CORPORATION PROFIT SHARING PLAN AND TRUST, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1—PLAN DESCRIPTION**

The following brief description of the Indak Manufacturing Corporation (Company) Profit Sharing Plan and Trust (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

The participants in the Plan are the employees of Indak Manufacturing Corporation. The Plan is a defined contribution plan covering all employees who have completed at least six months of service. Effective January 1, 2005, employees shall also include any employee who was an employee of Borg Indak, Inc. and is employed by Indak Manufacturing Corporation on or after January 1, 2005. Also, Hours of Service shall also include hours of service with Borg Indak, Inc. The Plan includes an income deferral option, which qualifies under Section 401(k) of the Internal Revenue Code. Under this option, participants direct the investment of the contributions into various investment options offered by the Plan. Annual company contributions are at the discretion of the Board of Directors. Starting July 1, 2007, the Company makes quarterly contributions to each of the eligible employees' 401(k) plan accounts, which equals to 3% of each participant's income earned during the period.

Effective November 18, 2024, the Plan received funds as a result of the termination of the plan sponsor's pension plan. As a result, assets of \$931,033 were transferred into the Plan of which \$59,321 were used to satisfy the 4<sup>th</sup> quarter safe harbor contribution. The remaining funds will be used to fund the employer safe harbor contribution for future years.

Participants may choose to contribute by payroll deduction up to 100% of their compensation, to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants who are at least age 50 may make additional "catch-up" contributions of \$7,500 in 2024 and 2023.

Participants are 100% vested in their voluntary contributions, rollover contributions and employer's safe harbor contributions, plus actual earnings thereon. Each participant's vesting in their matching and discretionary Company contribution account is determined in accordance with a schedule based on the participant's years of service.

Forfeited balances of terminated participants' non-vested accounts are used to reduce the employer's contribution or administrative expense. Forfeited non-vested accounts totaled \$-0- for 2024 and 2023. No forfeiture was reallocated to participants in 2024 and 2023. Forfeitures utilized to pay administrative expenses were \$-0- for 2024 and 2023.

The employer's contribution and forfeitures are allocated to each participant on the basis of both 1) compensation, subject to certain limitations, and 2) years of service, to a maximum of ten years.

Each participant's account is credited with participant's contribution, the Company's safe harbor contribution, and Company's discretionary contributions, if applicable, and Plan earnings.

A participant will be eligible for normal retirement on the first day of the month next following the participant's 65th birthday.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of the defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments, other than the Morley Stable Value Fund, are stated at fair value at December 31, 2024 and 2023. If available, quoted market prices are used to value investments. Investments having no quoted market price are reflected at their estimated fair value as determined by the investment manager. Investments in mutual funds are valued at the net asset value of shares held by the Plan at year-end.

Morley Stable Value Fund (Fund), a common collective trust (“CCT”), is invested primarily in guaranteed investment contracts (“GICs”) and synthetic investment contracts, and cash and cash equivalents. GIC and synthetic investments contracts are fully benefit-responsive investment contracts. The Fund is stated at contract value (principal balances of the contracts, plus accrued interest at the stated rate, less payments received and contract charges by the insurance company), which is approximate fair value, as determined by Charles Schwab Trust Bank. The contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The market yield for the underlying investments in the Fund was 1.79% – 2.86% for 2024 and 1.72% - 2.79% in 2023; with blended net crediting rate of 2.85% on December 31, 2024 and 2.76% on December 31, 2023.

Market value events may limit the ability of the Fund to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract or wrap issuer’s interest hereunder.

Such events may include but are not limited to: Fund administration is amended or changed, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the Fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the Fund, transfers to competing options without meeting the equity wash provisions of the Fund, and plan sponsor withdrawals without the appropriate notice to the Fund and/or issuer.

In the normal course of business, such events or conditions would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event.

Net appreciation (depreciation) on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year. Dividends, interest, and appreciation (depreciation) are included in investment income (loss).

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**PAYMENT OF BENEFITS**

Benefit payments to participants are recorded upon distribution.

**ADMINISTRATIVE EXPENSES**

Expenses of the Plan, to the extent that the Company does not pay such expenses, may be paid out of the assets of the plan.

**NOTE 3—FAIR VALUE MEASUREMENTS**

FASB Accounting Standards Codification (FASB ASC) 820 *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

**NOTE 3—FAIR VALUE MEASUREMENTS (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

*Level 2 and Level 3 Fair Value Measurements*

Level 2 and Level 3 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4—INFORMATION CERTIFIED BY THE CUSTODIAN OF THE PLAN'S ASSETS**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits, as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits, for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H, Line 4i.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5—TAX STATUS**

The Plan obtained its latest favorable determination letter on March 1, 2011, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6—RELATED PLANS**

Indak Manufacturing Corporation also had a defined benefit plan which was terminated (see Note 1).

For the purpose of computing statutory limitations of the maximum company contribution to a participant's account, all plans are aggregated.

**NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, expenses of the Plan are paid by the Company.

The Plan's investments are managed by Charles Schwab Trust Bank which is considered a party-in-interest. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 8—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 9—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 26, 2025, the date which the financial statements were available for issue. There were no other subsequent events which require disclosure.
