## Independent Auditors' Report

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Burke Rehabilitation Hospital 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### **1. Description of Plan**

The following description of the Burke Rehabilitation Hospital 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan was formed January 2, 2018 (inception) and is a defined contribution plan of The Winifred Masterson Burke Rehabilitation Hospital (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Eligibility***

For purposes of salary deferral contributions, substantially all employees of the Employer are eligible to participate in the Plan upon their first day of employment. For purposes of salary deferral contributions, there is no age or service requirement.

For Employer matching and nonelective contributions, an employee must be at least 18 years of age and have completed one year of service to be eligible to receive these contributions. Employees are not eligible to receive nonelective contributions if they are: a per diem employee; considered a highly compensated employee; or considered a non-highly compensated employee with less than twenty consecutive years of service as of December 31, 2017 in The Burke Rehabilitation Hospital Retirement Plan.

#### ***Contributions***

Each year, eligible employees may elect to contribute a percentage of their annual compensation on a pre-tax or Roth basis, subject to limitations established by the Internal Revenue Code ("IRC"). The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 2% of their eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes a nonelective safe harbor contribution each pay period of 3% of a participant's eligible compensation. Effective September 1, 2024, the Plan was amended to increase the nonelective safe harbor contribution from 3% to 6% of a participant's eligible compensation each pay period. For the 2024 Plan year, the Employer made safe harbor contributions amounting to \$2,287,240. The Employer makes a matching contribution each pay period equal to 50% of a participant's contributions not to exceed 2% of their eligible compensation. For the 2024 Plan year, the Employer made matching contributions amounting to \$556,063. Additionally, the Employer makes a nonelective contribution for eligible employees in an amount of 1% of a participant's eligible compensation per pay period. For the 2024 Plan year, the Employer made nonelective contributions amounting to \$26,660.

### **1. Description of Plan (*continued*)**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are 100% vested in their accounts at all times.

#### ***Revenue Credit Account***

Revenue Credits are earned when mutual funds in the Plan generate more revenue credits to the provider (Fidelity) than the plan provider (Fidelity) charges to administer the Plan. These excess credits are allocated back to all eligible participants on a pro rata quarterly basis based on the size of their account balance in the Plan. The eligible credits for the 2024 plan year totaled \$8,680 and were included in administrative expenses on the statement of changes in net assets available for benefits

#### ***Payment of Benefits***

Benefits are paid upon retirement (age 65), death, disability, or termination of employment. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of the participant's account, an annuity contract to be distributed under an option of the participant's choice, or a combination of both. In-service withdrawals are allowed at age 59 ½ for the participants account balance sourced from employee contributions (pre-tax and/or Roth after-tax), from all or any part of the participants account balance sourced from rollover contribution or in the event of a hardship as defined by the Plan.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

#### ***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of \$50,000 or 50% of their vested account balance (whichever is less). A participant may not have more than two loans outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. The loan must be repaid within a five-year period, unless the loan is used to acquire the principal residence of the borrower, which must be repaid within fifteen years from the date of the loan. Principal and interest is paid ratably through payroll deductions.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan’s investments are stated at fair value, except for the group annuity contract, which is stated at contract value. The mutual funds and money market fund held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of these funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. These funds are deemed to be actively traded. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus interest credited, less withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 8, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### 4. Group Annuity Contract

The Prudential Principal Preservation Separate Account (“Account”) is a group annuity product issued by Prudential Retirement Insurance and Annuity Company (“PRIAC”). The Account invests in a broadly diversified portfolio of fixed income instruments (primarily in intermediate-term bonds, private placements and commercial mortgages).

Principal and accumulated interest are fully guaranteed by PRIAC. Amounts contributed are deposited in the Account. A guaranteed interest rate is announced in advance and is guaranteed for a six-month period. Payment obligations and the fulfillment of any guarantees specified in the contract are supported by the assets in the Account. If such assets are not sufficient, the Account is backed by a diversified portfolio of fixed-income assets held in the general account of PRIAC. Principal and accumulated interest are fully guaranteed by PRIAC.

Restrictions or fees may apply to exchanges or withdrawals. The Account provides for the payment of certain withdrawals and exchanges at contract value. In order to maintain the issuer’s promise to pay such withdrawals and exchanges at contract value, the contracts subject the Account and its participants to certain restrictions. For example, withdrawals prompted by certain events (e.g., layoffs, early retirement windows, spin-offs, sale of a division, facility closings, plan terminations, partial plan terminations, changes in laws or regulations) may be paid at the market value of the Account’s securities, which may be less than your contract value balance or may restrict withdrawals in these events.

Certain investment options offered by the Plan may be deemed a competing fund. The terms of the contracts prohibit a participant from making a direct exchange from the Account to such competing funds. Instead, a participant must first exchange to a non-competing fund for 90 days. While these requirements may seem restrictive, they are imposed as a condition for the issuer’s promise to pay certain withdrawals and exchanges at contract value.

### 4. Group Annuity Account (*continued*)

Since the Account is fully benefit-responsive, it is presented at contract value on the statements of net assets available for benefits.

### 5. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, Fidelity Workplace Services LLC, dated August 7, 2017, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 6. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are presented as notes receivable from participants on the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Employer who may also be participants in the Plan. No such officer or employee receives compensation from the Plan.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Burke Rehabilitation Hospital 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

Our consideration of internal control was for the limited purpose described in the two paragraphs above and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

## **Auditors' Communication with Those Charged with Governance**

### **The TDA Plan Committee of Burke Rehabilitation Hospital 403(b) Plan**

We have audited the financial statements of Burke Rehabilitation Hospital 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) as of and for the year ended December 31, 2024, and we issued our report thereon dated October 8, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("U.S. GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated January 20, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### **Qualitative aspects of significant accounting practices**

#### *Significant accounting policies*

Plan management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

#### *Significant accounting estimates*

Accounting estimates made by the Plan's management are an integral part of the financial statements and are based on Plan management's knowledge and experience about past and current events and assumptions about future events.

Certain accounting estimates are particularly sensitive because of their significance to the financial statements and their susceptibility to change. Management believes that the estimates used and assumptions made are adequate based on the information currently available. We evaluated the key factors and assumptions used to develop the estimates in relation to the value of the Plan's investments in determining that they are reasonable in relation to the financial statements as a whole.

#### *Financial statement disclosures*

The financial statement disclosures are consistent and clear.

#### *Going concern*

We concur with management's assessment that the Plan will continue as a going concern for one year from the auditors' report date.

#### *Significant risks*

We have identified the following significant risks in connection with our audit:

- Revenue recognition; and
- Plan management override of controls.

#### *Form 5500 procedures*

We are required to obtain and read a substantially completed draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties encountered during the audit*

We encountered no significant difficulties in performing and completing our audit.

#### *Corrected and uncorrected misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. No misstatements were identified during our audit.

#### *Disagreements with management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Representations requested from Plan management*

We have requested certain written representations from the Plan's management in a separate letter dated October 8, 2025.

*Management consultations with other independent accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditors’ opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

*Other matters discussed with Plan management*

We generally discuss with the Plan’s management a variety of matters, including the application of accounting principles and auditing standards, business conditions affecting the Plan, and future plans and strategies that may affect the risks of material misstatement. None of the matters discussed and our responses thereto were a condition to our retention as auditors.

*Other matters supplemental schedule*

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).
