In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4a – Schedule of Delinquent Contributions for the year ended December 31, 2024 and Schedule H, Line 4i – Schedule of Assets Held as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 – DESCRIPTION OF PLAN

The following description of Dial Packaging 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan was established effective January 1, 1974 by Lewisburg Printing, Inc. (the “Company”) as a defined contribution plan. The Plan is a safe harbor plan covering eligible employees of the Company and three related employers (the “Employers”). The Plan provides retirement, disability and death benefits for all eligible employees electing to participate. The Plan was amended and restated effective January 1, 2021. The Plan incorporates provisions to permit qualification under Section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (“ERISA”).

Effective January 1, 2024, the LPC, Inc. 401(k) Plan changed its name to the Dial Packaging 401(k) Plan. The Plan continues to operate under the same provisions, except for the name change.

Eligibility and Entry: Employees are eligible to become a participant in the Plan after completing 1 year of service (12 consecutive months of employment during which they are credited with 1,000 or more hours of service) and attaining age 18. Once an employee is eligible to enter the Plan, they may become a participant on the following January 1st or July 1st.

401(k) Contributions: Each year, participants may contribute 100% of pretax annual compensation, as defined in the Plan. However, they cannot exceed the statutory limit of \$23,000 for the year ended December 31, 2024. Employees over age 50 may contribute additional catch-up contributions of \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Employers match 100% of the first 3% contributed by the employee and 50% of the next 2% contributed by the employee in accordance with the safe harbor regulations. The Employers may make nonelective contributions on a discretionary basis. No nonelective contributions were made during 2024.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and allocations of the Employers’ contributions, if applicable, and plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting: Participants are immediately 100% vested in their contributions and employer safe harbor match contributions plus actual earnings thereon. A participant’s vested right in non-safe harbor Employer contributions is based on their years of credited employment. A year of credited employment for vesting purposes is defined as any Plan year in which an employee completes 1,000 hours of service. An employee becomes fully vested in the employer account if they die, become disabled, or on the day they become 62. Vesting in their allocated share of non-safe harbor Employer contributions and Plan earnings thereon occurs in accordance with the following schedule:

Forfeitures: Participant forfeitures of employer contributions are reallocated to the remaining participants, based upon their relative account balances. Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. No forfeiture balance was available for use at December 31, 2024 or 2023. No forfeitures were used for the year ended December 31, 2024.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes are generally repaid over a period of 60 months through payroll deductions. Interest rates on participant loans are set at the time of origination at 1% above the prevailing prime rate.

Distributions: Upon termination of service (as defined in the Plan document), death, disability or retirement, a participant or their beneficiary may receive payment of the vested interest in their account balance as a lump sum distribution or, if the participant is subject to lifetime required minimum distributions, in installments. Benefit amounts under \$1,000 are automatically distributed to participants

In-Service Withdrawals: Participants can receive distributions from elective deferrals upon reaching age 59 ½. Participants who have reached age 62 can also receive distributions from matching contribution, safe harbor contributions and nonelective contributions. Participants can also withdraw funds from their rollover accounts at any time. Hardship withdrawals from the participant's elective deferral account are not permitted under the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, the participants employed by the Company as of the date of termination will become fully vested in their accounts.

Investment Options: Upon enrollment in the Plan, the participant may direct their contribution accounts, and any earnings, thereon, to certain investments allowed by the Plan. Participants may change their investment options at any time.

Plan Transfer: During the year ended December 31, 2024, total assets of \$5,923,374 were transferred from the Empower Plan to the Dial Packaging 401(k) Plan. These transfers were recorded at the fair/contract value of the assets on the date of transfer and are reflected in the accompanying financial statements as an addition of net assets available for benefits. The transfer did not result in any gain or loss to participants, as account balances were moved on a dollar-for-dollar basis.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Expenses: Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. A portion of expenses for maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Certain direct administrative expenses are paid by the Plan and are included in administrative expenses. Investment related expenses are included as a reduction of investment income.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various investment options in pooled separate accounts. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, and the sensitivity of certain fair value estimates in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

A description of the valuation methodologies used for assets measured at fair value is as follows:

Pooled Separate Accounts: All of the Plan's investments are units of pooled separate accounts. The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the pooled separate accounts held by the Plan is a passively managed fund that invests in a particular type of securities indicated by the pooled separate account's name. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the trustee of the Plan).

NOTE 5 – TAX STATUS

On January 1, 2021 the Plan was restated. A new determination letter dated June 30, 2020 was received as part of the restatement. The Internal Revenue Service (“IRS”) issued opinion letter indicates that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently not audits for any tax periods in progress. The Plan is not subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of pooled separate accounts managed by John Hancock Life Insurance Company U.S.A. (“John Hancock”). John Hancock is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of fees to John Hancock qualify as party-in-interest transactions.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 2, 2025, which is the date the financial statements were available to be issued.
