INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
Emeriti Retiree Health Plan for Connecticut College

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Emeriti Retiree Health Plan for Connecticut College (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (“financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Alta Trust as of December 31, 2024 and for the period from December 17, 2024 to December 31, 2024, and Teachers Insurance and Annuity Association of America (“TIAA”), as of December 31, 2023 and for the period January 1, 2024 to December 16, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C)

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Emeriti Retiree Health Plan for Connecticut College and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i-Schedule of Assets (Held At End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
Emeriti Retiree Health Plan for Connecticut College

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Emeriti Retiree Health Plan for Connecticut College (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (“financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Alta Trust as of December 31, 2024 and for the period from December 17, 2024 to December 31, 2024, and Teachers Insurance and Annuity Association of America (“TIAA”), as of December 31, 2023 and for the period January 1, 2024 to December 16, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C)

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Emeriti Retiree Health Plan for Connecticut College and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i-Schedule of Assets (Held At End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Emeriti Retiree Health Plan for Connecticut College (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. In the event that there is a conflict between information provided in this document and the benefit Plan documents, the terms in the Plan document will prevail.

Connecticut College (the “College” or “Employer”) is the Plan Sponsor and administrator of the Plan. The Plan is funded through two trusts, the Employee Voluntary Employees’ Beneficiary Association (“VEBA”) Trust of Connecticut College and the Employer VEBA Trust of Connecticut College. The Trust is a special type of trust where the contributions and earnings thereon are not taxed.

For the year ended December 31, 2023 and the period from January 1, 2024 – December 16, 2024, the net assets of the Plan were held at TIAA. The Plan was amended in September 2024 by the College and The Emeriti Retirement Health Solutions (“ERHS”), a not-for-profit company to appoint OneBridge as the third-party administrator of the Plan and to transfer the funds to the OneBridge platform, effective December 17, 2024. For the year ended December 31, 2024 and the period from December 17, 2024 to December 31, 2024, the Plan’s net assets were held in a YourWay Master Trust, whereas Alta Trust is the Master Trustee.

The Plan was also amended during the year to increase fees charged for the services performed by Emeriti and the third-party services providers and to update the percentage of the employer fee committed by each participant by status.

General Information

The Plan is a defined contribution plan sponsored by the College covering all employees at least 21 years of age (“Participants”). Certain employees such as employees hired on a seasonal basis, employees regularly scheduled to work less than twenty hours of service per week, and student employees are excluded from the Plan. The Plan reimburses participants for the cost of eligible medical expenses, as set forth in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Retirement Plan Oversight Committee (“RPOC”) is responsible for oversight of the Plan. The RPOC determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Finance Committee of the College’s Board of Trustees

Benefits

A participant who is employed by the College meets the retirement eligibility for access to health insurance options provided through Emeriti upon attaining age 60 and having performed at least 5 years of continuous service. Upon meeting this retirement eligibility, participants are reimbursed for allowable medical expenses, including premiums for health insurance coverage for themselves, their spouse, and their dependents. The Emeriti health insurance options are underwritten by Aetna Life Insurance Company and provide Medicare supplemental coverage beginning at age 65.

Contributions

Participants may elect to make after-tax contributions, commencing with their date of hire, provided they meet the eligibility requirements as defined in the Plan document. Participants may contribute any amount to their accounts, subject to amounts permitted under the Internal Revenue Code (“IRC”). All investments are participant directed and may be changed at any time by the participants.

For eligible employees, the College will contribute a flat dollar amount with annual increases at the discretion of the College. The College begins making employer contributions for eligible employees on the first of the month following the date he or she attains the age of 40 and completes two years of service. The College ceases making employer contributions when the College has made contributions for 25 years, the employee is terminated, or if the participant dies.

In addition, the College will make contributions to the accounts of certain eligible retirees, as defined in the Plan document, towards the cost of Medicare supplemental health insurance beginning when the retiree reaches age 65. Annual payments are based on the age of the retiree as of July 1, 2007 (Plan inception) and will continue until death. Payments are suspended immediately upon the reemployment of such individuals and payments are resumed when individual once again retires from the College.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the College’s contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transaction fees. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant’s vested account.

Vesting and Forfeitures

Participants are immediately vested in both employer and employee contributions and earnings thereon. Employer and employee contributions and accumulated earnings are available for reimbursement for future medical expenses. The residual balance (if any) remaining after a participant and any eligible dependents are deceased, is forfeited to the Plan.

Forfeited accounts from the Employer-Contribution Forfeiture Account will be used to pay eligible administrative expenses of the Plan or fund any future College contributions with any remaining balance allocated to the Plan participants. Forfeited accounts from the Employee-Contribution Forfeiture Account will be allocated to the Plan participants.

2. *Summary of Significant Accounting Policies*

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's assets are held in a Master Trust. The Plan's investments in the Master Trust represents the Plan's interest in the net assets of the Master Trust. The Master Trust is based on the beginning of the year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment income less actual Plan distributions and expenses.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The RPOC determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussions on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and/or losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and the trustee. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the College on behalf of the Plan and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Management's Date of Review

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

3. Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Alta Trust, as of December 31, 2024 and for the period from December 17, 2024 to December 31, 2024 and TIAA for the year ended December 31, 2023 and for the period from January 1, 2024 to December 16, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

4. Interest in Master Trust

The Plan's held in the Master Trust is commingled with other benefit plans. Each participating Plan's interest in the Master Trust is divided based on the participant's investment elections. The allocation of income and expenses is based upon each Plan's specific interests in the underlying funds which are based upon participant-direction and College's direction of the investments. The combination of the benefit Plan's assets is only for investment purposes, and each plan continues to be operated under its correct Plan documents.

The allocation of the Master Trust activity represents the Plan's share of the net investment income on investments held by the Master Trust determined by the Plan's allocable share of the net assets of the Master Trust. The net investment income is the realized gains or losses from investments sold, changes in unrealized gains or losses on investments, dividend, and interest income of the Master Trust.

The net assets were transferred to a Master Trust on December 17, 2024, therefore, no net assets for the year ended December 31, 2023 and for the period from January 1, 2024 to December 16, 2024 were held in a Master Trust.

5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair Value Measurement, Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment companies: Invested primarily in mutual funds, including money market funds.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's assets at fair value in the Master Trust and the Plan's interest in the Master Trust as of December 31, 2024 and 2023 by level is as follows:

All investments in the Master Trust are mutual funds. Mutual funds are level 1 assets. The total level 1 assets as of December 31, 2024 were \$470,332,663. No investments were held in the Master Trust as of and for the year ended December 31, 2023.

The Plan's interest in the Master Trust level 1 assets were \$5,993,129 as of December 31, 2024. For the year ended December 31, 2023, the Plan's level 1 assets were \$5,315,468.

Transfers between levels: There were no transfers in and/or out of Level 1, 2 or 3 for the financial statements measured at fair value on a recurring basis for the years ended December 31, 2024 and 2023.

6. *Plan Termination*

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue its contributions at any time and to amend, modify, or terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for an account of the participants. No assets of the Plan may revert to the College or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Tax Status

The VEBA trust funding certain benefits of the Plan received exemption letters from the IRS dated October 5, 2009, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related Master Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expect to be taken that would require recognition of a tax liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Other Matters – Self Correction Program

Certain errors were identified relating to employer contributions and deceased participants. The correction of errors has been identified. Corrections will include a debit to the participants accounts and a credit to the forfeiture account. These corrections will be made by the College as soon as administratively possible.

During 2024, the Plan Sponsor did not remit certain participant contributions to the Plan in a timely manner, as defined by ERISA. These instances were corrected during 2024. The Plan Sponsor intends to compensate participants for any lost earnings resulting from the delay of contributions.

Management does not believe these amounts will materially impact the financial statements or tax status of the Plan.

10. Related Party/Party-in-Interest

Certain employees and officers of the College, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

The Plan's investments are managed by OneBridge, recordkeeper and Alta Trust, Trustee of the Master Trust. These transactions qualify as party-in-interest transactions.

Cammack LaRhette Advisors, a financial advisor, provides investment management and consultation services to the Plan and its participants. As a provider of services to the Plan, these transactions qualify as party-in-interest transactions.

The College is the Plan Sponsor and therefore considered a party-in-interest. The Plan Sponsor may pay certain expenses related to the Plan's operations. These transactions are party-in-interest transactions under ERISA.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

11. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$4,828,773 and \$4,013,440, that were concentrated in five funds, respectively.
