Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Buckeye Pipe Line Services Company Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1 – DESCRIPTION OF PLAN

The Buckeye Pipe Line Services Company Retirement and Savings Plan (the Plan), is a defined contribution plan covering substantially all regular full-time employees of Buckeye Pipe Line Services Company (the Company), or one of its designated affiliated companies. The Plan was originally established by the Company effective July 1, 1970, and was amended and restated on January 1, 2024. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. In the event of any conflict between this description and the plan document, the plan document will govern.

Administration: The Plan is administered by the Pension Plan Committee (the Committee), which is composed of employees of the Company. The Committee is responsible for the operation and administration of the Plan and the management of the Plan's assets. Fidelity Management Trust Company (Fidelity) acts as trustee for the Plan's investment options and Fidelity Workplace Services LLC acts as recordkeeper of the Plan.

Plan Transfer: Effective January 1, 2024, Elysian Carbon Devco, LLC became a participating employer under the Plan. As a result, on April 15, 2024, plan assets of \$577,642 were merged into the Plan.

Eligibility and Participation: Eligible employees become participants in the Plan on their employment date. Certain union groups are also eligible to participate under the Plan.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Company matching and retirement account contributions, rollovers and applicable earnings, or losses on investments. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of administrative expenses are based on participant earnings or losses, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions: A participant may elect to contribute, on a pre-tax or Roth 401(k) basis, up to 50% of the participant's weekly compensation to the Plan. The maximum employee contribution cannot exceed the limits on pre-tax and/or Roth 401(k) elective deferrals and annual additions permitted by the Internal Revenue Code of 1986, as amended (IRC). Participants who have attained or will attain age 50 by the end of the calendar year may make additional catch-up contributions.

A participant may elect to make after-tax contributions by designating a whole percentage of compensation between 1% and 15%. The participant's after-tax contributions are made through payroll deductions.

The Plan includes an auto-enrollment provision whereby newly eligible employees are automatically enrolled in the Plan after 40 days of employment at a deferral rate of 5% of eligible compensation unless they affirmatively elect to opt out of the Plan or elect a deferral rate other than 5%.

If a participant has not provided investment elections, their contributions will be invested in a designated target date retirement fund based on the participant's age. Investment elections can be changed by a participant at any time. A participant may elect to irrevocably designate all or any portion of the participant's pre-tax contributions as Roth 401(k) contributions.

The Company contributes to the Plan on behalf of each participant an amount equal to 100% of such participant's contribution up to a maximum of 5% of the participant's eligible compensation per payroll period for employees with less than 20 years of service and 6% of the participant's eligible compensation per pay period for employees with 20 years of service or more. Contributions of the Company up to an amount equal to the first 2% of the participant's eligible compensation are allocated to the participant's 401(k) account and the remaining Company contributions are allocated to the participant's 401(a) account.

The Company also provides participants with a retirement account contribution of 5% of the participant's eligible compensation per payroll period.

Contributions to the rollover account are limited to participant transfer contributions to the Plan from a qualified plan of a previous employer or affiliated company. Contributions to the retirement rollover account are limited to the rollover of the present value or an employee's accrued benefit under the terminated ESOP.

Vesting: Company contributions to a participant's retirement account and Company contribution 401(a) account become fully vested after five years of service (20% vesting per Plan Year, which is January 1 - December 31). Company contributions to the retirement account and Company contribution 401(a) account also become fully vested upon the participant's termination of employment due to death, disability, attainment of age 65, or termination of the Plan. Participants are fully vested at all times in their contributions to the Plan, including their rollover account, their Roth rollover account, their retirement rollover account, and their Company contribution 401(k) pre-tax and Roth deferral accounts.

Forfeited Accounts: When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture. The Plan permits the use of forfeitures to either reduce future employer contributions or Plan administrative expenses for the Plan Year. However, if a participant is reemployed and fulfills certain requirements, the participant's account will be reinstated.

The nonvested portion of a participant's account will be forfeited following the participant's severance date, as of the date the participant receives a distribution of his entire vested interest in his Plan benefits. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$480,638 and \$143,731, respectively. During the year ended December 31, 2024, Company contributions to the Plan were reduced by \$543,684 from forfeited nonvested accounts.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are invested per the participants' direction. The Plan offers mutual funds, a self-directed brokerage account, and a stable value fund as investment options for participants. Participants may redirect future contributions or exchange existing balances among available investment securities at any time.

Notes Receivable From Participants: Within specified limits, participants may borrow from their accounts, at an interest rate fixed by the Committee, a minimum of \$500, up to a maximum of the lesser of \$50,000 reduced by the participant's loan balance outstanding during the one-year period preceding the loan inception date, or half of their vested interest in the Plan (excluding the value of the participants retirement account). The loans are secured by an assignment of a participant's vested interest in the Plan.

Principal and interest is paid ratably through payroll deductions or as a lump-sum for the outstanding loan balance. As of December 31, 2024, participant loans have maturities through 2046 at interest rates ranging from 3.75% to 9.00%.

Coronavirus-Related Loans: A participant who satisfied the eligibility requirements for a coronavirus-related distribution could take a loan from the Plan during the 180-day period beginning on March 27, 2020 of up to the lesser of \$100,000 (taking into account the outstanding balance of all other loans taken from plans of the employer) or 100% of the nonforfeitable value of the participant's account under the Plan. A participant who satisfied the eligibility requirements for a coronavirus-related loan may delay repayment of a new or existing loan from the Plan for a period of one year for loan repayments outstanding on March 27, 2020 through December 31, 2020. The delay of the loan repayment did not cause the loan to fail to meet the IRC requirements for the maximum five-year loan term for nonresidential loans or substantially level reamortized payment schedule. Once repayments recommenced, the loan will be adjusted to reflect the delay, including accrued interest.

In-Service Withdrawals: Participant rollover accounts, including Roth rollover accounts, may be withdrawn at any time, without penalty. Participant after-tax contribution accounts and vested Company contribution 401(a) accounts may be withdrawn at any time without penalty provided such amounts have been in the Plan for at least two years. Participant pre-tax contribution accounts and Company contribution 401(k) accounts generally may be withdrawn prior to attainment of age 59½, retirement, death, disability, or termination only in cases of hardship, as defined in the IRC and the Plan, and also as approved by the Committee. In no event may a participant withdraw any portion of the participant's retirement account or retirement rollover account prior to termination of employment with the Company. Only one withdrawal is permitted during any six-month period, except in the case of hardship withdrawals.

Distributions: Depending on the participant's account balance upon termination of Company employment, a participant's Plan benefit is paid in the form of a lump-sum payment or transferred into a specified rollover account. Prior to retirement or termination, a participant may elect to defer payment of the participant's Plan benefit until a specified future date.

Death Benefits: In the event of a participant's death, the participant's Plan benefit is payable to the spouse or designated beneficiary.

Subsequent Events: The Plan evaluates subsequent events through the date the financial statements are available to be issued for potential recognition or disclosure. Subsequent events have been evaluated through August 29, 2025, the date the financial statements were available to be issued. No events requiring recognition or additional disclosure were identified.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition: Purchases and sales of securities are recorded on a trade-date basis. Interest and other income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year. See Note 3 for discussion of fair value measurements.

The Plan's investments in mutual funds are stated at their fair values based on quoted market prices. Units in the Fidelity Managed Income Portfolio are valued at net asset value (NAV) as reported by Fidelity based on the underlying assets, which include a mix of mutual funds and managed accounts.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Payment of Benefits: Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

Administrative Expenses: Administrative expenses of the Plan, including management fees and operating expenses, are paid by the Company as provided in the plan document. All management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from investment income earned on a daily basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of investment return for such investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-Directed Brokerage Account: The underlying investments, which consist primarily of interest-bearing cash accounts and individual corporate common stocks, are valued at the closing price reported on the open market and are classified within level 1 of the valuation hierarchy.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust (Fidelity Managed Income Portfolio): Valued using NAV as reported by the Fund. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it was determined to be probable that the Fund will sell the underlying investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. In accordance with ASU No. 2015-07, these investments that are measured at fair value using NAV per share practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the fair value table below are intended to permit reconciliation of the fair value hierarchy to amounts presented in the statements of net assets available for benefits.

NOTE 4 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

NOTE 5 – PARTY IN INTEREST TRANSACTIONS

Plan investments include mutual funds, a self-directed brokerage account, and a common collective trust managed by the trustee and, therefore, these transactions qualify as party in interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transactions rules under ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested.

NOTE 7 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 13, 2018 indicating that the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, credit and risks related to the effect of global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
