NOTE 1 - DESCRIPTION OF PLAN

The following description of the Richmond National Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established effective July 26, 2024, as a defined contribution plan covering all eligible regular full-time and regular part-time employees of Richmond National Services, Inc. (the Employer), who have completed at least 1 month of service. The Plan entry date is the first day of each month following satisfaction of the service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Transfer from Other Plan: During the period ended December 31, 2024, \$ 2,844,062 was transferred to the Plan from the Slavic Secure PEP (the Prior Plan). Prior to July 26, 2024, the Employer was a participating employer in the Prior Plan.

Contributions: Each year, participants may contribute between 1% and 100% of eligible compensation, as defined in the Plan. Employees are automatically enrolled at a 6% deferral rate upon becoming eligible to participate in the Plan, and they may elect to change or discontinue deferrals as of the first day of each month. Eligible participants may elect to make Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Each pay period, the Employer makes Matching Contributions to the account of 100% of the first 3% of eligible compensation contributed to the Plan and 50% on the next 3% of eligible compensation contributed to the Plan. Contributions are subject to certain limitations defined by the Internal Revenue Code.

In November 2024, the Employer amended the Plan to allow for Discretionary Matching Employer Contributions effective January 1, 2025. The Employer may choose to make additional Discretionary Matching Employer Contributions to participant accounts. For the period ended December 31, 2024, Discretionary Matching Employer Contributions were not allowed.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contributions, and (b) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Participants who were employed by the Employer prior to July 26, 2024 are 100% vested after 1 year of service for Employer Matching Contributions and Employer Discretionary Contributions.

Payment of Benefits: Withdrawals from the Plan are generally permitted in the event of termination of employment, retirement, disability, as a Required Minimum Distribution (RMD), or death. Participants may also be eligible for a withdrawal in the case of a severe financial hardship as defined by the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½. Upon termination of service, benefit amounts under \$7,000 are automatically distributed to the participant at the discretion of the Employer.

Notes Receivable from Participants: Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rates are set at prevailing interest rates. Principal and interest is paid ratably through payroll deductions.

Forfeitures: Forfeitures of Employer contributions are used to offset future Employer contributions or pay administrative expenses of the Plan. During the period ended December 31, 2024, there were no forfeited Employer contributions that were used to offset Employer contributions or to pay administrative expenses. Forfeitures available to offset future Employer contributions and to pay administrative expenses as of December 31, 2024 were \$3,713.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions and earning thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value

is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of participation units held in the collective trust is based on the net asset values per unit as reported by the fund manager. The collective trusts provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement for participant transactions.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer. Certain investments of the Plan as of December 31, 2024 were invested in a mutual fund managed by Fidelity Investments Institutional. Fidelity Investments Institutional is affiliated with Fidelity Management Trust Company, the trustee of the Plan, and Fidelity Workplace Services, LLC, recordkeeper of the Plan; therefore, the Plan's payment of fees to the trustee and recordkeeper of the Plan qualify as party-in-interest transactions under ERISA.

Additionally, certain investments of the Plan as of December 31, 2024 were invested in a collective trust managed by First Citizens Bank & Trust Company, a fiduciary of the Plan. Therefore, fees charged by the investment manager of the collective trust qualify as party-in-interest transactions under ERISA.

Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6-TAX STATUS

The Employer has adopted a pre-approved plan document that has received an opinion from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified. No provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025 which is the date the financial statements were available to be issued.
