Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mi-T-M Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mi-T-M Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Principal Trust Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mi-T-M Corporation 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 - Description of the Plan:

The following description of Mi-T-M Corporation 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution 401(k) plan covering substantially all employees of Mi-T-M Corporation and Peosta Cleaning Systems who have six months of service prior to June 30, 2023 and three months of service after June 30, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts. Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution and (b) Plan earnings (losses). Allocations of earnings are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions. Each year, participants may contribute up to the maximum allowed by IRS regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual funds, pooled separate accounts, collective investment trust funds, and an insurance investment contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 7% for the years ended December 31, 2024 and 2023. The employer matched 50% of the first 7% of contributions made by a participant for 2024 and 2023. Contributions are subject to certain statutory limitations.

Investment Options. Upon enrollment, a participant may direct the investment of both participant and employer matching contributions in a variety of investment options, as more fully described in the Plan's literature. Participants may change their investment options at any time.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance whichever is less. The loans are secured by the vested balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. Loans must be repaid in no more than five years, unless the loan is used for the purchase of a primary residence. Principal and interest payments must be made, at least quarterly under a level amortization table.

Note 1 - Description of the Plan: (continued)

Vesting. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account plus actual earnings thereon is based on years of service. A participant is 20% vested after one year of credited service as defined in the Plan's literature and continues to vest at the rate of 20% for each successive year of service until 100% vested after five years of credited service.

Rollovers. A participant may contribute any rollover contribution to which the participant is entitled from another qualified trust. Such rollover contributions are deposited in the participant's account.

Forfeitures. Amounts of participants' forfeited nonvested accounts can be applied to reduce employer-matching contributions and discretionary contributions. In 2024, employer contributions were reduced by \$25,124 from forfeited nonvested accounts.

Payment of Benefits. On termination of service, the participant may elect to receive a lump sum amount equal to the value of the participant's vested account, annual installments over a stated period of time, a portion of it as a lump-sum and the remainder as annual installments, or may elect to leave their balance in the Plan subject to certain minimum distribution requirements. If the distribution is greater than \$1,000, the distribution will be rolled over into an IRA account through Principal, unless the employee has made a previous election.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting. The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses. Certain administrative expenses of the Plan, such as contract administration, recordkeeping, and transaction fees, are paid by the Plan. Certain other administrative expenses, such as audit fees of the Plan, are paid by the Plan Sponsor and are not included in the financial statements of the Plan.

Note 2 - Summary of Significant Accounting Policies: (continued)

Accounting Estimates. The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Management makes estimates regarding uncollectible employee and employer contribution receivables. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition. Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies. See Note 5 for discussion of fair value measurements and valuations.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gain or losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Note 3 - Information Certified by Principal Trust Company (Unaudited):

The following information included in the accompanying financial statements, the accompanying notes, and supplemental schedule were prepared in part or entirely from information certified by Principal Trust Company in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Principal Trust Company certified to the completeness and accuracy of investments of \$31,053,491 and \$27,858,758 at December 31, 2024 and 2023, respectively.

Principal Trust Company certified to the completeness and accuracy of the participant notes receivable balance of \$677,731 and \$606,238 at December 31, 2024 and 2023, respectively.

Principal Trust Company certified to the completeness and accuracy of \$3,798,769 of net appreciation in investments (including investments bought, sold, and held), \$19,729 of interest and dividends related to the aforementioned investments, and \$49,447 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4 - Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 5 - Fair Value Measurements:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The FASB Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. There were no plan assets requiring the use of Level 2 or Level 3 inputs for the years presented. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The following table sets forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Pooled separate accounts invest in mutual funds that use publicly quoted pricing inputs to determine the net asset values.

Collective investment trust funds invest in a collective trust fund as well as a variety of separate accounts and mutual funds. The collective investment trust funds do not use publicly quoted pricing inputs, however, the fair values are available to current investors via Principal's website or when plan participants access their account values.

The Plan Administrator determines the fair value measurement policies and procedures in consultation with the Plan Trustee. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

Note 6 - Income Tax Status:

The Plan has adopted a prototype plan sponsored by Principal Life Insurance Company which received a favorable determination letter dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require that the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in process.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Party-In-Interest Transactions:

Certain plan investments are shares of mutual funds and pooled separate accounts managed by Principal Funds, Inc., collective investment trust funds managed by Principal Global Investors Trust Co., and a fully benefit investment contract managed by Principal Life Insurance Company. These companies are affiliated with Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

The amounts invested with the trustees at December 31, 2024 and 2023 were \$25,696,7599 and \$25,626,316, respectively. Fees paid by the Plan for the investment management services amounted to \$132,086 for 2024.

Participant notes receivable from the Plan given to parties-in-interest totaled \$677,731 and \$606,238 as of December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 9 - Plan Amendments:

The Plan adopted the following two amendments effective for the 2024 Plan year:

All participants that had an elective deferral percentage less than 7% were automatically increased to 7% on September 1, 2024, unless the participant declined the automatic increase.

The Plan changed its method of calculating the employer matching contributions from each payroll period to a plan year calculation.

Note 10 - SECURE Act 2.0:

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly. There was no material impact to the Plan's financial statements as a result of any new 2024 retirement provisions.

Note 11 - Subsequent Events:

The Plan adopted the following amendments in 2025:

Effective January 1, 2025, the Plan decreased the number of allowed loans per participant from two loans to one loan.

Effective January 1, 2026, the Plan decreased the maximum amount that participants could borrow from their accounts from \$50,000 to \$15,000.

The Plan's management has evaluated subsequent events and transactions for potential financial statement recognition and disclosure through October 6, 2025, the date the financial statements were available to be issued.
