10. During the year ended December 31, 2024, we qualified as a financially distressed hospital and received additional revenues related to certain Medicaid managed care services. As of the date of this letter, the continuation of this rate was approved through March 31, 2025. We note the continuation of this rate add-on beyond March 31, 2025 is subject to the approval, however, we have no knowledge or reason to believe that the rate add-on will not continue beyond March 31, 2025.
11. Note 2 to the consolidated financial statements discloses all of the matters which we are aware that are relevant to the System's ability to continue as a going concern, including significant conditions and events, and management plans.
12. We have no knowledge of any uncorrected misstatements in the consolidated financial statements.

Information Provided

13. We have provided you with:
- a. Access to all information of which we are aware that is relevant to the preparation and fair presentation of the consolidated financial statements such as records, documentation and other matters.
 - b. Additional information that you have requested from us for the purpose of the audit.
 - c. Unrestricted access to persons within the System from whom you determined it necessary to obtain audit evidence.
 - d. Minutes of the meetings of the stockholders, directors and committees of directors, or summaries of actions of recent meetings for which minutes have not yet been prepared.
14. All transactions have been recorded in the accounting records and are reflected in the consolidated financial statements.
