Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Navan 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Navan 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. General

The Plan was established January 1, 2015 to provide retirement benefits to eligible employees of Navan, Inc., formerly TripActions, (the “Company”). The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective February 7, 2023, the Plan was amended to change the name of the Plan from TripActions 401(k) Savings Plan to Navan 401(k) Savings Plan along with the sponsoring employer from TripActions to Navan, Inc.

B. Administration and Expenses

Ascensus, LLC (“Ascensus”) is third-party administrator of the Plan and is responsible for maintaining participant records, and its affiliate, Ascensus Trust Company, serves as directed trustee.

Ascensus receives credits from Vanguard mutual funds that comprise a majority of Plan investment funds. The credits are applied to offset Ascensus recordkeeping, trust and administrative fees, and are factored into Plan investments as a reduction in investment return.

C. Eligibility

Nonresident aliens and collectively bargained employees are specifically excluded from the Plan. There are no age or service requirements. Employees are eligible to enter the Plan on the first day of the month following date of hire.

D. Contributions

Participants may elect to make pre-tax and/or Roth after-tax contributions to the Plan up to the amount allowable under the Plan document and current Code regulations. Participants of age 50 or older may elect to make additional catch-up contributions as allowed under Code regulations. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

Effective February 7, 2023, eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto enrolled at a pre-tax contribution rate of 3% of eligible compensation.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with participant directions.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

D. Contributions (Continued)

The Plan provides for employer discretionary matching contributions. The Company matched 50% of the first 6% of eligible compensation deferred by each participant. Effective July 8, 2023, the employer discretionary match was suspended.

E. Vesting and Forfeitures

A participant is fully vested immediately as to voluntary contributions, rollover contributions and related earnings. A participant vests in his or her account attributable to Company matching contributions at the rate of 25% annually and attains full vesting on completion of four years of service. Forfeitures of terminated participants' non-vested accounts are applied to reduce Company matching contributions. The unapplied balance of forfeitures was approximately \$378,000 and \$207,000 as of December 31, 2024 and 2023, respectively.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, and an allocation of Plan earnings or losses and expenses. Participants direct the investment of their accounts among a diversified group of mutual fund investment options provided under the Plan.

G. Payment of Benefits

Normal retirement age under the Plan is age 65. Participants are eligible for benefits upon attainment of age 59½, retirement, disability, or termination of service. Benefits are payable in a lump sum, partial payments, or installments. The Plan provides for mandatory distribution of accounts that are valued at \$5,000 or less subject to Code regulations. Hardship distributions are permitted from participant elective deferral accounts under limited circumstances on approval by the plan administrator. Benefits are recorded when paid.

H. Notes Receivable from Participants

The Plan allows participants to borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at a fixed rate commensurate with rates charged by commercial lenders for similar types of loans, and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence, in which case the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 5.50% to 10.50% with various maturities through March 2053. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividends and interest. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Investments include a variety of securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - TAX STATUS

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Plan investments in Vanguard mutual funds generate credits utilized by the Plan to offset record keeping and administrative costs of the Plan. Such transactions are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition against party-in-interest transactions under ERISA.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying 2024 and 2023 financial statements and supplemental schedule including investments held at December 31, 2024, and net appreciation of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee, Ascensus Trust Company.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical assets in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing an asset or liability.

Plan investments consist of actively traded open-end mutual funds that are registered with the Securities and Exchange Commission and required to publish their net asset value daily and transact at that price.
