INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Leiss Tool & Die 401(k) Profit Sharing Plan
Somerset, Pennsylvania

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Leiss Tool & Die 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, Ascensus Trust Company, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion on the Financial Statements

December 31, 2024 and 2023

Note 1: Plan Description

The following description of Leiss Tool & Die 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a participant directed defined contribution plan covering all full-time employees of Leiss Tool & Die (the “Company” or the “Plan Sponsor”), Jenny Products, Inc. and Highland Harley Davidson, all of which have a common owner, who have one year of service (with 1,000 hours of service) and are age twenty-one or older, as allowed under Section 401(k) of the Internal Revenue Code of 1986, as amended (IRC). The Company is the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is not covered by the Pension Benefit Guaranty Corporation. Overall responsibility for administering the Plan rests with the Board of Trustees. The Plan’s custodian, Newport Trust Company., is responsible for the management and control of the Plan’s assets, which are held in individual participant investment accounts (collectively known as the Trust).

Contributions

Each year, participants may contribute up to 20 percent of pre-tax annual compensation, as defined in the Plan, subject to certain IRC limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The employee salary deferrals are exempt from federal income tax until withdrawn from the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers approximately nineteen (19) mutual funds as investment options for participants. The employer may contribute amounts based on its sole discretion which shall be allocated to each participant in proportion to his or her compensation for the year. Any participant who is credited with 1,000 hours of service during the Plan Year and is employed on the last day of the Plan Year is eligible to receive an allocation of any employer contribution that is made. The Company contribution is invested in the same portfolio of mutual funds as participant’s contributions at the direction of each individual participant.

Participant Accounts

A separate account is maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Forfeitures shall be allocated to participants in the same manner as the employer’s contribution.

Note 1: Plan Description (continued)

Investment Options

Upon enrollment in the Plan, a participant must direct their salary deferral and any employer contributions into one or more of several diversified mutual funds as more fully described in the Plan's literature. Participants may change their investment allocation on a daily basis.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested in company contributions after (a) six years of credited service, (b) attainment of normal or early retirement age, (c) retirement due to disability, death or termination of Plan.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$0, respectively. These accounts may be used to either supplement future employer contributions or pay plan expenses. The nonvested forfeiture accounts were used to pay plan expenses in both 2024 and 2023.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant (or a participant's beneficiary in the event of death) may elect to (1) receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, or (2) elect a rollover distribution to an eligible retirement plan or eligible individual retirement account (IRA) in an amount equal to the value of the participant's vested interest in his or her account. If a participant's account is less than \$1,000 and an election is not made, the Trustee will distribute the vested interest in the participant's account to the participant in the form of a lump-sum payment. If a participant with an account balance greater than \$1,000 and not exceeding \$5,000, does not elect either to receive or to rollover the distribution, then the participant's vested interest in the account will be rolled over to an IRA. In addition, hardship distributions are permitted if certain criteria are met.

Administrative Expenses

During the year ended December 31, 2024 the Plan paid a third party for investment fund administrative expenses and recordkeeping fees relating to the maintenance of the participant accounts. All other administrative expenses, including audit fees were paid for by the Company, which is a party-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 2: Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at the quoted market prices, which represent the net asset value of shares held by the Plan at year-end, utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator and management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosures. Actual results could differ from those estimates.

Note 3: Information Certified by Ascensus Trust Company

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Accounting Standards Codification 820 requires that assets and liabilities reported at fair value be classified in one of the following three levels:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - If an asset or liability has a specified (contractual term), the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All investments in the statement of net assets are reported at fair value. All of the Plan's investments measured at fair value as of December 31, 2024 and 2023 are Level 1 measurements. There were no transfers between Levels 1, 2 or 3 in 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 6: Tax Status

The Plan has adopted a Non-standardized Pre-Approved Profit-Sharing/Money Purchase Plan sponsored by Newport Group Inc. The Plan, by letter dated June 30, 2020, was approved by the Internal Revenue Service and accordingly, was in compliance with the applicable sections of the Internal Revenue Code (IRC) and is therefore not subject to tax under the present income tax law. The pre-approved profit-sharing Plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since the determination letter, the Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt. The plan was amended as of January 1, 2022, to comply with the Bipartisan Act of 2018, allowing hardship withdrawals.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various mutual funds. Mutual funds are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of the mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements and supplemental schedule of the Plan.

The Plan provides investment options that hold securities of foreign companies, which may involve special risks and considerations not typically associated with investing in U.S. Companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

Note 8: Related-Party Transactions and Party-In-Interest Transactions

The delinquent contributions constitute prohibited transactions under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor has taken corrective action by remitting the delinquent contributions, including applicable lost earnings, to the Plan. In addition, the Plan Sponsor intends to file any and all required forms with the Internal Revenue Service to properly correct this transaction.

Note 12: Subsequent Events

The Plan has evaluated subsequent events through the date of the audit report, which is the date the financial statements were available to be issued. The results of this evaluation indicated that there are no subsequent events or transactions that are required to be disclosed in these financial statements.
