Opinion

**NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

Note 1 - Plan Description:

The following brief description of the Mi-T-M Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

Mighty M Holdings, Inc., the parent company of Mi-T-M Corporation and Peosta Cleaning Systems, Inc. (Company) established the Mi-T-M Employee Stock Ownership Plan effective as of January 1, 2021. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator oversees all administrative functions of the plan. The trust department of an independent third-party bank is the Plan's trustee.

The Plan purchased Company common stock using the proceeds of a borrowing obtained from the Company. The Plan holds the common stock in a trust established under the Plan. The borrowing is to be repaid to the Company over a period of forty years using employer contributions made to the trust fund. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC. Shares vest fully upon allocations.

The borrowing is collateralized by the unallocated shares of common stock. The lender (Mighty M Holdings, Inc.) has no rights against the shares of common stock once they are allocated under the provisions of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 21, 2024, present separately the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with vested rights in allocated common stock (Allocated) and
2. Common stock not yet allocated to employees (Unallocated).

Eligibility. Employees of Mi-T-M Corporation and Peosta Cleaning Systems are generally eligible to participate in the Plan once they have attained age 18 and completed one year of service (1,000 hours). Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

Note 1 - Plan Description: (continued)

Contributions. The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its loan. The employer may also make contributions to the Plan to pay benefits due participants. Employees are not permitted to make contributions.

Payment of Benefits. Upon attaining normal retirement age (65) while still employed with the employer, participants become fully vested in their participant account balance. Unless the participant elects to postpone their distribution to a later date, distributions will generally begin as soon as reasonably practicable in, and no later than the last day of the plan year following the plan year in which they retire (at or after normal retirement age).

Upon termination of employment, the participant is entitled to receive only the vested percentage of their account balance in the Plan. Participants with vested account balances of \$5,000 or less will be paid as soon as administratively feasible after the end of the plan year in which the termination occurs.

Participants with vested account balances greater than \$5,000, distribution of the vested benefit will be available as soon as administratively practicable in the plan year following the earlier of (1) the plan year during which the participant attains normal retirement age, dies, or becomes disabled, or (2) distribution will be available as soon as administratively practicable in the sixth plan year immediately following the plan year during which employment was terminated.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. During 2024 and 2023, the Company did not repurchase any shares from participants.

Voting Rights. The trustee of the Plan will generally vote all Company stock held by it as part of the Plan's assets in accordance with its fiduciary responsibilities and the terms of the Plan. In the case of any corporate matter which involves the voting of shares, the Trustee will notify participants of any such voting rights.

Vesting. If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest 20% per year of service and are 100% vested after five years of service.

Note 1 - Plan Description: (continued):

Plan Termination. The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code. Upon termination of the Plan, the Plan administrator should direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

Participant Accounts. The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non vested account. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on the compensation of the participant.

Put Option. Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification. Diversification is only offered to participants who have completed ten years of service, have attained the age of fifty-five and remain with the employer. The participant can elect to diversify their account by converting a portion of Company stock into cash and transferring such cash to another tax-qualified plan (such as the Company's 401(k) Plan) maintained by the employer that permits them to direct the investment of such amounts among at least three diversified investment alternatives. Participant's generally have a right to diversify up to 25% of Company stock held in their account during a period of five years after their eligibility to diversify, and up to 50% in the sixth year following such eligibility.

Forfeitures. Employer contributions and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. There were no forfeitures to allocate at December 31, 2024 or 2023.

Note 2 - Summary of Significant Account Policies:

Basis of Accounting. The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Management makes estimates regarding the fair value of Mighty M Holdings Inc. common stock. Accordingly, actual results may differ from those estimates.

Allocations. The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (“allocated”) and (b) stock not yet allocated to employees (“unallocated”), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period which debt service is paid.

Interest Bearing Cash. Interest bearing cash consists of a money market fund used to pay benefits to Plan participants.

Investment Valuation and Income Recognition. The shares of Company common stock are valued at fair value. See Note 4 for discussion of fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Operating Expenses. All expenses of maintaining the Plan are paid by the Company.

Payment of Benefits. Benefits are recorded when paid.

Note 3 - Tax Status:

The Internal Revenue Service has determined and informed the Company by a letter dated November 14, 2022, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 4 - Fair Value Measurements:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The FASB Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. The following presents fair value measurement information for the Plan's investments as of December 31, 2024 and 2023.

Level 3 Fair Value Measurements

The fair value of Mighty M Holdings, Inc. common stock is based on an annual independent appraisal. The appraiser took into account significant unobservable inputs including historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

The Plan administrator determines the fair value measurement policies and procedures. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The Plan's policy is to recognize transfers into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers into or out of Level 3.

Note 5 - Administration of Plan Assets:

The Plan's assets, which consist principally of Company stock, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Company.

Note 7 - Loan Payable - Related Party:

In 2021, the Plan entered into a \$73,800,000 loan agreement with the Company at 1.73% interest with a maturity date of December 31, 2060. The proceeds of the loan were used to purchase Mighty M Holdings, Inc. common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants when principal and interest payments are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments, divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 24,988 shares being released and allocated for the plan years ended December 31, 2024 and 2023. The agreement provides that the loan will be repaid over a period of forty years. The fair value of the note payable as of December 31, 2024 and 2023 was \$67,497,665 and \$68,841,378, respectively, determined by using interest rates currently available for issuance of debt with similar terms, maturity dates, and nonperformance risk. Note 8 - Risks and Uncertainties:

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks including interest rate, market, and credit risks, as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9 - Related Party and Party-in-Interest Transactions:

The Plan invests in Company common stock and has a loan payable with the Company. These are related party and party-in-interest transactions. As described in Notes 2 and 5, the Company pays the expenses of the Plan.

The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 10- Subsequent Events:

The Plan's management has evaluated events and transactions for potential financial statement recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.
