## Independent Auditors' Report

## 1. Description of Plan

The New York Academy of Medicine (the "Academy" or "Employer") adopted The New York Academy of Medicine Retirement Plan (the "Plan") on October 1, 1973. The following description of the Plan provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***General and Eligibility***

The Plan is a defined-contribution plan designed to meet the requirements of Section 403(b) of the Internal Revenue Code (the "Code") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan covers all eligible employees of the Academy.

Employees are eligible for elective deferrals and employer contributions immediately upon employment. Upon attaining eligibility, the participants will receive contributions from the Academy to their Plan accounts as of the date of the completion of the eligibility period. Certain employees may be excluded from participation if they fall within categories specified in the Plan document.

### ***Contributions***

**Elective deferrals:** Participants may elect to contribute a certain amount of their annual eligible gross compensation, subject to limitations as provided in the Code. Participants may also include, as rollover contributions, those distributions they may receive from other qualified defined-benefit or defined-contribution plans from prior employers. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amounts.

**Employer contribution:** In accordance with the terms of the plan document, the Academy may elect to make discretionary nonelective contributions equal to a specified percentage of participants' eligible compensation and may elect to make discretionary matching contributions. The nonelective percentage was 3% for 2024 and 2023, and the discretionary matching contributions were the lesser of 2% of eligible compensation or the employee contribution for 2024 and 2023. Both of these employer contributions are invested according to the investment elections selected by each participant.

### ***Participant Accounts***

Each participant's account is credited with Employer and participant contributions and the investment earnings thereon. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

### ***Vesting***

Participants are immediately vested in 100% of their salary deferral contributions, discretionary employer matching and non-elective contributions, plus actual earnings thereon.

### ***Loans to Participants/Collateralized Assets***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant are made directly from Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA and CREF"). The participant's account is not reduced by the loan amount but serves as security for the loan. This security amount, that covers the outstanding loan balance, is placed in a fixed income collateral account within the participant's total account. This security amount is set aside until the loan is paid in full.

The loan must be repaid directly to TIAA and CREF within a five year period in substantially equal payments (not less frequently than quarterly). The five year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower. The law treats the amount of any loan not repaid five years after the date of the loan as a taxable distribution on the last day of the five-year period or, if sooner, at the time the loan is in default.

At December 31, 2024 and 2023 there were 3 and 8 loans outstanding with total principal balances due of \$7,562 and \$20,896, which also represent a collateralization of participant accounts. No loans were in default at December 31, 2024 and 2023. The interest rate was 5.33% with maturities through 2029 at December 31, 2024. Interest rates on these loans ranged from 5.02% to 5.56% with maturities through 2029 at December 31, 2023.

From 2021, collateralized loans are no longer offered to the Plan participants. Any loan a participant takes in 2021 or later will be made directly with the retirement plan account. These loans are recorded as notes receivable from participants on the statements of financial position.

### ***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Participants may take a loan once in any 12 consecutive-month period. Participants may not have more than three outstanding loans at a time. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. A participant may request an in-service distribution once they have reached age 59 ½, only from the employee contribution and any earnings on it. In the event of a hardship distribution, only the participant's elective deferrals and earnings thereon are eligible to be distributed.

## 1. Description of Plan (*continued*)

### ***Other Income - Revenue Credit Account***

The Plan and TIAA entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is an account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$820 and \$9,580 at December 31, 2024 and 2023. During December 31, 2024 and 2023, \$25,345 and \$5,350 of these funds were used to pay Plan expenses and \$9,912 and \$9,775 of these funds were allocated from the Revenue Credit Account to participants of the Plan.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### ***Use of Estimates***

Management makes estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs relate to assets or liabilities that have little or no pricing observability as of the measurement date and are measured using management's best estimate of fair value.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

## 2. Summary of Significant Accounting Policies (*continued*)

### ***Investment Valuation and Income Recognition***

The TIAA Traditional Annuity Account consists of unallocated contracts. The fully benefit responsive contracts are carried at contract value and the non-benefit responsive contracts are carried at fair value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The TIAA Stable Value is a group annuity product issued by TIAA and is valued at contract value, which equals the accumulated cash contributions, interest credited, transfers in (if any), less any withdrawals and transfers out (if any).

Investments in mutual funds and variable annuity accounts are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the plan at year end. The registered investment companies are deemed to be actively traded. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Expenses relating to investment management are paid directly by the respective investment vehicle and are included as a reduction to net appreciation in fair value of investments. Other administrative expenses of the Plan are generally paid by the Academy and excluded from these financial statements.

### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 7, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

TIAA and CREF has been authorized by TIAA, FSB to certify the investments and investment information for which TIAA, FSB is the directed trustee. TIAA and CREF has been authorized by TIAA, FSB through July 14, 2023 to certify the investments and investment income information for which TIAA, FSB is the directed trustee and custodian. TIAA Trust, N.A. served as the directed trustee and custodian from July 15, 2023 through December 31, 2024.

#### ***TIAA Real Estate Account***

The TIAA Real Estate Account generally invests in real estate properties and real estate-related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter.

#### ***TIAA Traditional Annuity Account***

The TIAA Traditional Annuity Account is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity ("GSRA"), the Supplemental Retirement Annuity (SRA), and the Retirement Choice Plus ("RCP") contracts. The non-benefit responsive contracts are: the Group Retirement Annuity, Retirement Annuity ("RA") and Retirement Choice contracts. The Plan utilizes the GSRA, SRA, and RCP contracts, which are reported at contract value, and the RA contract, which is reported at fair value. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows: GSRA – 3.00%-5.75%; SRA – 3.00%-5.75%; RCP – 3.05%-6.00%; and RA – 3.55%-6.50%.

Under GSRA, SRA, and RCP contracts, lump-sum withdrawals and transfers can be done at any time. Due to the increased liquidity of GSRA, SRA and RCP contracts, these contracts are credited with lower interest rates. Under RA contract, lump-sum cash withdrawals are not allowed and transfers must be spread out in ten annual installments. The Plan administrator does not believe that any events would limit the Plan's ability to transact at contract value.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion is 3% and represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

#### *TIAA Traditional Annuity (Continued)*

The TIAA Traditional Annuity Account represents approximately 33% and 34% of the Plan's net assets available for benefits as of December 31, 2024 and 2023 and represents an obligation of TIAA to repay as amounts come due. The credit risk of the issuer, at December 31, 2024, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (Aa1 as of October 2024), Standard and Poor's (AA+ as of May 2024), A.M. Best (A++ as of July 2024), and Fitch Ratings (AAA as of August 2024).

### 5. Plan Termination

Although it has not expressed any intention to do so, the Academy has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 6. Tax Status

On August 7, 2017, the Internal Revenue Service issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions for periods after 2021 however, there are currently no examinations for any tax periods in progress.

### 7. Party-in-Interest

Certain investments are managed by TIAA and CREF. TIAA is the record-keeper and a custodian and CREF is a custodian for the Plan. Accordingly, these transactions are considered exempt party-in-interest transactions.

Certain employees of the Academy may also be participants in the Plan and perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

## 8. Non-Exempt Party-in-Interest Transactions

Certain Participant contributions totaling \$140,858 for the years ended December 31, 2024 and 2023 were remitted by the Employer to the Plan later than required by Department of Labor Regulation 2510.3-102. The Employer has made corrections for contributions amounting to \$100,295 and is in process of making the necessary corrections for the remaining contributions to satisfy both Department of Labor and IRS guidance for this matter.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
