### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Toyota Boshoku America, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Toyota Boshoku America, Inc. 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Toyota Boshoku America, Inc. 401(k) Profit Sharing Plan & Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Toyota Boshoku America, Inc. 401(k) Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing our audits in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Toyota Boshoku America, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

### Notes to Financial Statements

#### NOTE 1 DESCRIPTION OF THE PLAN

##### *General*

The following brief description of the provisions of the Toyota Boshoku America, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan") is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan sponsor is Toyota Boshoku America, Inc. (the "Company"). The custodian of the Plan's assets is State Street Bank & Trust ("State Street"). An employee of the Company acts as the Plan administrator. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### *Participation*

The Plan provides for participation immediately upon employment with the Company for all employees who have attained the age of 18.

##### *Contributions*

Active participants may contribute 1% to 80% of their compensation to the Plan on a before-tax basis through regular payroll deductions. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 (IRC) as amended (\$23,000 at December 31, 2024). Effective January 1, 2012, the Company matches 50% of every dollar of employee contributions up to 6% of employee compensation. The Company may also make a discretionary profit sharing contribution to the Plan, however, there were no discretionary profit sharing contributions made in 2024 and 2023. Rollover contributions from other qualified plans are also permitted.

The Plan has adopted provisions to allow for automatic enrollment into the Plan. When new participants become eligible to participate in the Plan, deferrals will be made on their behalf at 6%, unless the participant elects a different deferral percentage or not to participate. The Plan has also adopted an auto escalation feature, where participant elective deferrals are auto increased 1% on an annual basis until they reach a deferral percentage of 10%.

Participants that are age 50 and older are eligible to make "catch-up" contributions in accordance with, and subject to the limitations of IRC Section 414(v) (\$7,500 at December 31, 2024).

##### *Participant Accounts*

Participants determine the allocation of their contributions to the various investment alternatives offered by the Plan. Each participant's account is credited with the participant's contribution and an allocation of (a) the employer's matching contribution and (b) Plan earnings. Allocations are based on participant account balances. The benefit to which a participant entitled is the benefit that can be provided from the participant's account.

#### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Vesting and Forfeitures*

Participants are immediately vested in their contributions and any earnings or losses thereon. Additionally, participants have vested interests in employer contributions in increments of 20% over five years, starting with the first full year of service. The Plan provides that forfeitures of employer contributions are to be used to offset future employer contributions and administrative expenses. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$403,152 and \$472,452, respectively. During 2024, employer contributions were reduced by approximately \$559,756, from forfeited non-vested amounts.

##### *Investment Funds*

The Plan allows active participants to elect how their contributions will be directed from among various investment fund alternatives offered by the Plan. Investment fund alternatives range from conservative to aggressive in their degree of risk. Company matching contributions are invested in accordance with participant elections.

A participant may also direct their contributions to a brokerage account. This option allow participants to invest in most listed stocks, corporate bonds, zero-coupon bonds, U.S. Treasury securities, mortgage securities and U.S. government agency bonds, certificates of deposits, unit investment trusts, foreign securities, and other mutual funds. Participant accounts utilizing the self-directed brokerage option are subject to annual account fees.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repayable through regular payroll deductions within five years (except for certain home-related loans, payable over not more than thirty years). The loans are collateralized by the vested balance in the participant's account and bear interest in accordance with the Plan document. Interest rates range from 4.25% to 9.50% as of December 31, 2024. Interest earned on participant loan balances is credited directly to the participant's investment funds according to their respective allocation percentage elections. During December 31, 2024, the interest credited was \$788,788.

##### *Administration*

The Plan is administered by certain members of the Company's management. Expenses incurred in the administration of the Plan are paid by the Plan to the extent they are not paid by the Company. Fees charged by the custodian annually on participant loans are deducted from participant accounts.

#### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Withdrawals and Benefits*

Upon employment termination, death, or retirement, the participant's vested interest will be distributed to the participant or designed beneficiary if the amount is \$5,000 or less. Rollover contributions are not considered as part of the participant's vested interest in the Plan. The form of such distributions is a lump sum payment for vested interests of \$1,000 or less or the choice of a lump sum payment or direct rollover to an individual retirement account ("IRA") or another qualified plan. Participants with vested interests greater than \$5,000 are eligible for a rollover to an IRA or other qualified plan or may defer distribution until a later time as per the Plan document.

Participants are eligible for in-service withdrawals of their rollover balances and for certain circumstances resulting from financial hardship, as defined by the Plan document.

##### *Subsequent Event Evaluation*

The Plan Sponsor has evaluated all events subsequent to the balance sheet date through October 9, 2025, which is the date the financial statements were available to be issued.

##### *Plan Termination*

The Company anticipates that the Plan will continue without interruption, but it reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Basis of Accounting*

The financial statements are prepared on the accrual basis of accounting.

##### *Investment Valuation and Income Recognition*

The Plan's investments, with the exception of the fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Fully benefit-responsive investment contracts are stated at contract value.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation or depreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Notes Receivable From Participants*

Participant loans are classified as notes receivables and are measured at their unpaid principal balance plus any accrued but unpaid interest.

Delinquent participant loans are classified as distributions based on the terms of the Plan document.

##### *Payments of Benefits*

Benefits are recorded upon distribution.

##### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the Plan's financial statements and related notes. Actual results could differ from those estimates.

##### *Investment Risks*

The Plan provides for various investment options in a combination of various funds. These investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of those investments, it is at least reasonably possible that changes in the values of investments in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in the Net Assets Available for Benefits.

#### NOTE 3 FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a benefit-responsive investment contract with Prudential Retirement Insurance and Annuity Company (PRIAC). PRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed income account issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at Contract Value within reasonable timeframes. Contract Value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Contract Value is also often referred to as "Book Value". The contract is affected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, Prudential considers this contract to be benefit responsive.

Generally, there are not any events that could limit the ability of the plan to transact at Contract Value paid within 90 days or in rare circumstances, Contract Value is paid over time.

There are not any events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than Contract Value paid either within 90 days or over time.

#### NOTE 4 FAIR VALUE MEASUREMENTS

Applicable GAAP (Generally Accepted Accounting Principles) for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the applicable GAAP for Fair Value Measurements and Disclosures are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. (Mutual funds, common stocks, corporate bonds, US government securities, etc.)

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Mutual funds:* Valued at the quoted closing net asset values of the funds on the last day of the Plan fiscal year.

*Money market fund:* Valued at the net asset value ("NAV") of shares held by the Plan at year end.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- c) The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024.

#### NOTE 6 RELATED-PARTY TRANSACTIONS

Notes receivable from participants qualify as related party transactions. Certain Plan expenses were paid by the Company. The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it is not compensated.

Certain Plan investments are invested in money market accounts managed by Transamerica Life Insurance Company. Transamerica Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

#### NOTE 7 TAX STATUS OF THE PLAN

The Plan uses a prototype plan document sponsored by Transamerica Retirement Solutions Corporation ("Transamerica"). Transamerica received an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.
