## INDEPENDENT AUDITORS' REPORT

The Trustee and Participants of Jorns & Associates 401(k) P/S Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Jorns & Associates 401(k) P/S Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Jorns & Associates LLC 401(k) P/S Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of Jorns & Associates LLC (the “Company” or “Employer”). The Plan was effective January 1, 2023, with the first contributions made in March of 2023.

Empower Trust Company, LLC is trustee and a custodian and Empower Annuity Insurance Company of America is a custodian of the Plan. Empower Retirement performs the recordkeeping. Previously, Ascensus Trust Company was custodian of the Plan and the recordkeeping and administrative services were provided by CoPilot Plan Services. An employee of the Company serves as trustee.

The Plan was restated effective April 19, 2024, adopting Empower’s Pre-Approved Plan, with substantially similar provisions as the previous Plan agreement.

**Eligibility** – An employee who is 18 years or older and has completed one month of service is eligible to participate in the Plan on the first day of the following month after meeting the eligibility requirements. Nonresident aliens and employees who are subject to collective bargaining are not eligible for the Plan.

**Contributions** – Participants may elect to contribute any amount of their annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. Participants direct their contributions to various mutual funds, a money market fund and common collective trusts. Participants may designate a portion or all of their deferrals as 401(k) or Roth contributions.

The Company has elected to make safe-harbor matching contributions to all employees who have deferred to the Plan at a rate of 100% of the first 4% of gross compensation contributed. Participants are immediately eligible to receive the safe harbor contributions. The Company may also make discretionary employer matching contribution, or profit-sharing contributions using an integrated allocation method. No discretionary matching or profit-sharing contributions were made in 2024.

**Participant Accounts** – Each participant’s account is credited with the participant’s and the Company’s contributions. The investment earnings (losses) on the investments are allocated to each participant’s account in the proportion that the balance of each participant’s account bears to the total balance of all participants in each investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participant contributions and the Company contributions are fully vested at all times.

**Payment of Benefits** – Upon termination of employment, the participant, or in the case of death, the participant’s beneficiary, receives the participant’s account balance in a single lump-

sum. Participants may also rollover their account to an individual retirement account or another qualified employer plan.

**Notes Receivable from Participants** – Participants may obtain a Plan loan for no less than \$1,000 and no more than the lesser of \$50,000 or one-half the employee’s account balance. Participant loans may be repaid over a term of up to five years, in accordance with Plan provisions. If the loan is for a participant’s principal residence, the repayment period may extend beyond five years from the date of the loan, but the extended period shall be the lesser of ten years or a repayment period consistent with commercial home loan practices. Participant loans are drawn from participant account balances. Interest charged on loans bears a reasonable rate of interest.

**In-Service Withdrawals** – Participants who have attained the age of 59½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Document and permitted by the IRC.

**Administrative Expenses** – The Company pays certain expenses related to the Plan. The Plan paid expenses totaling \$14,705 in 2024.

**Plan Termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan should be terminated, all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The financial statements and supplemental schedule of the Plan are prepared under the accrual basis of accounting in accordance with accounting practices generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Investment Valuation and Income Recognition** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, money market fund, and common collective trust, are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management’s Review** – Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued, and there were not material events requiring recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the net asset value (“NAV”) of shares held by the Plan at year end based on published quoted prices.

Common Collective Trusts – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held in the fund less its liabilities.

Fixed Annuity – The EI Fixed Account is stated at fair value as the guaranteed annuity contract is not considered fully-benefit responsive. Fair value is equal to the contract value, less any market value adjustment and contingent deferred sales charge, if any. The account is valued using obtainable/observable existing contracts and readily available financial information.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting

date. The Plan's investments are reported at fair value as follows at December 31, 2024 and 2023:

**(a)** Certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. These investments are valued daily, may be redeemed daily with no restrictions, and with no notice requirements. Additionally, there are no unfunded commitments.

#### **4. RISKS AND UNCERTAINTIES**

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **5. INFORMATION CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, Empower Annuity Insurance Company of America and Ascensus Trust Company, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants and related interest
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **6. TAX STATUS**

The Company adopted a Prototype Non-standardized Profit Sharing Plan with CODA which received a favorable opinion letter from the IRS on November 14, 2022, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include a fixed annuity managed by Empower. Empower is the recordkeeper and custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest. The Plan has a number of service providers, and such providers are parties-in-interest under ERISA. The Plan paid certain fees to CoPilot and Ascensus to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants also are party-in-interest transactions.

## **8. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, employee deferrals and loan payments of \$34,710 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust. The Plan will file and pay the appropriate excise tax and will contribute lost earnings to the affected participants for the late contributions. These transactions are prohibited according to the provisions of the DOL.

During the year ended December 31, 2023, employee deferrals and loan payments of \$52,552 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust. The Plan will file and pay the appropriate excise tax and will contribute lost earnings to the affected participants for the late contributions. These transactions are prohibited according to the provisions of the DOL.
