We have performed audits of the accompanying financial statements of WMCHHealth Network Affiliated Employers 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Plan Description

The following description of WMCHHealth Network Affiliated Employers 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Westchester Medical Center Advanced Physician Services, P.C., NorthEast Provider Solutions, Inc., Mid-Hudson Valley Staffco, LLC and WMC-New York, Inc. (collectively the "Employers"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Eligible employees are eligible to participate in the Plan upon their date of hire.

Contributions

Each year, eligible employees may elect to have a percentage or specified dollar amount deducted from their eligible compensation, as defined by the Plan. Participant's contributions may be deducted on a pre-tax or Roth basis. Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Employers. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Plan provides for an employer safe harbor matching contribution equal to 100% of a participant's elective deferrals not to exceed 4% of the participant's eligible compensation.

Effective January 1, 2020, the Plan was amended to include an automatic enrollment feature whereby employees whose employment commenced on or after this date would be automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 4% of their eligible compensation. The amount will be deducted on a pre-tax basis. Effective January 1, 2025, the Plan was amended to include automatic increase of deferral percentage by 1% per year up to maximum of 10% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) Employers' contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All investments are participant directed.

1. Plan Description (*continued*)

Vesting

Participants are fully vested in their accounts at all times.

Plan Expense Account

The Plan and Empower Retirement entered into a service based pricing arrangement whereby a portion of the revenue earned by certain Plan investments is passed through to the Plan for payment of permitted Plan expenses. The Plan Expense Account is a nonparticipant directed account within the Plan. The Plan Expense Account balance was \$102,941 and \$32,809 at December 31, 2024 and 2023. During 2024, \$70,547 was used from the Plan Expense Account to reduce Plan expenses.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59 1/2, in accordance with provisions specified in the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 2%. A participant may only have one loan outstanding at any given time. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term is not to exceed 15 years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (*continued*)

Fair Value Measurements

The Plan follows U.S. GAAP guidance on fair value measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. These funds are deemed actively traded. The group annuity contract is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Participants loans are measured at their unpaid principal balance plus any accrued unpaid interest and are classified as notes receivable from participants. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default upon the occurrence of a distributable event, the participant loan balance is reduced and a benefit payment is recorded as a deemed distribution.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses for maintaining the Plan are paid by the Employers and are excluded from these financial statements. Administrative fees for transaction charges are paid by the Plan. Investment related expenses are included in net appreciation in value of investments on the statement of changes in net assets available for benefits.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 7, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York, qualified institutions.

4. Group Annuity Contract

The New York Life Guaranteed Interest Account (“GIA”) is a fully benefit-responsive general account group annuity contract that guarantees principal and accumulated interest. Guarantees are provided to participating retirement plans through a group annuity contract issued by New York Life Insurance Company (“New York Life”). Contributions are invested in a fixed income portfolio within New York Life’s general account. The GIA crediting rate is subject to change every six months following the first contract year.

The GIA group annuity contract provides that, subject to certain restrictions, withdrawals for benefit payments be made at contract value for events such as death, retirement, disability and termination of employment in the normal course of business. In-service withdrawals permitted by the Plan, such as loans, hardship and other eligible in-service withdrawals will also be paid at contract value. Payment for transfers to other non-competing investment options in the Plan’s investment lineup will also be made at contract value, subject to certain restrictions for competing investment options.

Certain distributions resulting from employer-initiated events (e.g., plan termination, bankruptcy, lay-offs, early retirement incentives) may be subject to restriction or a market value adjustment as described in the GIA contract. The plan administrator does not believe that any events would limit the Plan’s ability to transact at contract value.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A++ as of October 2024), Moody’s (Aaa as of October 2024), Standard and Poor’s (AA+ as of October 2024), and Fitch (AAA as of October 2024).

5. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits. Administrative fees paid to Empower Annuity Insurance Company amounted to \$537,875 for the year ended December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan was formed using a prototype plan which the IRS has determined and informed the applicant by letter dated June 30, 2020 that the prototype plan are designed in accordance with applicable sections of the IRC. Plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

US GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
