NOTE 1 - DESCRIPTION OF THE PLAN

The Shimadzu Precision Instruments, Inc. 401(k) Plan (the "Plan"), effective January 1, 1992, is a defined contribution plan established to provide retirement benefits to eligible employees of the Plan's sponsor, Shimadzu Precision Instruments, Inc. (the "Company" or the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Participation

The Plan specifically excludes employees covered by a collective bargaining agreement, leased employees, nonresident aliens, employees under third party contract or direct contract, and employees who do not reside in the mainland United States. Interns, irregular employees, direct temporary employees, and employees on temporary assignment in the United States from Shimadzu Corporation are eligible to participate in the Plan after attaining 1,000 hours of service and are 21 or older. All other employees of the Company are eligible to participate in the Plan after completing 3 months of service. Once eligible, employees will enter the Plan on the first day of the next calendar month.

B. Contributions

Participants may contribute to the Plan through tax-deferred salary deductions of eligible compensation, as defined in the Plan, up to the statutory maximum allowed by the Internal Revenue Code (the "Code"). Effective June 1, 2023, the Plan was amended to allow roth contributions. The Company may elect to contribute discretionary matching contributions. In 2024, the Company made matching contributions of 100% of deferrals up to the first 3% of compensation. Participants are eligible to receive an employer matching contribution after completing one year of service with 1,000 hours.

C. Benefits

Normal retirement age is 65. Benefits under the Plan are generally paid as a lump sum when a participant retires, dies, or ceases to be an employee, whichever applies. Benefits may also be paid as installment payments. Hardship and age 59½ withdrawals are permitted by the Plan.

D. Vesting

A participant is fully vested immediately as to voluntary contributions, rollover contributions and related earnings. Employer contributions are vested as follows:

E. Notes Receivable from Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan is \$1,000. A maximum of three loans may be outstanding at any one time. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent. Loans must be repaid within five years, except that loans for the purchase of a principal residence may be repaid over a term of ten years. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

F. Forfeitures

Forfeitures will be used to pay administrative expenses, reduce future Company contributions, or reallocated to participant accounts in proportion to matching contributions. Only participants employed on the date that forfeitures are determined will be eligible to receive reallocated forfeitures. For the year ended December 31, 2024, forfeitures totaled \$17,378 and \$13,650 of forfeitures were used to pay fees. The forfeiture balance as of December 31, 2024 and 2023 was \$15,838 and \$10,220, respectively.

G. Administrative Expenses

Investment fund operating expenses are incurred directly by the funds and are factored into each fund as a reduction in investment return. Recordkeeping and administrative fees charged by Fidelity Trust Management Company are calculated as 23 basis points of total Plan assets. Participant loan administration, account withdrawal fees, and recordkeeping and administrative fees are charged directly to the accounts of participants. The Company pays substantially all other Plan administrative costs.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires ("GAAP") the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

C. Investment Valuation and Income Recognition (Continued)

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The following tables summarize the Plan's investments at December 31 based on the inputs used to value them:

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - INCOME TAX STATUS

The Plan is a Fidelity Management & Research Company volume submitter plan that has received a letter of opinion from the Internal Revenue Service stating that the form of the Plan qualifies under the applicable sections of the Code. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their accounts and Plan assets would be distributed based upon the participants' account balances at that time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued and managed by Fidelity Management Trust Company, the Plan's trustee. Transactions related to these investments qualify as party-in-interest transactions; however, they are exempt from the prohibitions under ERISA. In addition, the Plan continues to hold certain variable annuity contracts issued by Prudential Insurance Company of America. These contracts also qualify as party-in-interest transaction under ERISA and are likewise exempt from prohibitions.

NOTE 8 - RISK AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The Shimadzu Precision Instruments, Inc. 401(k) Plan (the “Plan”), effective January 1, 1992, is a defined contribution plan established to provide retirement benefits to eligible employees of the Plan’s sponsor, Shimadzu Precision Instruments, Inc. (the “Company” or the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Participation

The Plan specifically excludes employees covered by a collective bargaining agreement, leased employees, nonresident aliens, employees under third party contract or direct contract, and employees who do not reside in the mainland United States. Interns, irregular employees, direct temporary employees, and employees on temporary assignment in the United States from Shimadzu Corporation are eligible to participate in the Plan after attaining 1,000 hours of service and are 21 or older. All other employees of the Company are eligible to participate in the Plan after completing 3 months of service. Once eligible, employees will enter the Plan on the first day of the next calendar month.

B. Contributions

Participants may contribute to the Plan through tax-deferred salary deductions of eligible compensation, as defined in the Plan, up to the statutory maximum allowed by the Internal Revenue Code (the “Code”). Effective June 1, 2023, the Plan was amended to allow roth contributions. The Company may elect to contribute discretionary matching contributions. In 2024, the Company made matching contributions of 100% of deferrals up to the first 3% of compensation. Participants are eligible to receive an employer matching contribution after completing one year of service with 1,000 hours.

C. Benefits

Normal retirement age is 65. Benefits under the Plan are generally paid as a lump sum when a participant retires, dies, or ceases to be an employee, whichever applies. Benefits may also be paid as installment payments. Hardship and age 59½ withdrawals are permitted by the Plan.

D. Vesting

A participant is fully vested immediately as to voluntary contributions, rollover contributions and related earnings. Employer contributions are vested as follows:

E. Notes Receivable from Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan is \$1,000. A maximum of three loans may be outstanding at any one time. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus one percent. Loans must be repaid within five years, except that loans for the purchase of a principal residence may be repaid over a term of ten years. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

F. Forfeitures

Forfeitures will be used to pay administrative expenses, reduce future Company contributions, or reallocated to participant accounts in proportion to matching contributions. Only participants employed on the date that forfeitures are determined will be eligible to receive reallocated forfeitures. For the year ended December 31, 2024, forfeitures totaled \$17,378 and \$13,650 of forfeitures were used to pay fees. The forfeiture balance as of December 31, 2024 and 2023 was \$15,838 and \$10,220, respectively.

G. Administrative Expenses

Investment fund operating expenses are incurred directly by the funds and are factored into each fund as a reduction in investment return. Recordkeeping and administrative fees charged by Fidelity Trust Management Company are calculated as 23 basis points of total Plan assets. Participant loan administration, account withdrawal fees, and recordkeeping and administrative fees are charged directly to the accounts of participants. The Company pays substantially all other Plan administrative costs.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires ("GAAP") the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

C. Investment Valuation and Income Recognition (Continued)

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The following tables summarize the Plan's investments at December 31 based on the inputs used to value them:

The common/collective trusts are measured at net asset value. Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - INCOME TAX STATUS

The Plan is a Fidelity Management & Research Company volume submitter plan that has received a letter of opinion from the Internal Revenue Service stating that the form of the Plan qualifies under the applicable sections of the Code. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their accounts and Plan assets would be distributed based upon the participants' account balances at that time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued and managed by Fidelity Management Trust Company, the Plan's trustee. Transactions related to these investments qualify as party-in-interest transactions; however, they are exempt from the prohibitions under ERISA. In addition, the Plan continues to hold certain variable annuity contracts issued by Prudential Insurance Company of America. These contracts also qualify as party-in-interest transaction under ERISA and are likewise exempt from prohibitions.

NOTE 8 - RISK AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
