**INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of the

**SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We performed audits of the accompanying financial statements of the Loyola University Maryland Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTE 1**    **DESCRIPTION OF PLAN**

The following brief description of Loyola University Maryland Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

***General***

The Plan is a defined contribution plan that covers eligible employees of Loyola University Maryland, Inc. (University). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The University is a private, nonprofit higher education institution located in Baltimore, Maryland. The University provides education and training services to undergraduate and graduate students.

The Board of Trustees and Plan Administrator, acting on the authority of the University, administer the Plan. Teachers Insurance and Annuity Association of America (TIAA) is the recordkeeper of the Plan. TIAA and College Retirement Equities Fund (TIAA-CREF) is the Trustee of the Plan.

***Eligibility***

Full-time employees who are at least 21 years old are eligible to participate on their date of hire or any month thereafter. Part-time regular benefited employees who are at least 21 years old are eligible to participate on their date of hire if they are expected to complete at least 1,000 hours of service in their first year of employment. Part-time non-student employees who are not eligible for benefits become eligible following completion of the age requirement and 1,000 hours of service in any Plan year.

***Contributions***

Each year, participants may make pretax contributions up to the annual limitations defined in the Internal Revenue Code. Participants who are United States citizens or resident aliens paid under the U.S. domestic payroll and who perform services for the University primarily within the U.S. or a temporary foreign assignment are eligible to make special Code Section 403(b) contributions pursuant to the Plan. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions.

Participants may elect to make supplemental pretax contributions without a University matching contribution but within the limits permitted by tax regulations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled

participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant.

The University's matching contributions for 2024 were based on 9% of eligible compensation. Participants must have turned 21 years old, completed one year of service (some exceptions apply), and made a pretax employee contribution of at least 2% of their eligible compensation to be eligible for the match.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the University's matching contribution, and an allocation of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their elective contributions, the University's matching contributions, and earnings thereon.

***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions in various investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

***Notes Receivable From Participants***

Beginning in May 2021, participants may borrow from their accounts a minimum of \$1,000 up to 50% of their vested account balances not to exceed \$50,000. The loans are secured by the balance in the participant's account. Loan interest is fixed at the Federal Reserve Board Bank Rate plus 1%. Principal and interest are paid ratably through electronic fund transfer agreements.

***Plan Loans***

Prior to May 2021, loans were available to participants through TIAA-CREF, subject to certain limitations. The interest rate for Plan loans could be fixed or variable with the initial rate and variable rate adjustments, if applicable, determined by the terms of the loan agreement. Plan loans were issued directly from the funds owned by TIAA-CREF, and loan proceeds were not removed from a participant's account balance. However, a portion of a participant's account balance is reserved, or held in collateral, to cover the outstanding loan amount for the period the loan is outstanding. For active loans, investments equal to 110% of the outstanding loan amount are reflected in the Statements of Net Assets Available for Benefits and serve as

collateral for the loan. Investments underlying defaulted loan balances are reflected in the Statements of Net Assets Available for Benefits until a distribution event occurs.

Beginning in May 2021, no new Plan loans were available for issuance; however, existing Plan loans were not required to be converted to notes receivable from participants. As of December 31, 2024 and 2023, participants had outstanding loan balances due to TIAA-CREF of \$316,870 and \$406,207, respectively. During 2024, accumulations totaling \$82,368 were used to satisfy Plan loan defaults, which were recorded as distributions in the accompanying Statement of Changes in Net Assets Available for Benefits.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in the participant's account. Amounts contributed on a pretax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participant turns 59½ years old.

***Plan Expenses***

The administrative expenses related to the Plan's Trustee are paid by the Plan. The University pays all other administrative expenses of the Plan.

***Plan Termination***

Although the University has not expressed any intent to do so, the University has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

**NOTE 2** **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Investments***

The Plan's investments are reported at fair value, except for fully benefit responsive investment contracts which are reported at contract value. See Note 4 for a discussion of fair value measurements.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balances plus accrued interest. Delinquent participants' loans are reclassified as distributions based upon the terms of the Plan agreement.

***Payment of Benefits***

Benefits are recorded when paid.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 30, 2025, the date the financial statements were available to be issued.

**NOTE 4**    **VALUATION OF INVESTMENTS**

The Fair Value Measurements and Disclosures Topic of the Codification establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments and other financial instruments at fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2    Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Variable Annuities: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Self-Directed Funds: Valued at the closing price reported in the active market on which the individual securities are traded.

Fixed Annuity Contract—Non-Benefit Responsive: Valued at contract value, which approximates fair value. As these investments are contract based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs. The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

Pooled Separate Accounts: Valued at the NAV of shares held by the Plan at year end. NAV is quoted on a private market that is not active; however, the share price is based on underlying investments that are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use

of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5    GROUP ANNUITY CONTRACT – BENEFIT RESPONSIVE**

The Plan entered into investment contracts with TIAA-CREF that are fully benefit responsive investment contracts and, therefore, reported at contract value. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the funds, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with TIAA-CREF. Such events include the following: (a) amendments to the Plan agreement (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The group annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6** TAX STATUS

The Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions as of December 31, 2024.

**NOTE 7** PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee of the Plan. The Plan pays investment management and recordkeeping fees to parties in interest, and these expenses are included in the net appreciation in fair value of investments. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.
