To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Medicus IT 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 1 to the financial statements, the Board of Directors of Medicus IT, LLC, the Plan Sponsor, voted on June 29, 2025 to terminate the Plan, which indicates that the Plan is not a going concern. The financial statements do not include any adjustments that might be necessary upon termination. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 1. Description of the Plan

The following description of the Medicus IT 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement or the Summary Plan Description for more information about the Plan.

General

The Plan is a participant directed defined contribution plan, covering all eligible employees of Medicus IT, LLC (the Employer or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participation in the Plan is voluntary. Employees are eligible to enter the Plan immediately.

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. The Vanguard Group, Inc. (VGI) holds and manages certain Plan investments and Ascensus Trust Company provides certain services on behalf of VGI. Ascensus, LLC is the recordkeeper of the Plan, as an agent for Ascensus Trust Company, is the custodian of the Plan, and one of the Trustees. The other Trustee of the Plan is an employee of the Plan Sponsor.

Effective June 30, 2025, the Employer was merged with and into Abacus Group, LLC and the Board of Directors of the Employer voted on June 29, 2025 to terminate the Plan.

Contributions

Participants may elect to contribute any dollar amount or percentage of their eligible compensation to the Plan, on a pre-tax and after-tax basis, so long as those contributions do not exceed annual limitations set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified retirement plans.

Effective January 1, 2025, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE) Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

The Employer makes a safe-harbor matching contribution to the Plan in an amount equal to 100% of the first 3% of eligible compensation that a participant contributes to the Plan, and 50% of each participant’s eligible compensation that a participant contributes to the Plan in excess of 3% but not in excess of 5% of the participant’s compensation.

The Employer may also make a discretionary profit-sharing contribution as determined by the Employer, subject to limits imposed by Federal Law. To be eligible for the Employer's discretionary profit-sharing contribution, participants must complete at least 1,000 hours of service in the Plan year and must be employed on the last day of the Plan year.

These contributions will be allocated to participants in the ratio that each eligible participant's compensation bears to the total compensation paid to all eligible participants for the contribution period. No discretionary profit-sharing contributions were made during the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's safe harbor and profit-sharing contributions and (b) Plan earnings (losses), and (c) administrative expenses. Allocations are based on participant compensation or individual account balances, as defined. The benefit to which a participant is entitled is based on the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, Employer safe-harbor contributions and accrued earnings thereon. A participant becomes fully vested in the Employer's profit-sharing contributions and the annual allocation of Plan earnings on those contributions after five (5) years of service. Participants are partially vested in the Employer's profit-sharing contributions as follows: 25% after 2 years, 50% after 3 years, 75% after 4 years, and 100% after 5 years. Each participant shall be 100% vested in their Employer contribution accounts upon death, disability or attainment of normal retirement age.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or up to 15 years for the purchase of a principal residence, with one note outstanding at any one time. The notes are secured by the vested balance in the participant's account and bear interest at the prime rate as specified in the Wall Street Journal plus 1%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) receives a lump-sum amount equal to the value of the participant's vested interest in their account or may choose to receive annuity distributions. Participants who have reached age 59½ may elect to withdraw all or a portion of amounts in their employee deferral account while still employed by the Employer. In addition, participants may request a financial hardship withdrawal from their elective deferral and rollover accounts, subject to limitations imposed by the IRC.

Effective January 1, 2023, the Plan adopted the provision of the SECURE Act 2.0 to permit self-certification of financial hardship withdrawals.

If a participant's vested account balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance, and the non-vested portion shall be treated as a forfeiture. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount will be distributed in cash or rolled over to an individual retirement account designated by the Employer, unless otherwise directed by the participant.

Effective January 1, 2024, the Plan adopted the provision of the SECURE Act 2.0 to increase the limit for involuntary automatic lump-sum distribution for account balances from \$5,000 to \$7,000.

Forfeitures

Participants in the Plan who leave employment of the Employer before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeited non-vested accounts may be used to reduce Employer matching contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$176 and \$10,277, respectively. For the year ended December 31, 2024, \$10,250 was utilized to reduce Employer matching contributions or pay administrative expenses.

Plan Termination

The Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts. As noted above, the Employer was merged into Abacus Group, LLC on June 30, 2025 and the Plan was formally terminated. Participants were given the option to take a full cash distribution, rollover their account balance to an IRA or into the Abacus Group, LLC 401(k) Plan. As of August 19, 2025, the Plan's assets were fully distributed out of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions

Participant and employer safe harbor contributions are recorded bi-weekly when the Employer remits the payroll deductions for investment into the Plan. Plan Sponsor discretionary profit-sharing contributions are remitted and recorded annually, if applicable.

Payment of Benefits

Benefits are recorded when paid to participants or their designated beneficiaries. Also recorded are distributions paid to former employees when their funds are paid to them or rolled over into another plan.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan invests in the Putnam Stable Value Fund, a common collective trust fund. The Plan's interest in the common collective trust funds is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

Administrative Revenue (Expenses)

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management fees for certain investments are included as a reduction of investment return (net appreciation or depreciation) and not reflected separately in the Statements of Changes in Net Assets Available for Plan Benefits. Administrative revenues arise when investment managers return a portion of the investment fees to the record keeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. There were \$118 and \$62 in unallocated administrative revenues held by the Plan at December 31, 2024 and 2023, respectively.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in two mutual funds that accounted for approximately 37% and 38% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through October 3, 2025, which is the date these financial statements were available to be issued

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Fund: The Plan invests in the Putnam Stable Value Fund, an investment vehicle that invests in benefit-responsive investment contracts, fixed income securities and money market funds. It is valued at NAV of units held by the Plan. The NAV, as provided by Putnam, is used as a practical expedient to estimate fair value. The NAV is based on fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund’s net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there is up to a 12-month redemption for this investment at the Plan level.

As of December 31, 2024 and 2023, the Plan’s investments in mutual funds are reported at level 1 within the fair value hierarchy. The Plan’s investments are as follows:

4. Income Tax Status

The Plan has been designed using a defined contribution non-standardized profit sharing plan by Ascensus, LLC. The Plan obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Summary of Information Certified by a Trustee

The following is a summary of financial information and data certified by Ascensus, LLC, the recordkeeper of the Plan as an agent for Ascensus Trust Company, a Trustee of the Plan:

Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, except for contribution receivables;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided on the Supplemental Schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

6. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

7. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are held and managed by VGI, and recordkeeping administrative services are provided by Ascensus, LLC. The Plan utilizes LPL Financial LLC (LPL Financial) as an investment advisor. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to VGI for investment management services of approximately \$9,000 for the year ended December 31, 2024. The Plan also made direct payments of approximately \$10,300 to LPL Financial during 2024. Participants note receivable also qualify as party-in-interest transactions. In addition, an employee of the Plan Sponsor served as one of the Trustees of the Plan.
