#### 1. DESCRIPTION OF THE PLAN

The following description of Quorum Business Solutions (U.S.A.), Inc. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the formal plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan, which was amended as of January 1, 2021 to comply with current law, is intended to be a qualified retirement plan that helps its employees save for retirement. The Plan covers substantially all employees of Quorum Business Solutions (U.S.A.), Inc. (“Company”). Participating employers include Coastal Flow Gas Management, Coastal Flow Liquid Measurement, and Enersight (USA), Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Plan Administration**

The Company is responsible for the day-to-day administration and operation of the Plan. Vanguard Fiduciary Trust Company serves as the trustee of the Plan. All amounts contributed to the Plan are held by Vanguard Fiduciary Trust Company in a qualified trust. Vanguard Fiduciary Trust Company is responsible for the safekeeping of the trust funds.

##### **Eligibility**

There is no minimum age requirement or minimum service requirement to participate under the Plan. Employees of the Company are eligible to participate in the Plan on the first day of the month coinciding with or next following their first day of employment. Collectively bargained employees, non-resident aliens, leased employees, temporary employees, and interns are not eligible to participate in the Plan.

##### **Contributions**

Participants are eligible to make salary deferrals to the Plan by requesting that a portion of their compensation be contributed to the Plan instead of being paid as wages. Participants can increase or decrease the amount of their salary deferrals during the year. The Plan is also set up with an automatic deferral feature in which the Company will automatically withhold 6% of the participant’s plan compensation. The Internal Revenue Service (“IRS”) imposes limits on the amount a participant can contribute as salary deferrals during a calendar year. Participants at least age 50 by the end of a calendar year may make special catch-up contributions to the Plan.

The Company may make a discretionary matching contribution to the Plan. Each year, the Company will determine the formula for the matching contribution. For 2024, the employer matching contribution was 50% of the first 6% of eligible compensation that a participant contributed to the Plan. The participant must have been employed on the last day of the calendar year to be eligible to receive the employer matching contribution.

If a participant has an account balance in another qualified retirement plan or an IRA, the participant may move those amounts into the Plan by means of a rollover contribution.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer contributions, rollover contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are always 100% vested in their salary deferrals and rollover contributions plus actual Plan earnings thereon. The participant's vested percentage in employer contributions is based on years of vesting service. A participant becomes 100% vested after four years of service.

**Investment of Plan Assets**

Participants have the right to direct the investment of Plan assets held under the Plan on their behalf. The Company will provide participants the investment choices available to them and other investment information. Participants can change their investment directions amount the investment options available in the Plan with respect to future plan contributions or existing individual account balances at any time.

**Notes Receivable from Participants**

Loans shall be made available to all eligible participants on an equal basis. The maximum amount a participant may borrow cannot exceed the lesser of 50% of their vested account balance or \$50,000, minus the highest outstanding loan balance, the participant had at any one time during the prior one-year period. The participant's vested account balances will be considered security for the loan. The interest rate applicable to the loan is determined by the Plan. Loan repayments are made according to an established repayment schedule and will be deducted automatically from the participant's paychecks on an after-tax basis.

**Payment of Benefits**

When a participant terminates employment, they may be entitled to a distribution from the Plan. If the total vested account balance exceeds \$5,000, the participant must consent to a distribution and may elect to take such distribution as a lump sum, partial lump sums, or installment payments. If the participant does not consent to a distribution, the balance will remain in the Plan. If the total vested account balance under the Plan is \$1,000 or less and the participant does not consent to a distribution of their vested account balance, the vested benefit will be distributed in a lump sum.

A participant may withdraw vested amounts from the Plan while they are still employed with the Company if they satisfy the Plan's requirements for in-service distributions. A participant may take an in-service distribution upon any of the following events: they are at least age 59½ at the time of distribution, they have incurred a hardship, they became disabled, or they are in certain qualified active military duty.

**Forfeited Accounts**

If a participant terminates employment before becoming fully vested in their plan benefits, the non-vested benefits will be forfeited. Forfeitures may be used to pay plan expenses or reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$427,048 and \$231,868, respectively.

**2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Other income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**3. CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, a qualified institution.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund – Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily NAV and to transact at that price. The money market fund is deemed to be actively traded.

Common/collective trust – Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. This practical expedient is not used when it is determined to be probable that the collective trust will sell the investment for an amount different than the reported NAV.

**5. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Vanguard. Vanguard is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan also engages in transactions with participants related to notes receivable. These transactions are covered by an exemption from the prohibited transactions provisions of ERISA and the Internal Revenue Code (“IRC”). Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**6. PLAN TERMINATION**

Although the Company expects to maintain the Plan indefinitely, the Company has the ability to terminate the Plan at any time. Termination includes a complete discontinuance of contributions under the Plan or a partial termination. If the Plan is terminated, all amounts credited to participants’ accounts shall become 100% vested, regardless of the Plan’s current vesting schedule. In the event of the termination of the Plan, participants are entitled to a distribution of their entire vested benefit.

**7. TAX STATUS**

The pre-approved plan adopted by the Company received its latest opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
