## INDEPENDENT AUDITORS' REPORT

To the Trustees and Plan Committee  
Cambridge Management, Inc. 401(k) Plan  
Tacoma, Washington

### Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Cambridge Management, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cambridge Management, Inc 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cambridge Management, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. **NOTE A.--DESCRIPTION OF PLAN**

The following description of the Cambridge Management, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution 401(k) plan originally established by Cambridge Management, Inc. (the Company) effective January 1, 2008, and recently restated January 1, 2022 to be in accordance with the Cycle 3 Plan Restatement requirements. The Plan was amended January 1, 2023 with amendments 3 and 4, that changed the amount of an automatic deferral arrangement to 5% and applied the provisions to only new plan participants, then changed the deferral amount back to 2% with an automatic escalation of 1%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company excluding employees that are non-resident aliens, leased employees, residents of Puerto Rico, and temporary and seasonal employees, unless the temporary or seasonal employee actually completes a year of service then such employee will no longer be a part of the excluded class. An eligible employee becomes eligible to participate in the plan after completing six months of service and reaching 18 years of age. The entry date is the first day of the month coinciding with or following the completion of eligibility requirements. Effective January 1, 2024, the Plan adopted a provision to increase mandatory cash-outs from \$5,000 to \$7,000.

*Contributions:* The Plan is funded by eligible participant elective deferrals which may range from 1% to 100% of eligible compensation and safe-harbor matching contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Also, all participants who are eligible to make elective deferrals may elect to designate all or any portion of their elective deferrals to Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Contributions are subject to certain limitations set by law.

The Plan provides for automatic enrollment of all employees who do not make an affirmative election to participate unless employee opts out. Newly eligible employees are enrolled in the Plan in accordance with a traditional automatic contribution amount of 2% of compensation for each payroll period. Each year thereafter, there is an automatic escalation in rates of 1% of compensation up to a maximum of 6% of compensation for all participants. Participants may elect to change or stop their payroll deduction at any time.

*Contributions (Continued):* The plan Sponsor uses a safe harbor matching contribution equal to 100% of the participants elective deferral contribution amount not exceeding 3% of the participant's eligible compensation, plus 50% of the amount the participants deferral contributions exceeding 3% of eligible compensation but not exceeding 5% of compensation.

*Participant Accounts:* Each participant's account is credited with the participant's contributions, Sponsor matching contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are immediately vested in their safe harbor matching contributions, rollover contributions and elective deferrals, plus actual earnings thereon. Vesting in Company non-safe-harbor matching contributions made prior to January 1, 2019 is based on years of continuous service at the rate of 20% per year after two years of service. A participant is 100% vested after six years of credited service or upon death or disability.

*Notes Receivable from Participants:* Participant may borrow from all vested balances a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participants account. A participant may only initiate two loans per calendar year and may only have one loan outstanding at a time unless one loan is a principal residence loan amortized for a period greater than five years. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within ten years. Under the terms of the Plan agreement, plan loans must bear a rate of interest similar to commercial loans by persons or institutions in the business of lending money in the same geographic area as the employer. Principal and interest are paid through payroll deductions.

*Retirement:* The normal retirement date is the date a participant attains age 65. There is no early retirement.

*Payment of Benefits:* Upon termination due to death, disability, retirement, or other reasons, a participant may receive a lump sum equal to the value of the participant's vested interest in his or her account as soon as administratively feasible, partial withdrawals, or in installments. Required distributions at age 70 ½ may be in lump sum, partial withdrawals, or installments. The participant's entire account balance must be paid by no later than 60 days following the end of the plan year in which the participant dies.

If, on termination of service, a participant has a vested interest in his account which is \$7,000 or less, he shall automatically receive a lump sum equal to the value of his account without the participant's consent. Hardship distributions are allowed in accordance with the provisions of the Plan. In-service distributions may be made at age 59 ½ and qualified reservist distributions are allowed.

*Forfeited Accounts:* Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and shall be used to restore forfeitures, pay plan expenses or to offset employer contributions. Forfeitures used were \$451 during the year ended December 31, 2024. The balance of unused nonvested account balances forfeited into the Plan as of December 31, 2024 and 2023 were \$16,076 and \$6,734, respectively.

*Investment Options:* Participants are allowed to direct their contributions and account balances in a variety of investment options including mutual funds and a fully benefit-responsive investment contract. The Sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

*Plan Expenses:* Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid for directly by the Company and are excluded from these financial statements. Fees relating to administration of notes receivable and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses, including any 12(b)(1) fees and revenue sharing fees, are deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

**NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Use of Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the financial statements and accompanying disclosures. Accordingly, actual results could differ from those estimates.

*Investment Valuation and Income Recognition:* Investments are reported at fair value, (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by the investment advisor and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Payment of Benefits:* Benefits are recorded when paid.

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE D.--FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E.--FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan invests in the Standard Stable Asset Fund A, which is a deposit administration contract with Standard Insurance Company (Standard). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by The Standard, represents contributions made under each contract, plus interest credited, less participant withdrawals and administrative expenses. Contract value of the Plan's investment in the fund was \$82,591 and \$67,807 at December 31, 2024 and 2023, respectively.

**NOTE E.--FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)**

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan that is declared quarterly. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Standard may terminate the contract with 30 days' advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time.

Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

**NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments may be in funds managed by the custodian, Charles Schwab Trust Bank or the Third Party Plan Administrator, Standard Insurance; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. Certain officers serve as trustees of the Plan. No such officer or employee receives compensation from the Plan.

**NOTE G.--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan shall become fully vested and non-forfeitable.

**NOTE H.--TAX STATUS**

The Plan was amended and restated effective January 1, 2022 and adopted a non-standardized pre-approved profit sharing/money purchase plan with cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I.--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE K.--SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan adopted a provision to allow an increase in catch-up contributions. Participants aged 50 and over are allowed to contribute an additional \$7,500 beyond the standard limit. A “super” catch-up contribution of \$11,250 is available for participants aged 60 to 63 years old.

Effective January 1, 2025, the Plan adopted a provision to allow long-term part-time (LTPT) employees to participate in the Plan by making elective deferrals. The LTPT employees must have worked two consecutive years with 500-999 hours of service beginning in 2021. Employees must also be at least age 21 and have never worked more than 1,000 hours of service in a year. LTPT employees are not eligible to receive any Employer contributions, including safe harbor or matching contributions.

Plan management has evaluated subsequent events through October 6, 2025 the date the financial statements were available to be issued.
