**NOTE 1           SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Operations**

Anoplate Corporation Employees' Deferred Savings and Profit Sharing Plan and Trust (the Plan) is a 401(k) deferred savings profit sharing plan covering all eligible employees of Anoplate Corporation (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting, in which revenue is recognized when earned or otherwise available, and expenses are recognized when incurred.

**Investment Valuation and Income Recognition**

Plan investments are held by Fidelity Management Trust Company and are recorded at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are recorded at unpaid principal balance at year end plus any unpaid accrued interest. The Plan considers the notes receivable from participants fully collectible at year end; accordingly, no allowance for doubtful accounts is required. Interest is recognized over the term of the loan. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 2            DESCRIPTION OF PLAN**

The following brief description of the Plan provides only general information. Participants should refer to the Summary Plan Description or the Plan document for a more complete description of the Plan's provisions.

*Eligibility.* Employees of the Company who have completed three months of service are eligible to participate in the Plan and receive employer contributions. Upon completion of eligibility requirements, the employees can enroll in the Plan on the first day of each month. Also, unless they affirmatively elect otherwise, all newly eligible employees are enrolled automatically into the Plan at an initial pre-tax deferral rate of 4%. Deferrals then increase annually by 1% to a maximum of 8% unless affirmatively elected otherwise.

*Contributions.* Each year, participants may contribute a specified portion of their pre- or post-tax annual eligible compensation to the Plan, subject to Internal Revenue Service limitations. Rollover contributions by participants are also permitted. Participants must complete three months of service to be eligible for both employee and employer contributions. The entry date shall be the first day of each month coinciding with or immediately following the date such eligible employee completes the service requirements. The employer makes Safe Harbor matching contributions on behalf of all eligible employees equal to 100% of the first 3%, and 50% of the next 2% of eligible compensation. Reimbursements or other expense allowances, fringe benefits (cash and non-cash), moving expenses, deferred compensation, welfare benefits, unused leave and differential wages are all excluded to determine eligible compensation when computing employee deferral, employer matching and employer nonelective contributions. The Company may make annual discretionary nonelective contributions in an amount to be determined at Plan year end by the Board of Directors of the Company.

In addition, the Plan allows for qualified employer matching contributions and qualified discretionary non-elective contributions. For the years ending December 31, 2024 and 2023, the Company made non-discretionary matching contributions only.

*Participant Accounts.* Each participant's account is credited with the participant's contribution, employer contributions and an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. All investments are directed by the Plan participants.

*Vesting.* Participants are immediately 100% vested in employee rollover contributions, employee contributions, and all employer contributions. All other contributions to the Plan follow the graduated vesting schedules in the Plan document.

*Payment of Benefits.* Upon normal retirement, death, disability or termination of service, a participant may elect to receive the vested value of his or her account either in a lump-sum amount, a rollover to a qualified IRA, or in installment payments as defined in the Plan document. In-service distributions are also allowed for hardship withdrawals and withdrawals after normal retirement age and after age 73, as defined in the plan document.

*Forfeitures.* The non-vested portion of a terminated participant's account is forfeited when they receive a distribution of their entire vested account or after they have incurred five consecutive one-year breaks in service. Forfeitures of unvested balances by terminated participants are used to reduce future employer contributions to the Plan.

Forfeitures available to offset future employer contributions totaled \$9,300 and \$3 at December 31, 2024 and 2023, respectively. Forfeitures of \$5,925 and \$1,138 were used to reduce employer contributions in 2024 and 2023, respectively.

*Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of the lesser of fifty percent of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and should bear a reasonable rate of interest fixed over the term of the loan.

*Administrative Costs.* Distribution and loan fees are paid by the participant that receives the related distribution or loan. Other administrative expenses of the Plan are paid either directly by the participant or by the Company.

*Termination of the Plan.* Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

**NOTE 3**            **SUMMARY OF INFORMATION CERTIFIED BY PLAN TRUSTEE**

The total fair value of investments held in trust was \$21,335,535 and \$18,375,411 at December 31, 2024 and 2023, respectively. The total amount of notes receivable from participants held in trust was \$66,641 and \$45,109 at December 31, 2024 and 2023, respectively. The trustee, Fidelity Management Trust Company, has supplied the Plan's administrator with certifications as to the completeness and accuracy of all information regarding investments and notes receivable from participant assets, transactions, and income presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4**            **PARTY-IN-INTEREST TRANSACTIONS**

A party-in-interest is defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Plan assets are used to pay some expenses for administration of the Plan and the remaining administrative expenses are paid by the Company or by the participants. Payments to such service providers by the Plan qualify as party-in-interest transactions.

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The investments managed by Fidelity Management Trust Company represented 92% of the Plan's net assets available for benefits for both of the years ended December 31, 2024 and 2023. The fees paid to Fidelity Management Trust Company were \$788 and \$750 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board authoritative guidance on fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All assets have been valued using a market approach.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 TAX STATUS**

The Plan is an adoption of a prototype standardized profit-sharing plan and is qualified under Section 401(a) of the Internal Revenue Code plan. The Plan adopted the amendment and restatement of the previous prototype plan effective April 1, 2016.

The prototype plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 7                    RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**NOTE 8                    CARES ACT PROVISIONS**

During the 2020 Plan year, the Plan changed some provisions to comply with the requirements of the Further Consolidated Appropriations Act, 2020, including the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) provisions, the Coronavirus, Aid, Relief and Economic Security (CARES) Act, and the Consolidated Appropriations Act, 2021 (CAA), and corresponding guidance. The Plan implemented certain requirements, among others, that allowed certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, delayed the commencement date for required minimum distributions, and allowed participants to take qualified COVID-19 related distributions up to \$100,000 from the Plan within the applicable time periods as defined in the relevant sections of Applicable Law. Written amendments to the Plan to reflect those operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

**NOTE 9                    SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.
