Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Local 2138 U.S.W.A. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 19, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 through December 19, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Local 2138 U.S.W.A. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 19, 2024 and December 31, 2023, and for the period ended December 19, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Local 2138 U.S.W.A. Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Local 2138 U.S.W.A. - Exercise professional judgment and maintain professional skepticism throughout the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of Local 2138 U.S.W.A. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective April 1, 1990 and has been amended throughout the years. The Plan was most recently amended and restated effective January 1, 2022. The Plan covers all full-time employees of Veritas Steel (fka: PDM Bridge) (the Employer) who are represented by the United Steel Workers of America Local 2138 (Plan Sponsor) and have completed three months of employment. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 75% of their annual compensation as pre-tax or Roth contributions to the Plan. Effective, April 1, 2022, the Plan includes an automatic enrollment feature, whereby new participants are automatically enrolled in the Plan at 3%, unless elected otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employer is required to make contributions to the Plan as required by the current collective bargaining agreement (\$41 per week for 2024) between the Employer and the Plan Sponsor on behalf of each participant who has completed at least 65 working days during the Plan year. During the period ended December 19, 2024, the Employer contributed \$226,443 to the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or certain individual retirement accounts (IRA). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, an allocation of Plan earnings or losses, and certain Plan expenses. Allocations are based on participant account balances and pursuant to the current collective bargaining agreement, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all sources of contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest are paid ratably through payroll deductions. Note terms range up to five years or longer for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest equal to the prime rate plus 1%.

Benefit Payments

Upon termination of service, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in their account in the form of a lump sum distribution. The Plan allows for in-service distributions at age 65 and hardship distributions, subject to Plan provisions. If a participant terminates employment and the participant's account balance is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the account balance is between \$1,000 and \$5,000, the Plan administrator will authorize that it be rolled over into an IRA.

Plan Transfer

Effective December 19, 2024, the Executive Committee elected to join the OpenPEP and authorized the merger of assets from the Plan to OpenPEP. On December 18, 2024, assets in the amount of \$7,729,809 were transferred from the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 19, 2024 or December 31, 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Contributions

Contributions from participants and Employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to the administration of benefits paid, notes receivable from participants, investment custodial, investment advisory and audit fees are charged to the participant accounts and are included in the administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

John Hancock Life Insurance Company (John Hancock), the insurance company, has supplied the Plan administrator with certification as to the completeness and accuracy of the investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 19, 2024 and December 31, 2023, the statement of changes in net assets available for benefits for the year period December 19, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 19, 2024 and December 31, 2023.

Pooled Separate Accounts – Valued daily at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investments securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Effective December 19, 2024, the Plan was terminated and all assets and liabilities were transferred to the OpenPEP, a Pooled Employer Plan (PEP).

As a result of the transfer, the Plan had no net assets available for benefits as of December 19, 2024. The transfer included all participant account balances, outstanding participant loans, and any other plan assets. Final distributions and transfers were completed in accordance with the Plan's provisions and applicable regulatory requirements.

The financial statements reflect the Plan's termination and the full transfer of assets. Accordingly, the Plan's net assets available for benefits as of December 19, 2024 are \$0. The Plan has filed a final Form 5500 for the plan year ended December 31, 2024 marked as "Final return/report."

The Plan did not adopt the liquidation basis of accounting as the transfer of assets was completed during the reporting period and no further activity is expected.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore, not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by John Hancock, the insurance company. Therefore, these transactions qualify as party-in-interest. Fees paid during the period for services rendered by John Hancock are based on customary rates for such services.

NOTE 9 CONTRACT WITH INSURANCE COMPANY

On May 29, 1997, the Plan entered into a group annuity contract with John Hancock Life Insurance Company. The contract is used as a funding vehicle for the separate accounts.
