We have performed audits of the financial statements of Richardson Manufacturing Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE A | DESCRIPTION OF PLAN**

The following description of the Richardson Manufacturing Company 401(k) Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*1. General*

The Plan is a defined contribution retirement savings plan covering all eligible employees of Richardson Manufacturing Company (the Employer). Employees are eligible to participate in the Plan on the first day of the month following one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Employer is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

*2. Contributions*

The Plan includes a 401(k) provision, which allows participants to contribute up to the maximum dollar amount as determined by the Federal government of pretax annual compensation, as defined in the Plan. The maximum deferral in 2024 and 2023 was \$ 23,000 and \$ 22,500, respectively, with the option of an additional catch-up deferral for those 50 years of age or over of \$ 7,500 in both 2024 and 2023. The Plan also includes a provision that allows rollovers from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect to defer a different percentage. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. At the anniversary date of the participant's deferral default enrollment date, the deferral rate increases by 1% for participants utilizing the auto-enrollment feature up to a maximum deferral rate of 6%.

The Employer may make matching contributions equal to a discretionary percentage, to be determined by the Employer, of the participant's elective deferrals. For the years ended December 31, 2024 and 2023, the Plan elected to contribute a safe harbor matching contribution. The Employer matches 100% of participant's elective deferrals not exceeding 1% of the participant's compensation, plus 50% of participant's elective deferrals in excess of 1% but not in excess of 6% of the participant's compensation. In addition, the Employer has a right to make a discretionary profit-sharing contribution to the Plan. The Employer made no profit-sharing contributions during 2024 and 2023.

**NOTE A | DESCRIPTION OF PLAN**

*3. Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of the Employer's contribution and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*4. Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's discretionary matching contribution portion of their account is based on years of service. A participant becomes 20% vested after two years of service, increasing by 20% per additional year, with full vesting after six years of credited service. Vesting in the Employer's safe harbor matching contribution portion of their account is based on years of service. A participant is not vested in the safe harbor matching contribution until reaching two years of service at which time the participant becomes 100% vested.

*5. Investments*

Upon enrollment in the Plan, a participant may direct contributions to selected investments as made available and determined by the Plan trustee. Participants may change their investment options at any time pursuant to procedures established in the Plan document.

*6. Payment of Benefits*

Upon the occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan Agreement, a participant may elect to receive a lump-sum cash distribution equal to the value of the participant's vested interest in his or her account. Hardship and in-service withdrawals, as defined in the Plan Agreement, are also permitted from a participant's account.

*7. Forfeitures*

The Plan applies forfeited non-vested account balances to reduce administrative expenses and employer contributions. During 2024 and 2023, the Plan used \$ 27,675 and \$ 20,397, respectively, to reduce administrative expenses and employer contributions. The Plan did not have any non-vested forfeitures as of December 31, 2024. As of December 31, 2023, the non-vested forfeiture account balance was \$ 57.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

*1. Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*2. Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*3. Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and trustee. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*4. Payment of Benefits*

Benefit payments are recorded when paid.

*5. Expenses*

Salaries and related costs of personnel administering the Plan, and certain legal and other professional fees with parties-in-interest are paid by the Employer and are not included in the accompanying financial statements. Other administrative costs of the Plan are paid by the Plan participants, as provided in the Plan document. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

6. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 2, 2025, which is the date the financial statements were available to be issued. Through October 2, 2025, no subsequent events required recognition or disclosure in the financial statements.

**NOTE C | FAIR VALUE MEASUREMENTS**

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. The guidance defines fair value, establishes a framework for measuring fair value and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The Plan has not made any fair value elections.

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an asset or liability as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

**NOTE C | FAIR VALUE MEASUREMENTS**

The following is a description of the valuation methodologies used for investments measured at fair value.

In 2024 and 2023, the pooled separate accounts classified in level 1 consists only of level 1 pricing inputs. The net asset value (NAV) of a separate account is not publicly quoted but is available to current investors via the Trustee’s website or when plan participants access their account values. The NAV is the basis for current transactions and the pooled separate account can be redeemed at NAV as of the measurement date. Therefore, the pooled separate account is considered to have a "readily determinable fair value." There are no conditions, limits, or restrictions on redemption transactions and amounts can be redeemed on a daily basis. The pooled separate account invests only in mutual funds that are deemed to be actively traded.

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE D | INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan allows participants to invest in a fully benefit-responsive investment contract with American United Life Insurance Company (AUL). AUL maintains these contributions in a general account. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The investment contract is designed to accrue interest based on a crediting rate established by the contract issuer. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract. Accordingly, the contract value is also the fair value. If an event should occur such that realization of full contract value for a particular investment contract is no longer probable, the contract will no longer be considered fully benefit-responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (such as complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an incurred violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE F | PLAN TERMINATION**

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of partial or total Plan termination, participants will be entitled to the full amount in their accounts as of the date of termination.

**NOTE G | TAX STATUS**

Upon transition to AUL as trustee, the Plan adopted a volume submitter profit sharing plan from OneAmerica Financial Partners, Inc. The Plan is a non-standardized pre-approved profit-sharing plan with CODA and received its last opinion letter dated August 19, 2020, stating that the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
