Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Other Matter — Supplemental Schedules Required by ERISA

December 31, 2024 and 2023

#### Note 1 - Description of the Plan

The following brief description of the PTI Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan, effective on January 1, 2016, is a defined contribution plan covering all eligible employees of Pac-Tech International, Inc. (the Plan Sponsor), who have completed three (3) months of continuous service and have reached the minimum age of eighteen (18) years, except employees covered by a collective bargaining agreement and temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 1081.01 of the Puerto Rico Internal Revenue Code (the Code).

##### Contributions

Each year, participants may contribute an amount of their compensation not exceeding the maximum deferral amount specified by local law. Participants may also contribute amounts representing distributions from other qualified plans, subject to the conditions and limitations set forth in the Plan agreement. The Plan's Sponsor shall, at its sole discretion, contribute to the accounts of participants. The Plan Sponsor matches the employees' elective deferrals not exceeding a percentage of compensation determined by the Plan Sponsor each plan year. For the year ended December 31, 2024, the Plan Sponsor matched up to 4% of each employees' contribution. The Plan Sponsor may, from time to time, make profit sharing contributions to the Plan at the option of the Plan Sponsor's Board of Directors.

Contributions are invested in various investment funds provided by Mid Atlantic Trust Company (the custodian of the Plan) as permitted in the Plan agreement.

##### Participant accounts

Each participant's account is credited with the participant's contribution and allocations of: (a) the Plan Sponsor's contribution and, (b) Plan earnings or losses. Allocations of Plan earnings are based on the participant's account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements – (Continued)

December 31, 2024 and 2023

Note 1 - Description of the Plan – (continued)

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's contributions is based on years of continuous service, as follows:

Investment options

Upon enrollment in the Plan, participants direct the investment of their accounts balances into various investment options offered by the Plan and may change investments and transfer amounts between funds as needed. The Plan currently offers mutual funds and demand deposits as investments options to its participants.

Notes receivable from participants

Notes receivable from participants are not permitted.

Excess participants' contribution payable

Participants may contribute excess contributions which will be reimbursed to the participants. Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits and as a reduction of participant-directed contributions for the year.

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or participant's beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or periodic installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

#### Note 1 - Description of the Plan – (continued)

##### Forfeitures

Upon a participant's termination from the Plan Sponsor or withdrawal from the Plan for any reason other than death, retirement or disability, the employer contributions on behalf of the participants not then vested are forfeited and used to reduce future Plan Sponsor's contributions, profit-sharing contributions or to pay administrative expenses. During the year ended December 31, 2024 and 2023, the Plan used these funds to pay administrative expenses amounted to \$8,328 and \$12,927, respectively. At December 31, 2024 and 2023, total forfeitures account amounted to \$24,755 and \$18,840, respectively.

##### Administrative expenses

Administrative expenses are paid directly by the Plan Sponsor unless paid by the Plan. Investment fees are paid by the Plan, while transaction charges are deducted from the participants' accounts.

##### Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested on their accounts.

#### Note 2 - Summary of accounting policies

Following are the significant accounting policies followed by the Plan:

##### Basis of accounting and presentation

The accompanying financial statements have been prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Payment of benefits

Benefits are recorded when paid.

December 31, 2024 and 2023

Note 2 - Summary of accounting policies – (continued)

Investments valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's investments appreciated in value by \$267,421.

Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accountants (AICPA), *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. As of December 31, 2024 and 2023, benefits owed to the participants amounted to \$20,978 and \$16,426, respectively.

Note 3 - Information certified by the Trustee (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Oriental Bank (the Trustee), has certified as to the completeness and accuracy of all investments related information reflected in the accompanying financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and schedule H, Part IV, line 4i – schedule of assets (held at year end) as of December 31, 2024. The Trustee maintains all records, executes investment transactions, and holds all the assets of the Plan. In addition, the trustee, upon authorization from the plan administrator, distributes benefit payments to the participants.

Note 4 - Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) No. 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Note 4 - Fair value measurements – (continued)

The three levels of the fair value hierarchy under the above-mentioned standard are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

- *Mutual funds* – valued at the net asset value of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded and were classified as Level 1.
- *Money market account* – valued at cost, plus accrued interest, which approximates fair value. These investments are classified as Level 1.

Note 4 - Fair Value Measurements – (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in these methodologies used at December 31, 2024 and 2023.

Note 5 - Party-in-Interest Transactions

Certain Plan investments consist of mutual funds managed by the Custodian. Therefore, these transactions qualify as party in interest transactions.

Note 6 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - Non-Discrimination Test

During the years ended December 31, 2024 and 2023, the Plan failed the non-discrimination test required by the Code. This test requires compliance with a determined percentage of contributions to the Plan as established in Section 1081.01(d) of 2011 Code.

The Plan Sponsor had the following alternatives to correct this non-compliance: (a) additional employer contributions to non-highly compensated participants, (b) reimbursement to highly compensated participants of their excess contributions, which would result in reporting this reimbursement as taxable income for the year in which the noncompliance takes place, or (c) reclassifying the excess contributions of high compensated participants as post-tax contributions, which requires reporting this excess amount as a taxable income for the year in which the reclassification takes place.

In order to comply with non-discrimination rules, the 2024 non-compliance event was corrected on April 10, 2025, through a reimbursement of excess contributions, plus accumulated earnings through the date of the reimbursement, for \$18,475 to certain highly compensated employees. The 2023 non-compliance event was corrected on April 11, 2024, through a reimbursement of excess contributions, plus accumulated earnings through the date of the reimbursement, for \$17,466 to certain highly compensated employees.

Note 8 - Delinquent Participant Contributions

For the year ended December 31, 2024, the Plan Sponsor remitted participants' contributions for several payroll periods amounting to \$12,814 to the Trustee later than required by the Department of Labor Regulation 2510.3-102. Participant contributions are pending to be credited by the corresponding estimated investment income that would have been earned had the participants' contributions been remitted on a timely basis. Delays in remitting contributions to the Trustee were due to unintentional administrative errors.

Note 9 - Tax Status

The Plan constitutes a qualified plan exempted from income tax under the provisions of Section 1081.01 of the Code. The Plan obtained a favorable determination letter on February 7, 2018, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

Management has evaluated the Plan tax position and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements.

Note 10 - Subsequent Events

The Plan has evaluated the impact of subsequent events through October 7, 2025, which is the date these financial statements were available to be issued. Except as described in Note 7, no other events have occurred subsequent to the statement of net asset available for benefit date and to the date financial statements were available to be issued, that would require additional adjustment to, or disclosure in the financial statements.
