1. **Description of Plan**

The following description of the Margolis Edelstein (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering full-time employees who have completed at least three continuous months of service. Part-time employees must complete 1,000 hours of service and reach age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 80% of annual eligible compensation, as defined in the Plan, up to the maximum salary reduction amount allowed by law (\$23,000 in 2024). Participants have the option to contribute on both a pretax and/or an after-tax basis. For 2024, participants who are projected to be age 50 or older by the end of the calendar year may also make a catch-up contribution of up to \$7,500. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Employees who have met the eligibility requirements will have 5% of their eligible compensation automatically withheld and deferred unless they elect otherwise. Unless a participant elects out, an automatic 1% increase will be applied on an annual basis each subsequent October 1, up to an annual maximum of 3% and a total deferral of 10%. Beginning in 2011, participants may elect to convert all, or a portion of their non-Roth vested account balance to a Roth Conversion Account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers twenty-eight mutual funds and a self-directed account option (Fidelity BrokerageLink) for those participants that want to choose from a wider variety of exchange traded mutual funds available based on employer guidelines as investment options for participants. Discretionary profit-sharing contributions may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations. The Company made employer contributions of \$498,462 and \$500,000 in 2024 and 2023, respectively.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s profit-sharing contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Company’s profit-sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service. A participant becomes fully vested upon death, termination of employment due to disability, or reaching retirement age (65 as defined by the Plan) while employed.

1. **Description of Plan** (continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the prior year, or 50% of their vested account balance. Loan terms may not exceed 5 years, unless the loan is for the purchase of a primary residence, in which case the loan must be payable within a reasonable time commensurate with the repayment period permitted by commercial lenders for similar loans. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by plan the administrator. Interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Benefits, Distributions and Withdrawals

On termination of service due to disability, retirement, or reasons other than death, the participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account or annual installments over the participant's life expectancy. On termination of service due to death, the participant's beneficiary will receive either a lump-sum amount or annual installments over the period designated in the participant's written election. The non-vested portion will be forfeited, if the participant receives a distribution of their benefits when they are partially vested.

A participant may elect to receive an in-service distribution from his or her deferral contribution account without terminating employment upon attainment of age 59½. Amounts attributable to rollover contributions may be withdrawn at any time.

The Plan includes an "involuntary cash-out" provision. Any terminated participant will automatically have their balance rolled over to an individual retirement plan, also referred to as "Automatic Rollover." The provision applies to vested account balances over \$1,000 and less than \$5,000. Balances under \$1,000 are automatically distributed as a lump-sum payment. If another type of distribution or plan provider is desired, written specification must be provided to the plan administrator within a reasonable period of time after termination.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$14,439 and \$15,327, respectively. Forfeited amounts are to be allocated as described in the Plan document. During 2024 and 2023, \$27,036 and \$25,453, respectively, were applied to plan administrative expenses.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes Receivable from Participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The Plan follows the provisions of ASC 740-10, "Accounting for Uncertainty in Income Taxes". This addresses the determination of whether tax benefits claimed, or expected to be claimed, on a tax return should be recorded in the financial statements. The Plan Sponsor recognizes the tax benefit from an uncertain tax position when, based on technical merits, it is more likely than not the position will be sustained on examination by the taxing authorities. The Plan Sponsor recognizes accrued interest and penalties associated with uncertain tax positions as part of the provision for income taxes. The Plan is exempt from federal income taxes and is acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. It would be subject to federal excise taxes on prohibited transactions and unrelated business income, if any, as described by the IRC.

The Plan files Form 5500 and applicable schedules with the Department of Labor and the Internal Revenue Service. The Plan is subject to routine audits by those authorities; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to examinations for years prior to 2021.

Subsequent Events

The plan considers events or transactions that occur after the date of the Statement of Net Assets Available for Benefits, but before the financial statements are issued, to provide additional evidence relative to certain estimates or to identify matters that require additional disclosure. The Plan Administrator has evaluated subsequent events through October 2, 2025, the date these financial statements were available to be issued, and made any necessary adjustments and disclosures, as applicable.

3. Fair Value Measurements

The *Financial Instruments Topic* in the ASC 820 requires disclosures about fair value of financial instruments, clarifies the definition of fair value for financial reporting, establishes a framework for measuring fair value and requires additional disclosures about the use of fair value measurements. The categorization of financial instruments within the valuation hierarchy is based on the lowest level of input that is significant to the fair value measurement. The hierarchy is prioritized into three levels (with Level 3 being the lowest) defined as follows:

Level 1 - Quoted prices in active markets for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than prices included in Level 1, such as quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in markets that are not active; or other inputs that are observable or can be corroborated with observable market data.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities. This includes certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in Level 1, Level 2, and Level 3 and no changes in valuation techniques for these assets or liabilities for the year ended December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for plan assets at fair value:

Interest-Bearing Cash - Federal money market fund that invests in short-term money market instruments provides current income while maintaining liquidity and a stable share price of \$1. The fund generally invests 100% of its assets in U.S. government securities.

Common Stock - Common stock valued at the quoted market closing price reported on the active market on which the securities are traded on the last day of the Plan year.

Registered Investment Companies – Registered Investment Companies are made up of a variety of mutual funds whose value is based on quoted market prices determined in an active market.

Common Collective Trust (CCT) - A trust for the collective investment and reinvestment of assets contributed from employee benefit plans maintained by more than one plan. The value of a CCT is based on the underlying assets owned by the trust, less its liabilities.

5. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. **Income Tax Status**

The Plan received an IRS approval letter on June 30, 2020 for the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA document used by the Plan, is acceptable for use by employers for the benefit of their employees under the IRC Section 401. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. **Related Party Transactions**

Pension Benefit Consultants, Inc. provides compliance testing services for the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for these services were \$4,410 and \$4,250 for each of the years ended December 31, 2024 and 2023, respectively.

Fidelity Investments are trustees and custodians of the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Fidelity Management Trust Company for administrative and investment services were \$22,277 and \$35,757 for the years ended December 31, 2024 and 2023, respectively.

UBS Financial Services, Inc. provides consulting services for the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for consulting services were \$52,659 and \$50,125 for the years ended December 31, 2024 and 2023, respectively.

Notes receivable from participants are reported as a party-in-interest. Notes are issued, upon participant request, in compliance with ERISA requirements. Unpaid loan balances are \$208,157 and \$230,649 as of December 31, 2024 and 2023, respectively.
