Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Heritage Group Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared, and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note A - Plan Description

The following description of the Heritage Group Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Heritage Encon Group, Inc. and Subsidiaries Atlantech, Inc. and Unitherm (collectively the Company or Employer or Plan Sponsor) on December 20, 1943, which was most recently amended and restated effective February 4, 2021 to be in compliance with current rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by the Company, which serves without compensation. The Plan Administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The Company has outsourced the recordkeeping function of the Plan to Empower Trust Company, LLC (Empower), the Custodian.

Eligibility

All employees excluding collective bargaining (union) and non-resident alien employees of the Company who work 1,000 hours or more a year are eligible to participate in the Plan upon completion of one year of service and the attainment of 21 years of age. Participants must be employed by the Company on the last day of the Plan year to be eligible for any Employer contribution.

Contributions

Eligible hourly employees may elect to contribute up to 100% of their pre-tax compensation, as defined in the Plan, up to the maximum limits provided under the Internal Revenue Code (IRC). Employee contributions are recognized in the period in which they are deducted from the employees' pay. The Company matches 25% to 50% of the first 6% of eligible compensation contributed by participants to the Plan depending on years of service. The Employer match contribution was \$52,089 for the year ended December 31, 2024 and was paid subsequent to December 31, 2024.

For eligible salaried employees, the Company makes an annual profit sharing contribution to the Plan at the discretion of the Company's Board of Directors. The profit sharing contribution is allocated to participants in the same ratio as a participant's compensation bears to the total compensation of all participants. The Employer discretionary profit sharing contribution was \$345,743 for the year ended December 31, 2024 and was paid subsequent to December 31, 2024.

Contributions - continued

The total Employer contribution receivable was \$397,885 and \$386,658 as of December 31, 2024 and 2023, respectively. Contributions are subject to certain limitations. Participant contributions are not permitted for salaried employees under the provisions of the Plan document. The Plan does not allow for catch-up contributions.

Rollovers

Employees may rollover eligible amounts from other qualified plans.

Participant Accounts

Each participant's account is credited with the participants' contributions, the employer's contributions, and an allocation of Plan earnings and charged with benefits paid to participants and an allocation of Plan losses and administrative expenses. Each salaried participant who is employed by the Company as of the end of the Plan year and meets the eligibility requirements participates in the allocation of the Company's profit sharing contributions and of forfeitures of terminated participants' nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's respective vested account balance.

Investment Options

Participants direct the investment of contributions into various investment options offered by the Plan. As of December 31, 2024, the Plan offers mutual funds and a stable value fund as investment options for participants. Participants may change or transfer their investment options at any time via telephone or the internet.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100 percent vested after six years of service or upon death or attainment of their normal retirement date. Vesting percentages are based on the following schedule:

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$35,296 and \$2,547, respectively. During the year ended December 31, 2024, forfeitures used as additional profit sharing contributions amounted to \$4,087.

Notes Receivables from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan repayment terms are for a period up to 10 years. The loans are secured by the participant's vested account balance and bear interest at rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

Benefits Paid to Participants

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or installments as determined by the Plan. For termination of service for other reasons, participants may receive the value of the vested interest as a lump-sum distribution.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024 and 2023, no allowance for possible losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent note receivable from participant is recorded as a benefit paid to participant based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, custodian, and insurance company. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

All administrative expenses related to the administration and operation of the Plan are paid by the Company.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note C - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note D - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note E - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. The valuation methodologies have not changed from December 31, 2023 to December 31, 2024.

Mutual funds: These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Stable value fund: This investment uses NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The fair value of the stable value fund is stated at NAV as a practical expedient.

The preceding method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F - Stable Value Fund

The Plan invests in the Stable Return Signature Fund (the Fund), a collective investment trust which invests in investment contracts with Wells Fargo Bank, N.A. (the Bank). An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. The bank maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Fair value represents contributions made under the contract, plus accrued interest, less participant withdrawals. Net appreciation amounted to \$18,188 for the year ended December 31, 2024.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at NAV. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract generally does not permit the Bank to terminate the agreement prior to the scheduled maturity date.

Certain events limit the Plan's ability to transact at NAV with the Bank. Such events include, but are not limited to, the following: (a) material amendments to the Fund's structure or administration; (b) changes to the participating plans' competing investment options (including the elimination of equity wash provisions), (c) complete or partial termination of the Fund (including a merger with another fund); (d) the failure of the Fund to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; (e) the redemption of all or a portion of the interests in the Fund held by a participating plan at the direction of the participating plan sponsor (for example, the closing or sale of a subsidiary, employing unit, or affiliate); (f) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement, applicable to the Fund or participating plans; and (g) delivery of any communication to plan participants designed to influence a participant not to invest in the Fund. The Plan does not believe any events that would limit the Fund's ability to transact at NAV with Plan participants are probable of occurring.

Note G - Unaudited Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower (a qualified institution), has certified that the following data included in the accompanying financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024 is complete and accurate.

Note H - Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Empower and, therefore, these transactions qualify as party-in-interest transactions. However, these transactions are exempt from the prohibited transaction rules under ERISA. Administrative expenses paid to Empower amounted to \$2,250 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

Note I - Income Tax Status

The Company has adopted a non-standardized form for a prototype plan sponsored by the Custodian. The Internal Revenue Service (IRS) informed the prototype plan by a letter dated June 30, 2020, that the prototype plan and related trust constitutes a qualified plan and trust under the applicable sections of the IRC. These prototype plan has been amended since receiving the determination letter, However, the Plan Sponsor believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audit for any tax periods in progress.
