## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Baker, Donelson, Bearman, Caldwell & Berkowitz Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

## 1. Description of Plan

The following description of the Baker, Donelson, Bearman, Caldwell & Berkowitz Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all employees of Baker, Donelson, Bearman, Caldwell & Berkowitz, P.C. (the Company) who are age 21 or older and have completed one year of service as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective January 1, 2017, the Plan was amended such that all eligible employees that have become employees of the Company as the result of a merger are automatically enrolled unless an election not to enroll is made at least 30 days after they become eligible for the Plan. Prior service will be taken into account for all purposes of the Plan. The Plan was subsequently amended effective February 1, 2019 to provide for the full vesting of participants in their accounts, regardless of the vesting schedule, in the event of death or total and permanent disability, and to remove the minimum distribution requirements for hardship and in-service distributions.

### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. On May 1, 2023, the Plan was amended to automatically increase the automatic deferral rate by 1% up to a maximum of 10% on May 1 each subsequent year.

The Company provides, for all participants, an annual safe harbor nonelective contribution based on each participant's eligible compensation (approximately \$9,800,000 for 2024 and \$6,500,000 for 2023). The safe harbor contribution was 4% in 2024 and 3% in 2023. Participants also received a matching contribution of 100% of participant deferrals up to 2% of eligible compensation (approximately \$4,700,000 for 2024 and \$6,100,000 for 2023). Additionally, at its discretion, the Company may elect to provide a profit sharing contribution. In both 2024 and 2023, the Company elected to contribute for certain groups of participants, as described in the Plan, a profit sharing contribution of 4% of these participants' eligible compensation (approximately \$6,800,000 for 2024 and \$4,200,000 for 2023). Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and the Company's contributions, as well as allocations of the Plan's earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **Vesting**

Participants are immediately vested in their contributions, the nonelective safe harbor Company contributions and the Company matching contributions plus actual earnings thereon. Vesting in the Company's profit sharing contributions and actual earnings thereon are 0% vested until participants complete their third year of service as defined in the plan document, at which time their account becomes 100% vested.

At December 31, 2024 and 2023, forfeited nonvested accounts were not significant. These accounts are used to pay administrative expenses of the Plan or to reduce future Company contributions. During 2024, use of forfeited nonvested accounts were not significant.

## **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or greater for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined monthly by the plan administrator. At December 31, 2024 and 2023, outstanding notes bore interest at rates ranging from 3.50% to 10.50%. Principal and interest are paid ratably through payroll deductions.

## **Payment of Benefits**

On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account. A participant may also withdraw funds as of any distribution date after attaining age 59 ½. If a terminated participant's account balance is less than \$7,000, the plan sponsor can distribute the entire balance in a lump sum amount. In addition, the Plan provides for withdrawals from the participant's account in the case of certain hardships as defined in the plan document.

## **2. Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that were paid by the Company were \$278,295 for the year ended December 31, 2024 and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Outside advisory fees for self-directed brokerage accounts (SDBA) are incurred by the individual participant who elected to invest in an SDBA and are paid directly from that individual participant's SDBA. The total fees paid to SDBA advisors in 2024 were \$368,683. Other investment related expenses are included in net appreciation of fair value of investments.

## Subsequent Events

Subsequent events were evaluated through October 1, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Accordingly, these fair value measurements are classified as having used Level 1 inputs.

*Pooled separate accounts:* Valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

*Self-directed brokerage accounts:* Primarily consist of mutual funds, common stocks and cash and cash equivalents. Mutual funds and common stocks are valued on the basis of readily determinable market prices. Cash and cash equivalents include cash and money market funds. The fair values of these investments are based on market prices of the shares held by the Plan at year-end. Accordingly, these fair value measurements are classified as having used Level 1 inputs. Accounts also hold investments in government, municipal and corporate debt obligations which are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing the value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, those bonds are valued under a discounted cash flow approach that maximizes observable inputs, such as current yields or similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks. Accordingly, these fair value measurements are classified as having used Level 2 inputs.

## 4. Concentrations

As of December 31, 2024, two investments accounted for approximately 24% of net assets available for benefits. As of December 31, 2023, one investments accounted for approximately 14% of net assets available for benefits.

## 5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the Trustees of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

## 6. Related-Party and Party in Interest Transactions

Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

## **8. Tax Status**

The Plan has adopted a pre-approved plan offered by the Burleigh Consulting Group. The pre-approved plan received an opinion letter dated June 30, 2020, that the pre-approved plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.


