### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Roadie 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements related to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Roadie 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal

control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would reasonably be expected to influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Roadie 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting polices used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about Roadie 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters**

#### *Supplemental Schedules Required by ERISA*

The supplemental schedules H, line 4a--schedule of delinquent participant contributions--modified cash basis and H, line 4i--schedule of assets (held at end of year)--modified cash basis as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are

supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosures under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### ROADIE 401(k) PLAN

December 31, 2024

#### NOTE A--DESCRIPTION OF PLAN

The following description of the Roadie 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Roadie, Inc. (the "Company", "Plan Administrator" or "Employer"). Employees who have attained twenty-one years of age are eligible to participate in the Plan coinciding with or following six months of service. Certain types of employees, as defined by the Plan, are not eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: The Plan provides for employee elective pre-tax and/or after-tax contributions with an Employer discretionary matching and non-elective provisions. Plan participants may make contributions up to 90% of their annual pre-tax compensation, or 50% of their annual after-tax compensation, as defined by the Plan, not to exceed the Federal statutory maximum. For the year ended December 31, 2024, the Employer elected to match 50 percent of participant's elective deferrals, up to 6% of the participant's compensation, as defined by the Plan. In order to be eligible for the match, the participant must have been employed on the last day of the Plan year or worked 1,000 hours in the Plan year. No discretionary non-elective contribution was made for the year ended December 31, 2024. Due to compliance failures in previous years, the Company made qualified non-elective contributions to the plan of \$126,252 during the year ended December 31, 2024.

The Plan includes an automatic salary deferral feature. The Employer automatically withholds 3% of the employee's compensation as an employee elective pre-tax contribution, unless the participant elects otherwise.

Participant Accounts: Each participant's account is credited with their contributions, their account's earnings or losses, the Employer's matching or non-elective contributions, less an allocation of certain administrative expenses that are paid by the Plan. All investments are participant directed. Participants may change their investment options daily.

Investments: Participants can allocate their contributions and employer contributions among a selection of mutual fund accounts.

Vesting: Participants are immediately vested in all contributions and allocated earnings thereon.

## NOTES TO FINANCIAL STATEMENTS--Continued

### ROADIE 401(k) PLAN

#### NOTE A--DESCRIPTION OF PLAN--Continued

Forfeitures: Forfeited amounts can be used to pay administrative expenses of the Plan and to reduce future Employer contributions to the Plan.

Withdrawals: A participant may withdraw his participant elected and rollover contributions, plus earnings thereon, in the case of a financial hardship. Withdrawals are taxable in the year received by the participant and may be subject to a penalty tax. Additionally, after reaching the age of 59½, a participant may request an in-service distribution from vested accounts.

Payment of Benefits: Upon a participant's termination of employment with the Company, or after reaching the age of 65, the participant is entitled to receive a distribution of his vested account balance. The participant may elect to receive a distribution at any time in the form of a lump sum payment. If the participant dies prior to receiving his entire vested account balance, the balance will be paid to the participant's beneficiary.

Notes Receivable from Participants: Generally, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance. Additionally, the loan cannot exceed \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding amount of loan on the date the loan is made. Participants may only have one loan outstanding at any given time. Loans are repaid ratably through payroll deductions over periods of up to 60 months. The loans are secured by the vested balance in the participant's account and bear interest at the rate as reflected in the Wall Street Journal on the date of the loan plus 1% per year.

Administration: The Plan is administered by the Employer. All funds in the Plan are held by Matrix Trust Company ("the Custodian"). The Plan's Custodian invests participants' account balances, as directed by the participants.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance.

The financial statements for the Plan are prepared utilizing the modified cash basis method of accounting, which differs from generally accepted accounting principles, which uses the accrual method.

## NOTES TO FINANCIAL STATEMENTS--Continued

### ROADIE 401(k) PLAN

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

The Plan considers all highly liquid investments with an original maturity of three months or less to be cash equivalents.

The Plan's investments are stated at fair value, as further described in Note C. Investment securities, in general, are exposed to various risks, including credit, interest, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in values of investment securities will occur and that such changes could materially affect the amounts reported in the statements of net assets available for benefits--modified cash basis.

Purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Realized gains and losses on the sale of investments are calculated based on the difference between the selling price and cost on an average cost basis. Interest income and dividends are recorded on the modified cash basis when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as the change in unrealized gains/losses for securities held at the end of the year.

Contributions are recorded on the modified cash basis, which recognizes participants' contributions and the related Employer matching contributions at the time the contributions are received in cash by the Plan.

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no net assets available for benefits that were not paid.

The participants are responsible for the payment of all administrative expenses. However, the Employer may elect to pay portions of these expenses.

Loans to participants are reported separately from plan investments as notes receivable. These loans are recorded at their unpaid balance.

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS--Continued

### ROADIE 401(k) PLAN

#### NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the accounting guidance are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the quoted market price, which represents the net asset value of shares held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE D--TRANSACTIONS WITH PARTIES IN INTEREST

The Plan has an agreement with the Custodian to maintain the investments of the Plan. For the year ended December 31, 2024, contributions to the Plan of \$3,070,201 were deposited with the Custodian for investment, and participants of the Plan received distributions of \$758,955 from funds held by the Custodian. Additionally, for the year ended December 31, 2024, the Plan recorded \$23,222 in administrative expenses paid to the Custodian or affiliates of the Custodian and other service providers. At December 31, 2024 and 2023, the Plan had \$9,066,815 and \$5,874,464 respectively, of assets under the Custodian's custody.

NOTE E--TAX STATUS

The Plan is intended to satisfy the tax qualification requirements under Section 401(a) of the Internal Revenue Code; therefore, the trust funds of the Plan are intended to be exempt from Federal income taxes. The amended Plan has not requested a favorable determination letter from the Internal Revenue Service since the prototype on which the Plan is based has been determined to be qualified under Section 401(a) of the Internal Revenue Code.

NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

NOTE G--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the year ended December 31, 2024, there were no significant differences between the financial statements and Internal Revenue Service Form 5500.

NOTE H--SUMMARY OF INFORMATION CERTIFIED BY PLAN CUSTODIAN

The total current value of the Plan's net assets was \$9,107,431 and \$5,900,344 at December 31, 2024 and 2023, respectively. With the exception of notes receivable from participants, the Plan's Custodian has supplied the Plan Administrator with a certification as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits--modified cash basis as of December 31, 2024 and 2023, and in the statement of changes in net assets available for benefits--modified cash basis for the year ended December 31, 2024, with regard to investment activity.

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedules.
