## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the  
Ransom Everglades School  
Section 403(b) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Ransom Everglades School Section 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

## **Basis for Opinion**

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the Ransom Everglades School Section 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is a defined contribution 403(b) Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**General**

The Plan is comprised of a defined contribution (“DC”) retirement plan under which Ransom Everglades School, Inc. (“School”) may make contributions on behalf of the School’s eligible employees each year, and a voluntary tax deferred annuity (“TDA”) plan, under which eligible employees may elect to make an additional contribution. The Plan commenced on September 30, 1958, and has since been amended and restated to conform to certain IRS regulatory requirements. The purpose of the Plan is to provide retirement benefits for participating employees. Currently, benefits are provided through insurance and annuity contracts issued by Teachers Insurance and Annuity Association (“TIAA”).

**Eligibility Requirements**

All employees of the School are eligible to participate in the TDA other than student-teachers and employees who normally work fewer than 20 hours per week. In addition, administrative or staff employees whose regular schedule is for an average of at least 30 hours per week, or 1,560 hours per year, and faculty employees who are regularly scheduled to work at least 60% of a full time teaching equivalent, are eligible to participate in the DC portion of the Plan and receive employer contributions.

**Contributions**

Under the TDA portion of the Plan, contributions will be made in accordance with the salary-reduction agreement entered into with the School up to the maximum allowed by the Internal Revenue Code. Under the DC portion, employer contributions will be made on a percentage of compensation, according to age and years of service as of the contribution date, provided that eligible participants have contributed at least 5% of their compensation. Each participant self-directs their account by selecting from various fund options, including guaranteed investment contracts, a pooled separate account, and portfolios with a registered investment company. Contributions are subject to certain limitations set by law.

**Participant Accounts**

Accounts are maintained for each participant to track the value of the participant and employer contributions, as well as the interest and investment earnings, less any withdrawals and charges. Investment earnings are allocated based on beginning account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in theirs and the employer’s contributions, including rollover contributions from a qualified retirement plan, plus accumulated earnings thereon.

**Rollovers**

The Plan accepts rollover contributions from other tax-qualified plans for those participants who choose to invest in the Plan.

**Payment of Benefits**

Upon retirement, disability, or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in monthly or annual installments in accordance with the Plan's provisions. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participant's vested account as a cash withdrawal. Plan participants with vested account balances equal to or less than \$5,000 may receive a single sum payment of the account balance. Plan participants with vested account balances greater than \$5,000 may elect to receive a distribution of their account balance or in substantially equal payments over a period of 10 years. Participants may also elect to receive their distribution in the form of a direct rollover to a qualifying account.

In the event of a financial hardship, a participant may receive a lump-sum cash payment from the TDA Plan. Hardship distributions are permitted only when it is necessary to meet a heavy and immediate financial need. Employed participants that reach the age of 59½ may receive a cash withdrawal equal to their TDA balance.

**Administrative Expenses**

Investment, recordkeeping, and distribution fees incurred by TIAA are deducted directly from the investments.

**Plan Termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Investment Options**

Upon enrollment in the Plan, a participant may direct their contributions into various investments and investment contracts offered by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America. In September 2009, the Financial Accounting Standards Board ("FASB") implemented the Accounting Standards Codification ("ASC") which establishes FASB ASC as the source of authoritative U.S. accounting and reporting standards for nongovernmental entities. Presented below is a summary of significant accounting principles followed in the preparation of the accompanying financial statements.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments held by the Plan are required to be reported at fair value, except for investments in fully benefit-responsive investment contracts (“FBRIC”). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. FBRIC’s are reported at contract value because contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024 and 2023, all participants who had elected to withdraw from the Plan had been paid.

**Risk and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits and statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through September 5, 2025 the date the financial statements were available to be issued.

NOTE 3 – PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan’s investments are shares of mutual funds and investment contracts managed by TIAA, the Certifying Entity of the Plan; therefore, these transactions qualify as party-in-interest. All direct fees and expenses of the Plan relating to legal, accounting, and other administrative services are paid by the Employer. As of December 31, 2024 and 2023, fees totaling \$15,254 and \$17,204 were paid by the Plan for certain investment and management services and were deducted from the net asset values of the investments of the Plan.

NOTE 4 – INFORMATION CERTIFIED BY THE CERTIFYING ENTITY

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA, the Certifying Entity of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related net appreciation in value of investments, interest and dividend income reflected in the accompanying Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and 2023.

**NOTE 5 – TAX STATUS**

The effective date of the Plan is September 30, 1958. Although there have been amendments to the plan and changes in its design, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, the Plan continues to qualify under section 403(b) as of December 31, 2024 and 2023. Therefore, no provision for income taxes is included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would be sustained upon examination by the applicable taxing authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

**NOTE 6 – FAIR VALUE MEASUREMENTS**

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management’s own assumptions in determining the fair value of investments).

Registered Investment Companies –Valued at the daily closing price as reported by the fund.

Pooled Separate Account –Valued at the quoted net asset value (“NAV”) of shares held by the Plan at year-end.

General Account – Non-benefit responsive contracts valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

**NOTE 7 – GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

**Benefit Responsive Investment Contract**

The Plan has a benefit-responsive investment contract with TIAA. This insurance company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Based on its assumptions and analysis, TIAA has concluded that contract value approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is included in the financial statements at fair value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. At December 31, 2024 and 2023, the benefit responsive contracts totaled \$2,316,057 and \$2,210,947, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

**NOTE 7 – GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY (Continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance entity to terminate the agreement prior to the scheduled maturity date.

**Non-benefit Responsive Investment Contract**

The Plan entered into a non-benefit investment contract with TIAA. TIAA maintains the contributions in an unallocated general account to which it adds interest at annual rates. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract for a benefit event (termination, death, disability, or retirement). At December 31, 2024 and 2023, non-benefit responsive contracts totaled \$15,038,821 and \$14,502,603 respectively. These amounts are reported at fair value. See Note 6.
