#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Second Nature Brands Employee Savings Plan, f/k/a Kar Nut Products Co. Employees Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### 1. DESCRIPTION OF PLAN

The following description of the KNPC Holdco LLC d/b/a Second Nature Brands (“Company”) Employee Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### GENERAL

The Plan is a defined contribution plan covering all full-time employee of the Company who have been credited with 90 days of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan fiduciaries oversee the governance of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

#### CONTRIBUTIONS

Each year, participants may contribute pre-tax annual compensation or after – tax (Roth) compensation up to the maximum allowed by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective investment trusts as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employee are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Company contributes a safe harbor match of 100% of the first 3% of base compensation that a participant contributes to the Plan, plus 50% of contributions which are over 3%, but not over 5% of base compensation. Additional profit sharing amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain statutory limitations.

#### PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### 1. DESCRIPTION OF PLAN (continued)

##### VESTING

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting of discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service, with respect to discretionary contributions.

##### NOTES RECEIVABLE FROM PARTICIPANTS

Participant notes receivable are not permitted per the Plan document.

##### PAYMENT OF BENEFITS

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The plan also permits withdrawals of active participant's elective contributions and rollover contributions only in amounts necessary to satisfy financial hardship as defined by the plan agreement.

##### FORFEITED ACCOUNTS

Forfeited accounts are used to reduce employer contributions. There were no forfeitures for the years ended December 31, 2024 or 2023.

##### RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 2. SUMMARY OF ACCOUNTING POLICIES

### BASIS OF ACCOUNTING

The financial statements are presented on the accrual basis of accounting.

### USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s investment committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians, and investment company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net investment appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

### PAYMENT OF BENEFITS

Benefits are recorded when paid.

### EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in administration expenses.

### DATE OF MANAGEMENT'S REVIEW

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued. There were no subsequent events to disclose.

#### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Valued at the daily closing price as reported by the funds. Mutual and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

COLLECTIVE INVESTMENT TRUSTS

Valued at the NAV of the units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and collective investment trusts managed by Charles Schwab. Charles Schwab is the investment custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services amounted to \$9,013 and \$7,854 for the years ended December 31, 2024 and 2023, respectively.

Certain Plan investments are shares of mutual funds and collective investment trusts managed by CapTrust Financial Advisors. CapTrust Financial Advisors are the investment advisors for the Plan and, therefore, these transactions qualify as a party-in-interest. Fees paid by the Plan for investment advisory services amounted to \$41,824 and \$41,004 for the years ended December 31, 2024 and 2023, respectively.

Plan administration services are provided by the Sentinel Benefit Group of MI, Inc. and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for these services amounted to \$67,901 and \$46,157 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **7. TAX STATUS**

The Company has adopted a volume submitter plan that relies on the opinion letter of the volume submitter plan document. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **8. PROHIBITED TRANSACTIONS**

During 2024, the Company failed to remit participant contributions in a timely manner. The Company identified instances for a total of \$25,869 in 2024 in which participant contributions were remitted to the Plan in violation of Department of Labor (DOL) regulations. The Company remitted the principal amount of the contribution outside of the DOL Voluntary Fiduciary Correction Program (VFCP). The Company calculated lost earnings on delinquent participant contributions for 2024 which were remitted to the Plan in 2025.
