Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of John's Disposal Service, Inc. Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of John's Disposal Service, Inc. Savings & Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of John's Disposal Service, Inc. Savings & Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management

Note 1. Description of Plan

The following brief description of the John's Disposal Service, Inc. Savings & Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all employees of John's Disposal Service, Inc. and John's Recycling, Inc. (Company) who have twelve months of service, are age 19 or older and have worked at least one thousand hours during that twelve-month period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

The Company may make a discretionary matching contribution which is allocated to all eligible participants based on participants' elective deferrals. The Company will match 25% of a participants' elective deferrals (pre-tax and/or Roth), up to 1% of total eligible compensation, on a per-payroll basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may also make a discretionary contribution which is allocated to all eligible participants or a qualified non-elective contribution which is allocated to all non-highly compensated eligible participants.

c. Participant's Accounts

Each participant's account is credited with the participant's contribution, employer contribution (if any), Plan earnings, and Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately fully vested in their own contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of continuous service at a rate of 20% per year beginning in year two. A participant is 100% vested after six years of credited service, attainment of normal retirement age, death, or disability while an employee.

e. Notes Receivable from Participants

Participants may borrow from their fund accounts. Up to two loans are permitted at a time and are limited to 50% of a participant's vested account balance, provided such loans do not exceed \$50,000. The loans bear interest at the prime rate plus 1%. A maximum of a five-year payback is allowed for loans other than for the purchase of a primary residence (a maximum of twenty-five years is allowed for loans to purchase a principal residence). Principal and interest repayment occurs by payroll deduction.

f. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$1,813, respectively. Forfeitures may be used to reduce the employer contributions for the year, restore forfeitures, or pay reasonable Plan expenses per the Plan document. \$3,810 was used to pay administrative fees and reduce employer matching contributions during the year ended December 31, 2024.

g. Investment Options

Upon enrollment in the Plan, a participant is required to complete an investment designation stating the percentage of contributions made on behalf of the participant to the available investment options. Participants may change their election with respect to future contributions and current invested balances through completion of a subsequent investment designation form.

h. Payment of Benefits

On termination of service due to death, a participant's beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments.

For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution as soon as administratively feasible. For participant's whose vested interest in his or her account does not exceed \$1,000, the vested account balance will be distributed directly to the participant as soon as administratively feasible. For participant's whose vested interest in his or her account exceeds \$1,000 but not \$5,000, the vested account balance will be distributed as soon as administratively feasible. The participant will have the option to choose to receive the distributions directly or to roll over the distribution into an individual retirement account or the qualified plan of a new employer.

In-service withdrawals are allowed from a participant's deferral and roller contribution account, upon certification of disability, once a participant has reached normal retirement age, for active military service, and for hardship purposes. The minimum distribution amount allowed is \$1,000.

i. Plan Expenses

Administrative costs are shared between all of the Plan participants based on the ratio of the account balance to the total account balance of all participants. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Certain investment related indirect fees are included in the net appreciation of fair value of investments.

j. Changes to the Plan

Effective November 1, 2024, the Plan transitioned all assets and administrative services from John Hancock Life Insurance Company to Mutual of America Financial Group as third party administrator and Mid Atlantic Trust Company as custodian.

j. Changes to the Plan (Continued)

As part of the transition, the Plan adopted the Mutual of America Financial Group restated non-standardized defined contribution pre-approved Plan Document effective November 1, 2024. No significant changes were made to how the plan is administered.

Note 2. Summary of Significant Accounting Policies

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for Plan benefits and changes in those assets.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Significant estimates used in preparing these financial statements include those assumed in the valuing of investments at fair value. An estimate regarding a possible loss on these investments cannot be made due to the fluctuating nature of market conditions. It is at least reasonably possible that the estimates will change within the next year depending on market conditions.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

e. Payment of Benefits

Benefits are recorded when paid.

f. Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and other investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the trustee of the Plan prior to November 1, 2024 and Mid Atlantic Trust Company (custodian of the Plan subsequent to September 30, 2024).

During 2024, the Plan's investments, including gains and losses on investments bought and sold, as well as held during the year ended December 31, 2024, appreciated (depreciated) in value as follows:

Note 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 5. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended, the Plan's Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 6. Related-Party and Party-in-Interest Transactions

Certain Plan investments were shares of pooled separate accounts managed by John Hancock Retirement Plan Services, LLC and are mutual funds managed by Mutual of America Capital Management, which qualify as party-in-interest transactions. Certain investment related indirect fees are included in the net appreciation of fair value of investments. Transactions with the financial advisor, record keeper and plan auditor also qualify as party-in-interest transactions. Total fees paid to parties-in-interest during 2024 were \$49,274. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts and Collective Trust Funds – Reflected at Net Asset Value (NAV) as a practical expedient which is considered fair value. The NAV is equal to contract value of the underlying investment and is equal to the accumulated cash contributions and interest credited to the Plan's contracts and collective trust funds, less any withdrawals or transfers. The pooled separate accounts and collective

trust funds are not available for sale or transfer on any securities exchange. The contract value is a relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments utilizing NAV as a practical expedient are recognized outside the fair value hierarchy.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become immediately fully vested in their accounts.

Note 9. Bonding

ERISA Section 412 (a)(2)(D) requires the Plan to be bonded in the amount of 10% of Plan assets, up to \$500,000. Bond coverage at December 31, 2024 and 2023 was \$500,000 and \$500,000, respectively.

Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of John's Disposal Service, Inc. Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of Plan

The following brief description of the John's Disposal Service, Inc. Savings & Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all employees of John's Disposal Service, Inc. and John's Recycling, Inc. (Company) who have twelve months of service, are age 19 or older and have worked at least one thousand hours during that twelve-month period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

The Company may make a discretionary matching contribution which is allocated to all eligible participants based on participants' elective deferrals. The Company will match 25% of a participants' elective deferrals (pre-tax and/or Roth), up to 1% of total eligible compensation, on a per-payroll basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may also make a discretionary contribution which is allocated to all eligible participants or a qualified non-elective contribution which is allocated to all non-highly compensated eligible participants.

c. Participant's Accounts

Each participant's account is credited with the participant's contribution, employer contribution (if any), Plan earnings, and Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately fully vested in their own contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of continuous service at a rate of 20% per year beginning in year two. A participant is 100% vested after six years of credited service, attainment of normal retirement age, death, or disability while an employee.

e. Notes Receivable from Participants

Participants may borrow from their fund accounts. Up to two loans are permitted at a time and are limited to 50% of a participant's vested account balance, provided such loans do not exceed \$50,000. The loans bear interest at the prime rate plus 1%. A maximum of a five-year payback is allowed for loans other than for the purchase of a primary residence (a maximum of twenty-five years is allowed for loans to purchase a principal residence). Principal and interest repayment occurs by payroll deduction.

f. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$1,813, respectively. Forfeitures may be used to reduce the employer contributions for the year, restore forfeitures, or pay reasonable Plan expenses per the Plan document. \$3,810 was used to pay administrative fees and reduce employer matching contributions during the year ended December 31, 2024.

g. Investment Options

Upon enrollment in the Plan, a participant is required to complete an investment designation stating the percentage of contributions made on behalf of the participant to the available investment options. Participants may change their election with respect to future contributions and current invested balances through completion of a subsequent investment designation form.

h. Payment of Benefits

On termination of service due to death, a participant's beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments.

For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution as soon as administratively feasible. For participant's whose vested interest in his or her account does not exceed \$1,000, the vested account balance will be distributed directly to the participant as soon as administratively feasible. For participant's whose vested interest in his or her account exceeds \$1,000 but not \$5,000, the vested account balance will be distributed as soon as administratively feasible. The participant will have the option to choose to receive the distributions directly or to roll over the distribution into an individual retirement account or the qualified plan of a new employer.

In-service withdrawals are allowed from a participant's deferral and roller contribution account, upon certification of disability, once a participant has reached normal retirement age, for active military service, and for hardship purposes. The minimum distribution amount allowed is \$1,000.

i. Plan Expenses

Administrative costs are shared between all of the Plan participants based on the ratio of the account balance to the total account balance of all participants. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Certain investment related indirect fees are included in the net appreciation of fair value of investments.

j. Changes to the Plan

Effective November 1, 2024, the Plan transitioned all assets and administrative services from John Hancock Life Insurance Company to Mutual of America Financial Group as third party administrator and Mid Atlantic Trust Company as custodian.

j. Changes to the Plan (Continued)

As part of the transition, the Plan adopted the Mutual of America Financial Group restated non-standardized defined contribution pre-approved Plan Document effective November 1, 2024. No significant changes were made to how the plan is administered.

Note 2. Summary of Significant Accounting Policies

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for Plan benefits and changes in those assets.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Significant estimates used in preparing these financial statements include those assumed in the valuing of investments at fair value. An estimate regarding a possible loss on these investments cannot be made due to the fluctuating nature of market conditions. It is at least reasonably possible that the estimates will change within the next year depending on market conditions.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

e. Payment of Benefits

Benefits are recorded when paid.

f. Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and other investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the trustee of the Plan prior to November 1, 2024 and Mid Atlantic Trust Company (custodian of the Plan subsequent to September 30, 2024).

During 2024, the Plan's investments, including gains and losses on investments bought and sold, as well as held during the year ended December 31, 2024, appreciated (depreciated) in value as follows:

Note 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 5. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended, the Plan's Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 6. Related-Party and Party-in-Interest Transactions

Certain Plan investments were shares of pooled separate accounts managed by John Hancock Retirement Plan Services, LLC and are mutual funds managed by Mutual of America Capital Management, which qualify as party-in-interest transactions. Certain investment related indirect fees are included in the net appreciation of fair value of investments. Transactions with the financial advisor, record keeper and plan auditor also qualify as party-in-interest transactions. Total fees paid to parties-in-interest during 2024 were \$49,274. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts and Collective Trust Funds – Reflected at Net Asset Value (NAV) as a practical expedient which is considered fair value. The NAV is equal to contract value of the underlying investment and is equal to the accumulated cash contributions and interest credited to the Plan's contracts and collective trust funds, less any withdrawals or transfers. The pooled separate accounts and collective

trust funds are not available for sale or transfer on any securities exchange. The contract value is a relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments utilizing NAV as a practical expedient are recognized outside the fair value hierarchy.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become immediately fully vested in their accounts.

Note 9. Bonding

ERISA Section 412 (a)(2)(D) requires the Plan to be bonded in the amount of 10% of Plan assets, up to \$500,000. Bond coverage at December 31, 2024 and 2023 was \$500,000 and \$500,000, respectively.
