INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Plan Administrator
Beast Code 401(K) Plan & Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Beast Code 401(K) Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of Beast Code 401(K) Plan & Trust (the Plan) provides only general information. Participants should refer to the summary plan description of the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a voluntary defined contribution plan available to all employees of Beast Code, LLC (the Company or Plan Sponsor). All employees who are 18 years of age are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute any amount of pretax annual compensation, as well as any amount of posttax annual compensation, as defined in the Plan, not to exceed the maximum allowed under IRS Code 415(d). Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers), and those who have reached age 50 or more during the calendar year may make "catch-up" contributions to the Plan. The Company contributes to each participant a 401(k) safe harbor contribution of 100% on salary deferrals up to 6% of compensation. The Company may make additional non-elective discretionary matching contributions exceeding 6% of compensation. There were no non-elective contributions during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (1) the Company's contribution, if any, and (2) the Plan net earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options

Participants must direct their salary deferred contributions from several investment options offered through Nationwide Trust Company, as made available and determined by the Plan administrator. Those investment options consist of values of interest in registered investment companies and self-managed accounts. Value of interest in registered investment companies are units of participation that the plan has in the underlying assets of the mutual fund. The self-managed accounts have access to brokerage services provided by Charles Schwab & Co., Inc., allowing the participants to personally direct the investment contributions to various investment options. The securities available for investment in the self-managed account generally consist of stocks, cash, and cryptocurrency.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution or in monthly installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Funds may also be accessed prior to the date they become distributable by way of a financial hardship withdrawal. Hardship withdrawals are allowable in accordance with current Internal Revenue Service (IRS) guidelines.

Vesting

Participants are immediately vested in their contributions, safe harbor contributions made by the Company and earnings on those contributions. Vesting in the Company's discretionary non-elective contributions, however, is based on years of continuous service, as follows:

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value based on quoted market prices. The Plan presents in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments, which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation on investments held at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

The self-managed accounts are valued at market value as determined by Charles Schwab & Co., Inc. (Broker). Because of the inherent uncertainties in estimated market value, it is reasonably possible that the estimates used will change within the near term. The Plan presents in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments, which consists of the net change in market value of the self-directed brokerage investments during the year.

Contributions

Contributions from participants are recorded in the period in which the Company makes the deductions from the employees' payroll. All Company contributions, including discretionary and non-elective, are recorded in the period in which the Company submits the contributions to the Plan. Rollover contributions are recorded as Plan contributions during the period in which the funds are received by the Plan.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Benefits to participants are recorded when paid.

Administrative Expenses

The Company serves as the administrator for the Plan and has sole responsibility for the administration of the Plan. Those services are provided without charge to the Plan. Fees related to the administration of benefit payments are charged directly to the participants' accounts. Investment related expenses are calculated based on the net appreciation in fair value of investments as they are paid from the participants' accounts. Administrative expenses for 2024 totaled \$39,396. Other administrative expenses such as accounting and legal fees are paid by the Company rather than the participants.

Subsequent Events

The Company has evaluated events and transactions that occurred between December 31, 2024 and October 1, 2025, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

3. INFORMATION CERTIFIED BY TRUSTEE

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments as of December 31, 2024 and 2023, and net appreciation in fair value of investments and dividend and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Nationwide Trust Company, the trustee of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy to prioritize inputs with valuation techniques that measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Observable inputs such as quoted prices in active markets;

Level 2 – Inputs, other than quoted prices in active markets, that are observable either directly or indirectly; and

Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair

value of its investments. The following is a description of the valuation methodology used for assets measured at fair value:

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Self-directed brokerage accounts*: These accounts consist of investments comprised of cash, equities, and unit investment trusts. The equities are corporate common stocks valued at the closing price reported on the active market on which the individual securities are traded. The unit investment trusts are cryptocurrencies and are valued using the net asset value (NAV) per unit.

5. EXEMPT PARTIES-IN-INTEREST TRANSACTIONS

During 2024, certain Plan investments were shares of funds managed by Nationwide Trust Company. Nationwide is the trustee as defined by the Plan; therefore, these transactions qualify as parties-in-interest to the Plan. Fees were paid to Nationwide Trust Company by the Plan during the year ended December 31, 2024.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts in accordance with the terms and provisions of the Plan.

7. INCOME TAXES

The Plan has adopted a non-standardized pre-approved profit-sharing plan with cash or deferred arrangement. The IRS has determined and informed the Plan Sponsor by an advisory letter dated June 30, 2020, that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan has been amended since receiving the advisory letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Net assets available for benefits per the financial statements at December 31, 2024 agree with the amount of net assets available for benefits reported on Form 5500 for the applicable year.

10. PLAN RESTATEMENT

Effective January 1, 2024, the Plan was restated to comply with the latest IRS regulations and to incorporate amendments made since the last restatement. The restatement includes changes required by the IRS's Cycle 3 restatement period, which mandates updates to Plan documents approximately every six years.

The restatement was necessary to ensure the Plan's continued compliance with applicable laws and regulations, including the Pension Protection Act and subsequent IRS guidance. While the restatement did not result in any changes to the Plan's financial position as of December 31, 2023, it introduced updates to eligibility requirements, contribution limits, and distribution options that became effective for the Plan year beginning January 1, 2024.

The restated Plan document has been reviewed and approved by the IRS, ensuring that the Plan maintains its tax-favored status.
