Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Westmont Group Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1 - DESCRIPTION OF PLAN

The following description of Westmont Group Employees' 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) and profit-sharing plan that was established effective January 1998, covering all eligible employees, as defined by the Plan, who are employed by Westmont Industries, Advanced Ground Systems Engineering, LLC, Otto Systems, LP, and Hydraulic Cranes, LLC (collectively the "Company" or "Plan Sponsor") under Section 401(k) of the Internal Revenue Code (the "Code"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan covers substantially all employees of the Company who are 21 years of age or over and have been employed by the Company for at least three (3) consecutive months. Employees may enter the Plan monthly upon attaining eligibility. The entry date is the first day of the month following the date the employee meets the eligibility service requirements.

The Plan Sponsor appointed Ascensus Trust Company ("Ascensus") as the trustee ("Trustee") and Ascensus, LLC as its record keeper ("Record Keeper") of the Plan.

Participant Contributions

Each year, participants may elect to contribute a percentage of their compensation to the Plan; however, the total amount of the contribution generally may not exceed the Internal Revenue Service ("IRS") imposed limit of \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500, in addition to the IRS limit for the year ended December 31, 2024.

Employer Contributions

The Plan Sponsor may make a discretionary employer matching contribution to the Plan on behalf of the qualifying contributing participant, but only with respect to their elective deferral. In 2024, the employer matched 100% of the first 5% of the compensation a participant contributed to the Plan. For the year ended December 31, 2024, the Plan Sponsor made matching contributions of \$599,184 to the Plan.

Additional amounts may be contributed to the Plan at the discretion of the Plan Sponsor through profit-sharing contributions ("Profit Sharing Contributions"). For the year ended December 31, 2024, the Plan Sponsor did not make any Profit-Sharing Contributions to the Plan.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution, (b) an allocation of the employer's contributions, (c) Plan earnings, and (d) charged with an allocation of administrative expenses and any miscellaneous fees. Earnings or losses are allocated by funds based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become immediately vested in their rollover contributions, voluntary salary deferral contributions, plus actual earnings. Vesting in the Plan Sponsor's contributions and Profit-Sharing contributions are based on the participant's years of service and in accordance with the following vesting schedule:

Additionally, participants become 100% vested in the employer's contribution upon death or total and permanent disability of the participants.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their accounts and up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the past twelve months or 50% of their vested account balance, less any current outstanding loans. Loans are secured by the balance of the participant's account and bear interest at the prime rate on the borrowing date. The maximum loan term is five years unless the loan qualifies as a principal residence loan, in which case the loan term is not to exceed thirty years. Principal and interest are paid through payroll deductions. As of December 31, 2024, interest rates charged on outstanding loans ranged from 3.25% to 8.50% and the loans mature through March 2029.

Investment Options

Upon enrollment in the Plan, participants may direct employee and employer contributions to any of the investment options offered by the Plan. Participants may change their investment options daily and reallocate contributions among investment options at any time.

Benefits

Benefits can be drawn upon retirement, death, disability, or termination. The Plan provides for distributions at age 59½, while the participant is still currently employed. Benefits are paid to the participant or their beneficiary as a lump-sum payment equal to the participant's vested amount in their account. Terminated participants whose vested balance is \$1,000 or less will automatically receive an immediate lump-sum distribution equal to their vested account balance.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants will become fully vested in their Employer contributions in the event of Plan termination.

Forfeited Accounts

Forfeitures are the non-vested portion of participants' accounts which are lost upon termination of employment. Forfeitures are used to reduce future employer contributions to the Plan or may be used to pay any administrative expenses of the Plan. The forfeiture account balance totaled \$40,121 and \$40,355 as of December 31, 2024 and 2023, respectively. In 2024, approximately \$32,000 of forfeitures were applied to pay for the Plan's administrative expenses.

2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are reported at their fair values (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between the market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and losses are recognized when realized. Net appreciation or depreciation in fair value of investments consists of both realized gains or losses and unrealized appreciation or depreciation of those investments.

Cash Equivalents

The Company considers all highly liquid investments with original maturities of three months or less to be cash equivalents.

Benefits

Upon retirement, disability, death, or termination of service, a participant will receive either a partial withdrawal, lump sum, or a rollover of benefits equal to the value of the vested portion of his or her account. Distributions are subject to the applicable provisions of the Plan Agreement. The Plan allows for in-service withdrawals under certain conditions.

Administrative Expenses

Expenses incurred in administering the Plan are paid by the Plan and allocated proportionally to each participant's account balance, except those relating to processing fees for certain benefit payments that are assigned to the respective individual participant's account.

3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

4 - INVESTMENTS CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments reported on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023.

5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with particular investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

6 - TAX STATUS

The Company has adopted a non-standardized pre-approved plan document that received an opinion letter from the Internal Revenue Service, dated June 30, 2020, indicating that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (the IRC). Although the Plan has been amended, the Company and the Plan Administrator believe that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain positions that, more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, no uncertain positions were taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

7 - PARTY-IN-INTEREST TRANSACTIONS

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned.

The plan administrator and trustee are parties in interest. However, there were no transactions with the Trustee.

In addition, the Plan Sponsor, Westmont Industries, LLC, and Affiliates are parties-in-interest. However, there are no transactions with the Plan Sponsor other than the funding contributions to the Plan and payment of certain expenses.

8 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 24, 2025, the date when the financial statements were available to be issued.
