Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Bridgeview Eye Partners Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Bridgeview Eye Partners Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees, who are not covered under a collective bargaining agreement, of Bridgeview Eye Partners and subsidiaries (the “Company”) that have completed six months of service and attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: Participating employees may contribute up to 90% of their eligible compensation, as defined in the plan. The Plan automatically enrolls employees at a 5% deferral rate, upon becoming eligible, unless the employee declines. The automatic deferral rate increases 1% annually up to a maximum of 10% unless the participant elects otherwise. Additionally, participants who have attained age 50 prior to the end of the Plan year shall be eligible to make catch-up contributions. Participants may also contribute in the form of direct rollover amounts representing distributions from other qualified retirement plans. Company matching and profit sharing contributions are discretionary. Matching contributions are allocated based on the participant’s voluntary salary deferral contribution and Company profit sharing contributions are allocated based on the participant’s compensation, as defined by the Plan. The Company did not make discretionary match or profit sharing contributions for the plan year ended December 31, 2023. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's voluntary contributions and an allocation of (a) the Company's contribution and (b) Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their 401(k) and rollover contributions plus actual earnings thereon. Vesting in the remainder of their account plus earnings thereon is based on years of continuous service. A participant becomes 20% vested after two years of credited services and an additional 20% per year until 100% vested after six years of credited service.

Payment of Benefits: Upon termination of service, a participant has the option to remain in the Plan or receive an amount equal to the value of his or her vested account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants may request a distribution in the event of a financial hardship as defined by the plan. However, the amount of the hardship distribution cannot exceed the amount needed to meet the hardship. Active participants may also take distributions from the plan upon attainment of age 59½.

Forfeitures: The balance in forfeited non vested accounts at December 31, 2024 and 2023 was \$27,980 and \$24,522, respectively. These amounts will be used to reduce future employer contributions or to pay the Plan’s administrative expenses. During the year ended December 31, 2024, there were no forfeitures applied to participant accounts.

Notes Receivable from Participants: A participant may borrow up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. Loans range from one to five years and may be for a longer term if the loan is for the purchase of a primary residence. The interest rate is comparable with the current prevailing interest rate. Principal and interest are repayable through payroll deductions. All loans are covered by demand notes.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in fair value of investments reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company and Reliance Trust Company (the trustees of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the *assumptions* that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Money Market Deposit Account: Fair value is estimated to approximate the cost basis of the deposit account balance, based upon the liquidity of the account and the credit quality of the issuer. (Level 1 inputs).

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices in nationally recognized securities exchanges (Level 1 inputs).

Common Collective Trusts: The fair values of participation units held in the common collective trusts are based on the net asset values reported by the fund managers. The common collective trusts provide for daily redemptions by the Plan with no advance notice requirements, and have redemption prices that are determined by the funds net asset value per unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTIES IN INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor’s Rules and Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of mutual funds as well a collective trust fund issued by T. Rowe Price Trust Company; a trustee of the Plan. These investments as well as the investment management and plan administrative fees paid by the Plan to the recordkeeper and investment manager qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest investments.

NOTE 6 – INCOME TAX STATUS

The Internal Revenue Service has issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, the plan administrator believes the Plan is designed and is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits for any tax jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2021.
