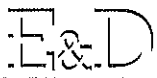

To the management of Vaso Corporation 401(k) Profit Sharing Plan & Trust:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Vaso Corporation 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION

Background - The Vaso Corporation 401(k) Profit Sharing Plan & Trust (the "Plan"), as amended, is a defined contribution plan as described in the Internal Revenue Code section 401(k) sponsored by Vaso Corporation (the "Company"). The Plan was adopted on January 1, 1999 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The custodian of the Plan is Principal Trust Company. Principal Life Insurance Company ("Principal Life") is the issuer of the pooled separate accounts and investment contracts held by the Plan. Associated Pension Consultants is the third-party administrator of the Plan. Wilshire Associates Incorporated provides investment advisory services to the Plan.

Plan Amendments - Effective May 1, 2023, the Plan was amended to permit discretionary employer matching contributions in addition to the 10 percent employer matching contributions provided for in the Plan. As described below, the Company elected to begin making discretionary employer matching contributions of an additional 10 percent effective May 15, 2023.

The Plan implemented certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act"), which was signed into law during December 2019. The SECURE Act raised the age for minimum distributions from 70 1/2 to 72 effective January 1, 2020. The SECURE 2.0 Act, which was signed into law during December 2022, raised the age for minimum distributions from 72 to 73 effective January 1, 2023.

During March 2020, the Plan implemented certain provisions of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"). For the year ended December 31, 2020, the CARES Act allowed certain eligible individuals to take coronavirus-related distributions, temporarily increased participant loan borrowing limits, allowed for the suspension of repayments on participant loans, and suspended required minimum distribution rules. Participants had the option of repaying distributions under the CARES Act within three years after the date the distribution was received; accordingly, such repayment period extended into 2023.

Written amendments to the Plan to reflect the operational changes in the SECURE, SECURE 2.0, and CARES Acts will be adopted in accordance with applicable law and IRS guidance.

1. PLAN DESCRIPTION (continued)

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

Eligibility - The Plan is available to all employees of the Company and affiliated entities which have adopted the Plan, excluding any employee who is included in a unit of employees covered by a collective bargaining agreement, provided retirement benefits were the subject of good faith bargaining and the collective bargaining agreement does not provide for participation in this Plan. Additional eligibility requirements are the attainment of age 21 and completion of two months of service. An eligible employee may elect participation in the Plan as of the first day of the month following the completion of eligibility requirements.

Affiliated entities which have adopted the Plan are Vasomedical Solutions, Inc., Vaso Diagnostics, Inc. d/b/a VasoHealthcare, VasoHealthcare IT Corp, and NetWolves Network Services, LLC.

Contributions and Vesting - Participants in the Plan may make elective deferral contributions in the form of pre-tax contributions or Roth contributions on an after tax basis, subject to section 401(k) maximum limitations (\$23,000 in 2024) from 1 percent to 80 percent of eligible compensation. Employees who attain age 50 are permitted to make catch-up contributions of up to \$7,500 in 2024.

An eligible employee may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as rollover contributions, with certain restrictions.

The Plan provides for employer matching contributions, calculated each pay period, equal to 10 percent of a participant's elective deferral contribution. During the year ended December 31, 2024, the Company elected to make additional discretionary employer matching contributions of 10 percent resulting in an aggregate employer matching contribution of 20 percent.

VASO CORPORATION 401(k) PROFIT SHARING PLAN & TRUST

1. PLAN DESCRIPTION (continued)

Participants are fully and immediately vested in their own contributions and earnings thereon. Participants vest in employer contributions and earnings thereon at the rate of 20 percent after one year of service, increasing by 20 percent each subsequent year of service until fully vested after five years of service. In addition, participants who are actively employed become fully vested upon attainment of the normal retirement age of 65, or in the event of disability as defined in the Plan, death, or the termination of the Plan.

Forfeitures - When participants terminate employment prior to full vesting, the nonvested amounts in their individual accounts, referred to as forfeitures, may be used to reduce future employer contributions or pay expenses of the Plan. For the year ended December 31, 2024, forfeitures in the amount of \$1,264 were used to pay administrative expenses. As of December 31, 2024 and 2023, unallocated forfeitures amounted to \$11,857 and \$1,088, respectively.

Distributions to Participants - Distributions to participants are available upon the following events: termination of employment, retirement, attainment of age 59 1/2, death, or disability. A participant's benefit, consisting of his/her entire account balance, is paid in the form of a lump sum payment. Payment shall be made as soon as administratively feasible following the date on which the event occurs, provided, however, that the participant's consent is obtained for distributions of amounts in excess of \$1,000. For terminated participants with account balances between \$1,000 and \$5,000, in the absence of a payment election by the participant, the plan administrator may elect to distribute their account balance to an individual retirement account set up in his or her name. A participant with an account balance in excess of \$5,000 may elect to defer payment until April 1 following the calendar year in which the participant attains age 73 or terminates employment, whichever is later.

The Plan also provides for hardship withdrawals to participants meeting certain requirements as described in the Plan agreement.

Upon enrollment in the Plan, participants are directed to designate a beneficiary or beneficiaries by completing a designation form. If a married participant designates someone other than their spouse as primary beneficiary, then the spouse must consent to this designation by signing the form and his/her signature must be witnessed by a Plan representative or a notary public. A participant's entire account balance is payable to the designated beneficiary upon his/her death.

1. PLAN DESCRIPTION (continued)

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, which is determined by the Plan administrator based on prevailing interest rates, remains fixed for the duration of the loan. The interest rate range was 5.25 percent to 10.5 percent per annum on loans outstanding during the year ended December 31, 2023. Principal and interest is paid ratably through payroll deductions over periods of 1 to 5 years, or up to 10 years for purposes of using loan proceeds in the purchase of a primary residence.

Administrative Expenses - A substantial portion of administrative expenses incurred in connection with the management of the Plan are paid by the Company. In accordance with Plan provisions, the Company may, at any time, elect to have some or all of such expenses paid by the Plan. Fees related to the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Net appreciation (depreciation) in fair value of investments is reported net of investment related expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The Plan's policy is to prepare financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America for defined contribution plans.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further information regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments include capital gains distributions and the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties - The Plan provides for various participant-directed investment options in securities including mutual funds, pooled separate accounts, and insurance company investment contracts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. As a result of the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.

Termination - The Company intends to continue the Plan indefinitely, but reserves the right to modify or discontinue it at its discretion, subject to applicable provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Subsequent Events - The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued (see Note 8).

3. INCOME TAX STATUS

In June 2020, the Internal Revenue Service stated in an opinion letter that the prototype plan adopted by the Plan administrator was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter, however, the Plan administrator and management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, they believe that the Plan was qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that would likely not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any open tax periods.

Investments in mutual funds - The participant-directed mutual funds offer various investment options ranging from conservative funds which principally seek to preserve capital and provide fixed income to aggressive funds invested principally in common stocks which seek growth of capital over the long term. The mutual funds also include T. Rowe Price Retirement Funds with varied target retirement dates. See Note 5 for a description of mutual funds stated at fair value.

Pooled separate accounts - The participant-directed pooled separate accounts offer various investment options including those investing primarily in fixed income investments and accounts whose underlying investments mirror stock index funds, other equity funds, or specialty funds. See Note 5 for a description of pooled separate accounts stated at fair value.

Principal Guaranteed Options - The Principal Fixed Income Guaranteed Option and Principal Guaranteed Option are fully benefit-responsive insurance contracts under group annuity contracts issued by Principal Life. The Plan's investments in such insurance contracts are maintained in Principal Life's general account. Under the group annuity contracts, the issuer is contractually obligated to repay the principal and interest (as defined) to the Plan.

During August 2023, the Company entered into a group annuity contract with Principal Life to offer the Principal Guaranteed Option in place of the Principal Fixed Income Guaranteed Option as a participant-directed investment, and to exercise its 12 month notice to liquidate the remaining balance in the Principal Fixed Income Guaranteed Option, with no surrender charge, during the third quarter of 2024.

For the Principal Fixed Income Guaranteed Option, the interest rate guaranteed to the Plan is reset on a semiannual basis. For the period from December 2023 to the date of liquidation, the net crediting rate was 0.90 percent per annum. For the Principal Guaranteed Option, a composite crediting rate is determined by Principal Life and reset on a semiannual basis. For the period from December 2023 to May 2024, the net crediting rate was 5.40 percent per annum. For the period June 2024 to November 2024 and November 2024 to May 2025, the net crediting rate was 5.15 percent and 4.85 percent per annum, respectively.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. For the Principal Guaranteed Option, the underlying group annuity contract contains multiple conditions in the event of plan level terminations of the contract, including notification periods, potential surrender charges, and requiring the Plan's interest in the contract be paid out in installments.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the issuer.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- * quoted prices for similar assets or liabilities in active markets;
- * quoted prices for identical or similar assets or liabilities in inactive markets;
- * inputs other than quoted prices that are observable for the asset or liability;
- * inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price (Level 1 inputs). The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - Investments in pooled separate accounts are valued at the daily closing NAV of units of the accounts as reported by Principal Life. Principal Life provides guidance to the Plan sponsor that the pooled separate accounts held by the Plan can be considered to have readily determinable fair values, based on the NAV of each account being determinable and published (the NAV is available to current investors and is the basis for current transactions). Based on these characteristics, pooled separate accounts were classified as having Level 1 inputs in the fair value hierarchy.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include pooled separate accounts, and the Principal Guaranteed Options are issued and managed by Principal Life, a member of Principal Financial Group, which also includes Principal Trust Company, the custodian of the Plan. Other service providers include Associated Pension Consultants and Wilshire Associates Incorporated. Transactions with the custodian, its affiliates, and other service providers qualify as party-in-interest transactions; however, they are exempt from prohibited transaction rules under ERISA. Administrative expenses in the accompanying statement of changes in net assets available for benefits consist of fees paid to Principal Trust Company and Principal Life in connection with recordkeeping and custodial services. Amounts paid as indirect compensation to the custodian and other service providers are treated as a reduction of the investment return on the Plan's investments.
