**(1) Plan Description**

The following description of Engage2Excel Inc. 401(k) Profit Sharing Plan ("Plan") is provided for general informational purposes only. Participants should refer to the Plan agreement for more complete information.

**(a) General**

The Plan is a defined contribution plan established by Engage2Excel, Inc. (the Company) on August 1, 1986. Employees become eligible to begin deferring a portion of their salary into the Plan after attaining age 18. Employees are required to complete six months of service to be eligible for the employer matching and employer profit sharing contributions. Six months of service is defined as the close of the first eligibility computation period during which an employee is credited with 500 hours of service or more. The Plan's Administrative Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**(b) Contributions**

Each year, participants may contribute an amount equal to a dollar amount or percentage of the contributing participant's compensation not to exceed the limits imposed by IRS Code Sections 401(k), 402(g), 4040 and 415. Participants may also make rollover contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company contributed 50% of the first 6% of base compensation that a participant contributed to the Plan. The Company can adjust this percentage annually. The Company may also contribute an additional profit-sharing contribution at the option of the Company's board of directors. Contributions are subject to certain limits. The Company made no discretionary profit sharing contribution for 2024 and 2023.

**(c) Participant Accounts**

Each participant's account is credited with the participant's contribution, and allocations of the Company's contribution and plan earnings (losses) on their individual accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(1) Plan Description, Continued**

**(d) Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions is based on years of service. For each year of service, participants vest 20%. After five years of service, participants are 100% vested in such contributions. If a participant dies or becomes disabled while still employed by the Company, his or her entire Plan interest becomes 100% vested.

**(e) Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum payment equal to the value of their vested interest in his or her account. In the event that participant terminates employment with the Company and the participant's vested account balance is less than \$5,000, the participant will automatically receive a lump-sum payment. A participant may request a withdrawal from his or her account balance based upon financial hardship as defined by the Internal Revenue Code. In the event such a withdrawal is made, the distribution is subject to a 10% excise tax if the participant has not attained age 59 ½. Also, upon making such a withdrawal, a participant is suspended from plan participation for a period of six months.

**(f) Forfeited Nonvested Accounts**

Unallocated forfeitures at December 31, 2024 and 2023, were \$127,365 and \$169,628 respectively. Non-vested forfeitures used to reduce administrative expenses for the years ended December 31, 2024 and 2023, were \$2,027 and \$9,000, respectively. Profit sharing forfeitures are allocated to qualifying participants' accounts based on the ratio that each qualifying participant's compensation for the plan year bears to total compensation of all qualifying participants for the plan year. Employer matching forfeitures are used to offset plan administrative expenses. The excess is allocated to the qualifying contributing participants' accounts based on the ratio that each qualifying contributing participant's compensation for the plan year bears to the total compensation of all qualifying contributing participants for the plan year.

**(g) Notes Receivable from Participants**

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate as received by the Trustee from Reuters plus one percent. Interest rates currently range from 4.25% - 9.50%. Principal and interest is paid ratably through monthly payroll deductions over a period not to exceed five years with a minimum period of six months. For loans used to acquire a principal residence, a repayment period of up to ten years may be selected.

**(h) Administrative Expenses**

Plan fees and expenses, including fees and expenses connected with the providing of administrative services by external service providers, are paid by the Plan.

**(i) Investment Options**

Upon enrollment in the Plan, a participant may direct contributions into several investment options as allowed by the Plan.

**(j) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' balances will be distributed in accordance with the Plan document.

**(2) Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**(a) Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**(c) Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**(d) Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and trust company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(e) Payment of Benefits**

Benefit claims are recorded as expenses when they have been approved for payment and paid by the plan.

**(f) Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company.

**(3) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

*Registered investment companies:* Valued at the daily closing prices as reported by the fund. These are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets (NAV) and to transact at that price. These investments are deemed to be actively traded.

**(4) Distributions Payable**

There were no amounts allocated to accounts of persons who had withdrawn from the Plan and were not paid as of December 31, 2024 and 2023.

**(5) Tax Status**

Effective January 1, 2000, the Plan adopted a non-standardized form of a prototype plan sponsored by Vanguard Fiduciary Trust Company. The prototype plan was amended and restated effective January 1, 2021. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(6) Related Party Transactions**

Plan assets include investments in funds managed by Vanguard Fiduciary Trust Company. Vanguard is the Plan's trustee. Any transactions with the trustee qualify as party-in-interest transactions under ERISA.

Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(7) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

**(8) Subsequent Events**

The Company has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued. There were no significant subsequent events identified which require disclosure.
