Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of the Esperion Therapeutics, Inc. 401(k) Plan (the Plan) provides only general information. Esperion Therapeutics, Inc. is the Plan Sponsor. Participants should refer to the Summary Plan Description and other plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), and was created to provide retirement benefits for employees of Esperion Therapeutics, Inc. (the Employer or Plan Sponsor).

Full-time employees aged 21 or older are generally eligible to participate in the Plan upon date of hire. Generally, part-time employees aged 21 or older who have completed 1,000 hours of service or more in the one-year period following commencement of employment, or during any calendar year commencing thereafter, are eligible to participate in the Plan.

Contributions

Each year participants may contribute any amount up to 100% of eligible annual compensation, subject to maximum amounts established by the Internal Revenue Code (the Code), pursuant to Section 401(k) of the Code. The Plan also allows participants age 50 or older the ability to contribute catch-up contributions as permitted by the Code. The Employer may make discretionary matching contributions to participants' accounts based on their pretax contributions. For the 2024 plan year, the Employer made matching contributions of 50% of the first 12% of compensation that a participant contributes to the Plan. In addition, cash or stock may be contributed at the discretion of the Employer in the form of a profit-sharing contribution. The Employer did not make a profit-sharing contribution for the year ended December 31, 2024. The plan also allows rollover contributions in accordance with the Code.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer matching and profit-sharing contributions plus actual earnings thereon is based on years of credited service, as defined in the Plan. A participant is 100% vested after three years of credited service.

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions and the Plan's earnings. Allocations are based on the participant's share of the net earnings or losses of their respective elected investment options. Forfeited balances of terminated participants' non-vested accounts are used to pay expenses of the Plan or to reduce the amount of the Employer's contributions. Reasonable administrative expenses not paid from forfeited balances may be deducted from the Plan's earnings. Total forfeitures held by the Plan at December 31, 2024 and 2023 amounted to \$5,741 and \$26,093, respectively, and forfeitures used to reduce the Employer's contributions for 2024 were \$355,133. These forfeitures may be first used in the future to pay Plan administrative expenses and to reduce future Employer contributions. The benefit to which a participant is entitled is the vested balance that can be provided from the participant's account.

Investment Options

Participants in the Plan are allowed to direct the investment of their respective account balances in various investment options. Participants are permitted to change their investment options at any time.

Participant Loans

Participants may borrow from their plan accounts a minimum of \$1,000 and a maximum amount of the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participants account during the prior 12-month period. All loans must be repaid in level payments on at least a quarterly basis over a 5-year period unless it is for the purchase of your principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan.

1. Description of the Plan (continued)

Payment of Benefits

In the event of retirement, termination of service, death, or disability the participant, or their beneficiary, may receive a lump-sum amount equal to the vested value of his or her account. Participants may also elect to receive installments of their vested account balances. Participants may obtain withdrawals of any portion of their participant contributions after attaining the age of 59 1/2 or for certain financial hardship situations. Such withdrawal will be authorized by the plan administrator (Esperion Therapeutics, Inc.) only upon satisfaction of criteria as enumerated in the plan agreement.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. In the event of plan termination or partial termination, the account of each affected participant shall be fully vested and shall be distributed to the participant.

Administrative Expenses

Administrative expenses are generally paid by the Employer. Certain management fees and other related expenses are paid by the Plan.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant account balance is reduced, and a benefit payment is recorded.

Related-Party and Parties-in-Interest

Parties-in-interest are generally defined under Department of Labor (DOL) Regulations as any fiduciary of the Plan, any party rendering service to the Plan, including the Employer. The Plan holds investments managed by the Trustee of the Plan. The transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

3. Investments

Certain investment information disclosed in the financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Trustee.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity). The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

Mutual funds: Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

5. Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the pre-approved plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Subsequent Events

Plan management evaluated subsequent events for the Plan through October 10, 2025, the date the financial statements were available to be issued.
