Our audit requires cooperative effort between management and the audit team. During our audit, we found significant difficulties in working effectively on the following matters:

Required Communications Regarding Internal Control (AU-C 265)

Consideration of Internal Control Over Financial Reporting

In planning and performing our audit of the financial statements of Vanguard Truck Holdings, LLC 401(k) Plan as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America (GAAS), we considered the Plan's internal control over financial reporting (internal control).

This consideration served as a basis for designing our audit procedures that are appropriate in the circumstance for the purpose of expressing our opinion on the financial statements.

However, this consideration was **not** for the purpose of expressing an opinion on the effectiveness of the Plan's internal control.

Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified.

Categorizing Deficiencies by Severity

Deficiency

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect and correct misstatements on a timely basis.



Significant Deficiency

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.



Material Weakness

A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that material misstatements of the Plan's financial statements will not be prevented or detected and corrected on a timely basis.



Identified Deficiencies

We identified certain deficiencies in internal control as follows:

Deficiencies

- **Non-Timely Contributions:** We noted one payroll that was delayed in submitting participant contributions to the Plan. The DOL requires that participant contributions be remitted to the Plan on the earliest date on which the withholdings can be reasonably segregated from the plan sponsor's general assets. Failure to remit participant contributions to the Plan in a timely manner results in a prohibited transaction which must be separately reported to the DOL and may result in penalties to the plan sponsor. We recommend that the plan sponsor review the procedures involved in remittance of participant contributions to the Plan and implement the necessary controls to ensure participant contributions are remitted timely. We further recommend you contact your Trustee to determine what additional corrective actions, if any, need to be taken.

- **Unallocated Forfeitures:** Unallocated plan forfeitures totaled \$161,481 and \$101,592 at December 31, 2024 and 2023, respectively. According to the Plan's provisions, forfeitures are to be applied to reduce the employer contributions or plan expenses. We recommend management review and, if appropriate, utilize these forfeitures as outlined in the plan document as soon as administratively feasible. In addition, we recommend a procedure be implemented requiring an annual evaluation of such forfeitures in accordance with the Plan.
- **Employee and Employer Contributions:** We noted one instance in which the deferral election selected by the participant was not accurately applied to several paychecks. The individual reached the maximum contribution limit; therefore, there were no missed employee contributions; however, this did result in missed employer contributions. We recommend management implement the necessary controls to ensure deferral elections are being properly applied to payroll. In addition, we recommend that the Entity contact your trustee or ERISA counsel to determine what corrective action needs to be taken as a result of the error noted.
- **Annual Compensation Limit:** We noted one instance in our testing in which employer deferrals were contributed over the annual compensation limit. We recommend plan management contact your trustee to determine what corrective action needs to be taken as a result of the error noted.
- **Meeting Minutes:** As the sponsor of the Plan, Vanguard Truck Holdings, LLC has the fiduciary responsibility to ensure the operation of the Plan is in accordance with the terms of the plan document, trust agreement, and government regulations. The appropriate officers and/or employees responsible for the administration of the Plan should meet periodically to evaluate the administration of the Plan and document these meetings. Documentation serves as evidence of oversight and compliance with the fiduciary requirement. We noted no formal minutes to meetings related to the Plan. We recommend minutes be taken to document when meetings are held, who is in attendance, and the items discussed during the meetings.

7. The Plan is qualified under the appropriate section of the Internal Revenue Code, and we intend to continue them as a qualified Plan and trust. We do not have any intention at present to terminate the Plan.
