INDEPENDENT AUDITOR'S REPORT

To the Trustees of the
Graphic Communications Conference of the
International Brotherhood of Teamsters, Locals 16-C
and 235-M and Employers Health and Welfare Fund

Opinion

We have audited the accompanying financial statements of Graphic Communications Conference of the International Brotherhood of Teamsters, Locals 16-C and 235-M and Employers Health and Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of Graphic Communications Conference of the International Brotherhood of Teamsters, Locals 16-C and 235-M and Employers Health and Welfare Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.





In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.



Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Graphic Communications Conference of the International Brotherhood of Teamsters, Locals 16-C and 235-M and Employers Health and Welfare Fund (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Fund's provisions.

General - The Plan provides health and other benefits to an employee, or dependent of an employee, pursuant to collective bargaining agreements, to members represented by the Graphic Communications Local Unions 16-C or 235-M, or both. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides health benefits (medical, hospital, surgical, major medical), dental (self-insured), vision, prescription drug, life insurance (employee only), accidental death and dismemberment (employee only), and short-term disability (employee only, self-insured) benefits to an employee on the first day of the calendar month following the month in which the employee completes one month of covered employment, or as otherwise provided by the collective bargaining agreement and as approved by the Board of Trustees (the Board). Retired employees and dependents are not entitled to medical, life insurance, accidental death and dismemberment, or short-term disability benefits. They may continue to participate in the vision and dental plans provided they were eligible in the month immediately preceding the month in which the retirement is effective, and the employee was eligible to receive a pension from an employer's qualified retirement plan or from a jointly trusteed multi-employer pension plan established for employees in the graphic communications industry, and on a timely basis elect retiree coverage on a self-pay basis.

The Plan does not provide for an accumulation of eligibility credits to extend coverage to participants. Coverage terminates when premium payments cease to be made on behalf of the participant.

Contributions are made by employers based on specific provisions of the collective bargaining agreement. The collective bargaining agreement provides for specific annual increases in the monthly contribution rate if determined necessary by the Trustees to maintain the current level of benefits. Employer contributions are made on behalf of each employee who works continuously as a regular full-time employee in accordance with the terms of the applicable collective bargaining agreement.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Retirees (and dependents) are responsible for their own monthly contribution for vision and dental coverage as determined by the Trustees. In general, retiree benefits are intended by the Trustees to be self-funded by retirees who choose to continue participation in the Plan without an interruption in coverage.

Postretirement Benefits - Qualifying retirees may elect on a timely basis at their initial eligibility to continue dental and vision benefits as an eligible participant on a self-pay basis. Upon the death of a qualifying retiree, the surviving spouse may elect to continue coverage under the Plan.

A retiree who refuses dental/vision coverage at the time of initial eligibility, or elects to terminate existing retiree coverage, shall not be allowed to reenroll at a later date. Continuing eligibility is contingent upon receipt of the required monthly premium payment as determined by the Board of Trustees, and such monthly premium is subject to change from time to time based upon claims experience.

The collective bargaining agreements to which the employers and the Union are parties require that each participating employer make monthly employee benefit plan contributions to the Fund on behalf of employees covered under such agreements. Contributions are due on the 15th day of the month following the month during which the covered employees worked or received wages under the collective bargaining agreements.

The Board administers and interprets the Plan and has the authority and discretion to take all actions and to make all decisions necessary and proper to carry out the Plan. The Board reserves the right to terminate, amend, or suspend the Plan for any reason; to alter or postpone the method of payment of any benefit; and to amend or rescind any other provisions of the Plan, without the consent of any employer or other person.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Investment Valuation and Income Recognition - Investments are carried at fair value. The fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recognized on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses - Administrative expenses are billed to and paid directly by the Plan.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3. TAX STATUS

The Plan has been declared an exempt organization by the Internal Revenue Code (IRC). The Plan has obtained a determination letter dated February 1, 1999, in which the Internal Revenue Service stated that the Plan, as then designed, qualifies under Section 501(a) of the Internal Revenue Code and is, therefore, exempt from federal income taxes under the provisions of Section 501(c)(9).

The Plan accounts for income taxes in accordance with the Accounting Standards Codification (ASC) Topic *Income Taxes*. These provisions provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribed a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Plan performed an evaluation of uncertain tax positions for the years ended December 31, 2024 and 2023, and determined that there were no matters that would require recognition in the financial statements or that may have an effect on its tax-exempt status. As of December 31, 2024, the statute of limitations for tax years 2021 through 2023 remains open with the U.S. federal jurisdiction and the various states and local jurisdictions in which the Plan files returns.

NOTE 4. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described on the next page:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Short-term investments: Valued at amortized cost, which approximates fair value.

Mutual funds: The fair value of the Plan's investments in mutual funds are valued using the quoted prices of identical investments on the active markets they are traded.



NOTE 5. PRIORITIES UNDER TERMINATION

Although it has not expressed any intention to do so, the Trustees have the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Trust or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan, a participating employer, and one of the Plan's sponsors, Kansas City Graphic Communications Union No. 16-C (the Union), shared the services of administrative assistants. The Union pays the employees' salary, payroll taxes and benefits for all hours worked on Plan and Union activities and is reimbursed by the Plan for that portion of hours directly related to Plan responsibilities. The Plan also pays certain administrative fees directly to service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8. CONCENTRATIONS

The Plan received approximately 86% of its contributions from a single employer.

NOTE 9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
