We have performed audits of the financial statements of The Allen & Company 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF PLAN

The following description of the The Allen & Company 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s information.

**General** —Effective January 1, 1995, Allen & Company Incorporated established the Allen & Company Incorporated 401(k) Savings Plan (Incorporated Plan) for eligible employees of Allen & Company Incorporated and its subsidiaries. Effective September 1, 2002, the Incorporated Plan was amended to include eligible employees of Allen & Company LLC (a registered broker-dealer) (the “Company” or “Plan Sponsor”), which was formed on September 1, 2002. At the date of formation of Allen & Company LLC, the Incorporated Plan was renamed the The Allen & Company 401(k) Savings Plan, and Allen & Company LLC was named the Plan Sponsor. J Bar 9 LLC, a related entity, became a Plan Sponsor on January 1, 2013; the Plan was amended as of the same date to reflect the additional Plan Sponsor. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024 the Plan was restated to add Safe Harbor non-elective contributions.

On June 30, 2024, the Company terminated its defined benefit pension plan. In accordance with applicable regulations, excess assets totaling \$13,764,969 were transferred to the Company’s defined contribution 401(k) Plan. The transfer was approved by the appropriate regulatory authorities and complies with ERISA and IRC Section 420 requirements. During year ended December 31, 2024 excess assets of \$6,148,523 were allocated to participants as contributions. At December 31, 2024 \$7,657,158 of excess assets remained to be allocated.

**Eligibility** — Newly hired eligible employees are enrolled immediately in the Plan with an automatic 6% contribution rate unless the employee affirmatively elects a different percentage or elects not to make an elective deferral contribution. An eligible employee is an employee who is hired with the intention of providing a minimum of 870 hours of service over a 12 month consecutive period beginning with their date of hire. Automatic contributions begin on the first pay period falling on or after the 30th day of employment. Employees hired with the expectation of working fewer than 15 hours per week or for a job expected to last fewer than 6 months become eligible upon completion of 500 hours in three consecutive calendar years beginning in 2021 or completes 500 hours in two consecutive calendar years beginning in 2023.

**Participant Contributions** — Participants may contribute up to 100% of gross wages on a before-tax basis or an after-tax basis, limited to a maximum amount in any calendar year, as adjusted annually pursuant to Section 402(g) of the Internal Revenue Code (IRC) (\$23,000 in 2024). Participants age 50 and above that have contributed the maximum contributions for that year may make a catch-up contribution, equal to \$7,500 in 2024. Contributions from participants are recorded in the period the related payroll deductions and transfers to the trustee are made.

In addition, the tax deferred contribution rate for participants who are eligible for the Plan on or after January 1, 2019 will automatically increase by 1% annually commencing January 1, 2020, up to 15% of eligible compensation, unless the participant elects against the increase as permitted under the Plan.

Participants may elect to change their level of contribution into the Plan at any time.

The participants' contributions and the Plan's net investment income or loss are allocated on the basis of participant elections among thirty-one mutual funds, all administered by the trustee. All investments are participant-directed.

**Employer Contributions** — Eligible participants who were hired or re-hired on or after January 1, 2009, will be eligible for employer contributions. The Plan Sponsor will contribute 4% of the participant's annual eligible compensation into his/her plan account beginning at the date of eligibility. The maximum annual compensation considered for this contribution is \$100,000. This contribution will be made regardless if the participants decide not to make any contributions of their own to the Plan.

In addition, the Plan Sponsor will match 100% of any contribution an eligible participant makes up to 2% of the participant's annual eligible compensation.

Additional amounts may be contributed at the Plan Sponsor's discretion. No such additional discretionary contributions were made for the year ended December 31, 2024.

**Participant Accounts** — Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, employer contributions (if eligible), and allocations of Plan earnings, and charged with withdrawals and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments** — Participants direct their contributions into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offers thirty mutual funds as investment options for participants.

**Vesting** — Participants are vested immediately in the Safe Harbor non-elective contributions as well as their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

Employer contributions vest as follows:

**Notes Receivable from Participants (Participant Loans)** — Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer from (to) the participant account to (from) the Notes Receivable from Participants account. Loan terms range from 1 to 5 years (10 years for primary residence loans). The loans are collateralized by the balance in the participant's account and bear interest at the prime rate at the time the loan is initiated. Principal and interest are paid ratably through bi-weekly payroll deductions. At December 31, 2024, participant loans have maturities through 2030 at interest rates ranging from 4.25% to 9.50%. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Effective January 1, 2019 participants who have terminated employment may elect to continue to make loan repayments on their outstanding loans.

**Payment of Benefits** — Distributions can be made upon retirement, death, disability, or termination of the employment in the form of a lump-sum, partial distribution, or rollover into another qualified plan.

Terminating participants whose account balances are less than \$5,000 may elect to receive either a lump sum distribution or rollover the balance into the T. Rowe Price Rollover IRA. Participants may continue to have their account maintained by the Plan if, upon termination, their vested account balance is greater than \$5,000.

Hardship withdrawals are available for active employees subject to certain limitations.

**Forfeited Accounts** — At December 31, 2024 and 2023, there were \$134,435 and \$47,280 of forfeited nonvested accounts, respectively. During the year ended December 31, 2024, employer contributions were reduced by \$60,158 from forfeited nonvested accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

**Use of Estimates** — The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions used.

**Administrative Expenses** — Substantially all administrative expenses are paid by the Company, as provided in the Plan document. The Plan Sponsor provides accounting and other administrative services to the Plan at no charge. Specific expenses incurred by a participant as a result of a special request, are paid directly by the participant.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Investment Valuation and Income Recognition** — The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Gains and losses on sale of securities are determined based on average cost. Dividend income is recorded on the ex-dividend date. Net depreciation includes the Plan's realized gain and losses on investments bought and sold as well as unrealized gains and losses on investments held during the year.

**Notes Receivable from Participants** — Notes receivable from participants are measured at unpaid principal plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

**Payment of Benefits** — Benefit payments are recorded when paid.

### 3. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, Plan management believes it is, at least, reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### 4. FAIR VALUE OF FINANCIAL INSTRUMENTS

Accounting Standards Codification, *Fair Value Measurements and Disclosures* (ASC) 820, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques** — Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. All of the Plan's investments in mutual funds are considered level 1 under ASC 820.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

### 5. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by

management and agreed to or derived from information certified as complete and accurate by T.Rowe Price Trust Company, Inc., a qualified institution.

### 6. PLAN TERMINATION

Although the Plan Sponsor expects to continue the Plan indefinitely, it has the right to amend or terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of Plan termination, each participant and beneficiary of each deceased participant shall have a fully vested and nonforfeitable interest in any values held in their account, as of the date of termination.

### 7. FEDERAL INCOME TAX STATUS

The Plan uses T. Rowe Price's pre-approved profit-sharing plan document. Accordingly, the Plan is permitted to rely on the opinion letter dated August 19, 2020, from the IRS which stated that the pre-approved profit-sharing plan was designed in accordance with the applicable regulations of the IRC. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain officers and employees of the Company who are participants in the Plan perform administrative services related to the operation, recordkeeping, and financial reporting of the Plan. The Company, at its option, pays these and other administrative expenses on behalf of the Plan. The Plan would pay such expenses if the Company discontinued its practice of paying them. No such officer or employee receives compensation from the Plan.

At December 31, 2024 and 2023, the Plan held \$87,513,502 and \$68,361,575, respectively, of mutual funds managed by T. Rowe Price. T. Rowe Price is the trustee as defined by the Plan and these transactions qualify as exempt party-in-interest transactions. For the year ended December 31, 2024, the mutual funds managed by T. Rowe Price held by the Plan recorded an investment gain of \$8,093,756. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Participant loan fees are paid to T. Rowe Price by participants.

These transactions qualify as related-party transactions and are permitted because they are covered by ERISA's exemptions from prohibited transactions.

### 9. SUBSEQUENT EVENTS

Management of the Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.
