- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) and supplemental schedule of delinquent participant contributions as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Comprehensive Logistics Co., LLC Employee Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Comprehensive Logistics Co., LLC. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

Employees are eligible to participate in the Plan upon completion of three months of service and attainment of 21 years of age. An employee may begin to participate after such requirements are satisfied.

Contributions

Participants may elect to make pre-tax contributions up to the maximum annual contribution allowed by the Internal Revenue Code ("IRC"). Participants may also make Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Eligible employees not electing to specify a contribution amount or deferral percentage to the Plan automatically contribute 3% of eligible compensation each pay period. The Plan also includes an auto increase provision whereby participants deferral rates are automatically increased by 1% a year up to a maximum deferral rate of 6% of compensation on July 1 of each Plan year. Participants can elect to adjust contributions subsequent to the automatic enrollment.

During 2024, the Company made matching contributions in an amount equal to 25% of the first 6% of the participant's eligible compensation contributed to the Plan, with the exception of participants who are a part of the Dearborn United Automobile Workers ("UAW") union and the York International Association of Machinist and Aerospace Workers ("IAM") and are eligible to participate in the Plan. The Company made matching contributions in an amount equal to 100% of the first 3% and 50% of the next 3% of the Dearborn UAW union participant's eligible compensation contributed to the Plan and 50% of the first 6% of the IAM union participant's eligible compensation contributed to the Plan.

The Company may also elect to make a discretionary profit-sharing contribution to the Plan. The profit-sharing contribution is allocated among eligible participants based on the participant's share of the total compensation of all eligible participants in the Plan. No profit-sharing contributions were made in 2024.

Participant Accounts

Each participant's account is credited or charged, as applicable, with the participant's contribution, rollover contributions, the Company's matching contribution and discretionary profit-sharing contribution, if any, and actual earnings and loss thereon. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investment Options

Participants' account balances are invested at the discretion of the participant in any of the investment options offered by the Plan. With certain restrictions, participants may change their investment options daily.

Forfeitures

The amounts forfeited by participants who terminate employment prior to becoming fully vested may be used to reduce subsequent Company contributions or pay administrative expenses. For the year ended December 31, 2024, Company contributions were reduced by \$174,547 from forfeited non vested accounts. As of December 31, 2024 and 2023, the amount of available unused forfeitures were \$26,034 and \$18,806, respectively.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary match and discretionary profit-sharing contribution portion of their accounts is based on the following table for Employees who did not complete one hour of service after July 10, 2019:

Payment of Benefits

Upon normal retirement at age 65, disability, death or termination of employment, a participant or beneficiary will receive the value of his or her account in equal monthly installments or a single lump-sum cash distribution for his or her vested account balance.

Withdrawals while an active employee of the Company, including financial hardship withdrawals, are also permitted in certain circumstances, without penalty, as defined in the Plan and in accordance with the IRC.

Notes Receivable from Participants

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their vested account. Loans may have a repayment term of up to five years, or longer if the loan is used to purchase a primary residence. No more than one loan per participant may be outstanding at any time. No loans less than \$1,000 will be made. The loans are secured by the balance in the participant's account and bear interest at the fixed rate of prime at the date of the loan plus 2%. Interest rates on participants' loans range from 4.25% to 10.50% at December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") as applied to defined contribution plans, and in accordance with the terms of the Plan document. A summary of the significant accounting policies applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported increases and decreases of Plan assets during the reporting period. Actual results could differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are held by Fidelity Management Trust Company as of December 31, 2024 and 2023, and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued, but unpaid interest. If a participant is delinquent on loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - A stable value fund valued at the NAV of units of the collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value.

Money Market Funds - Valued at NAV of \$1.00 per share held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with industry practices, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) Contributions to the funds may be made daily at the contract value and are considered made immediately after the daily valuation. Qualified Plan participants are allowed to withdrawal at any time without penalty, regardless of their frequency or amount. The Funds require participants to invest in a non-competing fund for at least 90 days before transferring to a competing fund option. Any Plan sponsor or Plan fiduciary initiated withdrawal from the Funds are not subject to a written notice of the intent to withdraw assets from the Funds.

NOTE D - STABLE VALUE AND MONEY MARKET FUNDS

The Plan's investments include an investment in the Putnam Stable Value Fund (the "Funds"), a collective trust fund that is considered to be a stable value fund that is a fully benefit-responsive investment contract. The Funds invest in high-quality guaranteed investment contracts ("GICs") and similar contracts issued by insurance companies, banks and other financial institutions. The Funds also invest up to 75% of its assets in security-backed investment contracts ("SBICs"), including separate account products of insurance companies. The Funds invest at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and, pursuant to liquidity and deposit agreements, stable value funds with investment policies and other provisions similar to those of the fund and may invest without limit in these investments. To earn additional income, the Funds (or another stable value fund in which it invests) may lend securities to other financial institutions on a collateralized basis. Any income will be net of fees. Securities lending is subject to certain risks. Unit price yield and return will vary.

The Plan's investments include an investment in the Fidelity Government Money Market Fund (the "Money Market Fund"), a collective trust fund that is considered to be a money market fund that is a fully benefit-responsive investment contract. This fund normally invests at least 99.5% of the fund's total assets in cash, U.S. Government securities and/or repurchase agreements that are collateralized fully (i.e., collateralized by cash or government securities). Certain issuers of U.S. Government securities are sponsored or chartered by Congress, but their securities are neither issued nor guaranteed by the U.S. Treasury. Investing in compliance with industry-standard regulatory requirements for money market funds for the quality, maturity, liquidity and diversification of investments. The fund stresses maintaining a stable \$1.00 share price, liquidity, and income.

NOTE E - FINANCIAL INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE F - FEDERAL INCOME TAXES

The Internal Revenue Service (“IRS”) has issued an opinion letter stating that the prototype plan adopted by the Plan, as then designed, qualified under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan’s investments include funds managed by the trustee; therefore, the transactions related to these funds qualify as party-in-interest transactions. Additionally, certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate or amend the Plan subject to the provisions of ERISA. In the event the Plan terminates, the accounts of the participants will be distributed at that time in the manner determined by the Plan administrator, in accordance with the terms of the Plan.

NOTE I - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued and has determined that there were no subsequent events that have occurred through the date of the report that would require recognition or disclosure in the financial statements.
