## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of the  
Falvey Linen Supply, Inc. 401(k) Retirement Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of the Falvey Linen Supply, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. Description of the Plan**

The following description of the Falvey Linen Supply, Inc. 401(k) Retirement Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant directed defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers substantially all employees of Falvey Linen Supply, Inc. (the Employer, Plan Sponsor or Company), as defined in the Plan Agreement. The Plan covers all full-time employees who, on the first day of the first month or the seventh month of the plan year, have attained age 18 and completed 90 days of service.

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Effective July 10, 2024, the Plan Administrator changed its trustee from Empower Annuity Insurance Company of America (Empower) to Lincoln Financial Group Trust Company, Inc. (Lincoln). As appointed trustee, Lincoln acts at the direction of the Plan Administrator. Effective July 10, 2024, the Plan assets transferred from Empower to Lincoln.

***Contributions***

Participants may elect to contribute up to 100% of their pre-tax and after-tax compensation, as defined in the Plan, subject to limitations by the IRC. Participants who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC. Rollover contributions representing distributions from other qualified defined contribution or defined benefit plans are permitted by the Plan.

The Employer may make discretionary non-elective contributions and Employer matching contributions to the Plan on behalf of participants. Under the Plan, each employee is a separate classification. To qualify for an allocation, participants must complete at least 1,000 hours of service during the applicable period and be employed by the Employer on the last day of that period, as defined in the Plan Agreement. The total amount of discretionary non-elective contributions and Employer matching contributions is determined by the Employer, in its sole discretion, and is determined separately for each employee classification, as defined in the Plan Agreement. No Employer matching contributions were made for the year ended December 31, 2024. The Company made discretionary non-elective contributions of \$1,552,101 for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Employer's discretionary non-elective contributions and Employer's matching contributions (if applicable), and their allocation of Plan earnings/losses and any expenses incurred. Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions, rollover contributions and any earnings thereon. Participants become vested in the Employer's discretionary non-elective contributions and Employer's matching contributions, including related earnings, as follows: 25% after 2 years, 50% after 3 years, 75% after 4 years, and 100% after 5 years. Participants are immediately vested in all accounts upon death, disability, or attainment of normal retirement age as defined in the Plan Agreement.

***Participant Notes Receivable***

The Plan does not permit participant loans.

***Payment of Benefits***

Benefits are available for distribution upon retirement, death or disability in a single lump-sum distribution or an annuity option. In the event of termination for any reason other than retirement, death or disability, payment of vested benefits will be made by the Plan Sponsor in accordance with the procedures described in the Plan. Participants who have attained age 59½ may elect to withdraw all or a portion of their vested account while still employed. If a participant's vested balance is less than \$1,000, the participant will receive an immediate cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 but is less than \$5,000, the amount will be rolled over to an individual retirement plan designated by the Plan Sponsor. The Plan also provides for mandatory distributions to participants upon reaching the Required Minimum Distribution age, as defined in the Plan Agreement.

Hardship withdrawals from the Plan are also permitted subject to the applicable Internal Revenue Service (IRS) laws and cannot exceed the amount required to meet the immediate financial need created by the hardship. Withdrawals are subject to a \$500 minimum.

***Forfeitures***

Forfeitures of non-vested Employer discretionary non-elective contributions and Employer matching contributions may be used to pay administrative expenses and reduce Employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,146 and \$30,025, respectively. During 2024, approximately \$38,000 of forfeitures were used to offset Employer contributions. There were no forfeitures used to pay administrative expenses.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value, except for the group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

Contract value represents investments at cost plus accrued interest income, less amounts withdrawn to pay benefits and expenses. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and the insurance company (Notes 3 and 4).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Fully Benefit-responsive Investment Contract***

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

During the years ended December 31, 2024 and 2023, the Plan had investments in the Empower General Account and the Lincoln Stable Value Account, which are group annuity contracts issued and backed by the general accounts of Massachusetts Mutual Life Insurance Company and the Lincoln National Life Insurance Company, respectively, which meet this requirement.

The Plan's investment in these funds, which represents contributions and reinvested interest income, less withdrawals and expenses, plus or minus net participant-directed transfer activity with the Plan's other investment funds are recorded at contract value.

***Participant Notes Receivable***

Participant notes receivable are not permitted by the Plan.

***Contributions***

Participant contributions are recorded weekly or biweekly when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary non-elective contributions and Employer matching contributions are made at year-end, if applicable.

The Employer's discretionary non-elective contribution receivable in the amount of \$850,167 was remitted subsequent to year-end.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Revenue and Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Administrative revenue arises when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. The Plan held unallocated administrative revenues of \$0 and \$15 at December 31, 2024 and 2023, respectively.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in six mutual funds that accounted for approximately 83% of total Plan investments as of December 31, 2024. The Plan invested in three mutual funds that accounted for approximately 40% of total Plan investments as of December 31, 2023.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

Management has evaluated subsequent events through October 8, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1, within the fair value hierarchy.

**4. Fully Benefit-responsive Investment Contracts**

For the period of January 1, 2023 through July 9, 2024, the Plan had an investment in the Empower General Account, a group annuity contract, which was a traditional fully benefit-responsive investment contract. Contributions to this investment were backed by Massachusetts Mutual Life Insurance Company.

The account was credited with participant contributions, plus earnings and charged for participant withdrawals and administrative expenses. Empower was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate for the period of January 1, 2024 through July 9, 2024 and for the year ended December 31, 2023 was 0.64% and 1.00%, respectively. The crediting interest rate was reviewed on a semi-annual basis for resetting. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate for the Empower General Account. During 2024 and upon the Plan's change in trustees, the Plan liquidated the investments held in the Empower General Account and the assets were transferred to Lincoln.

Effective July 10, 2024, the Plan has an investment in the Lincoln Stable Value Account with a guaranteed rate of return and a guarantee of principal that is backed by the general account of Lincoln National Life Insurance Company.

The Plan's investment in the Lincoln Stable Value Account, a traditional group fixed annuity contract, is a fully benefit-responsive investment contract. This fully benefit-responsive guaranteed investment contract provides preservation of principal, maintains a stable interest rate, and provides daily liquidity at contract value for participant withdrawals and transfers in accordance with the provisions of the Plan. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Lincoln group annuity contracts for stable value assets have a crediting rate declared quarterly and are backed by the general account. The minimum crediting interest rate under the contract was 1.00% for the period July 10, 2024 through December 31, 2024. Some restrictions apply to the free transferability from the group fixed annuity contract to other investment options and withdrawals for reasons driven by the contract owner.

The guarantees of values provided for investments made with Lincoln under the Plan's contract are based on the financial strength and claims-paying ability of Lincoln. As described in Note 2, because the group fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for the benefits attributable to the group annuity contract.

**5. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants. Any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**6. Income Tax Status**

The Plan is an adoption of a non-standardized pre-approved defined contribution plan that received an opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Employer and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**7. Summary of Financial Data Certified by the Trustees**

The following is a summary of financial information and data certified by the trustees, Lincoln for the period July 10, 2024 to December 31, 2024, and Empower for the period January 1, 2023 to July 9, 2024:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 (Lincoln) and 2023 (Empower), except for contribution receivables, if any;  
Investment income on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided in the supplemental schedule, Schedule of Assets (Held at Year End) at December 31, 2024 (Lincoln).

**8. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**9. Related Party Transactions and Party-in-Interest Transactions**

Empower was the recordkeeper and trustee of the Plan through July 9, 2024. Effective July 10, 2024, Lincoln was appointed the recordkeeper and trustee of the Plan. Fees paid for third party administrative fees are paid directly to Angell Pension Group, Inc. (Angell). Therefore, these transactions qualify as party-in-interest transactions. The Plan receives revenue credits, as discussed in Note 2. Amounts credited to the revenue credit account plus earned interest are used to pay third-party administrative expenses or allocated to participant accounts. During 2024, approximately \$6,400 was credited to the administrative revenue account and used to offset third-party administrative expenses. The Plan made direct payments of approximately \$17,500 to Empower, approximately \$15,000 to Lincoln and approximately \$900 to Angell, respectively, for the year ended December 31, 2024.
