We have performed audits of the financial statements of 401(k) Savings Plan for Employees of 1199SEIU United Healthcare Workers East (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Note 1. Description of Plan

The following description of the 401(k) Savings Plan for Employees of 1199SEIU United Healthcare Workers East (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** Effective July 1, 2000, 1199SEIU United Healthcare Workers East (the Company or Sponsor) established the Plan for eligible employees of the Company and related participating employers of the controlled group. The Plan may be amended from time to time. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Newly hired employees are eligible for enrollment in the Plan upon completing six months of service with respect to elective contributions, except for leased employees. Eligible participants may enter the plan on the first day of the plan year quarter coinciding with or next following the date requirement is met.

**Participant contributions:** Participants may contribute any portion of their gross eligible compensation (as defined in the Plan) on a before-tax basis, limited to a maximum amount in any calendar year, as adjusted annually pursuant to Section 402(g) of the Internal Revenue Code (IRC) (\$23,000 in 2024). Participants age 50 and above that have contributed the maximum contributions for that year may make a catch-up contribution (\$7,500 in 2024).

**Participant rollover contributions:** Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**Participant accounts:** Each participant's account is credited and debited with the participant's contributions and withdrawals, as applicable, and an allocation of the Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

**Participant investment options:** Participants direct contributions into various investment options offered by the Plan. Participants may change their investment options at any time throughout the year. If a participant fails to make an investment direction, contributions shall be deposited to the Vanguard Target Retirement Fund that most closely approximates the year in which participant will be 65 years of age.

**Vesting:** Participants vest immediately in their elective and rollover contributions plus actual earnings thereon.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years unless the loan is for the purchase of the participant's principal residence, in which case it can be longer. The loans are collateralized by the balance in the participant's account and bear interest at the prime rate (at the time the loan is initiated) plus 1%. The loans provide for quarterly payments under a level amortization through payroll deductions or an ACH agreement. A participant may have no more than four outstanding loans at any time.

**Payment of benefits:** A participant's vested interest in the Plan's assets is distributable upon retirement, death, disability, separation from service or attainment of age 59½, as provided for in the Plan.

#### Note 2. Summary of Accounting Policies

The following are the significant accounting policies followed by the Plan:

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates and assumptions used.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For further discussion about the fair value of the Plan's investments, see Note 4, Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Gains or losses on investments bought or sold as well as held during the year are included in net appreciation (depreciation) in fair value of investments and in the statement of changes in net assets available for benefits.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. Rebates received on investments are included in net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits. These rebates are generally used to pay administrative expenses.

**Contributions:** Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit payments:** Benefits to the participants are recorded when paid.

**Administrative expenses:** Administrative expenses are paid by the Plan or by the Company, as provided in the Plan document.

**Subsequent events:** The Plan evaluates events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was October 6, 2024, for these financial statements.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds (registered investment companies):** Fair values are based on unadjusted quoted prices based on net asset value (NAV) reported by the issuer. There are no restrictions on redemption for any of the funds.

**Collective investment trust:** Valued based on the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of Plan termination or partial termination, each participant and the beneficiaries of each deceased participant shall have a fully vested and nonforfeitable interest in any values held in his or her account as of the date of termination.

#### Note 6. Risk and Uncertainties

The Plan provides for various investment options in any combination of mutual funds and other investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### Note 7. Related-Party and Party-in-Interest Transactions

Certain officers and employees of the Company who are participants in the Plan perform administrative services related to the operation, record keeping and financial reporting of the Plan. The Company, at its option, pays these and other administrative expenses on behalf of the Plan. The Plan would pay such expenses if the Company discontinued its practice of paying them. No such officer or employee receives compensation from the Plan. Fees paid by the Plan for investment management services are included as a reduction of the return on each fund.

The Trustee, Newport Trust Company, LLC, is a party-in-interest as defined by ERISA. Transactions with this party were considered exempt party-in-interest transactions under ERISA.

#### **Note 8. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan documents; however, The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.
