Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Forestdale, Inc. 1. Description of Plan

Effective August 1, 2008, Forestdale, Inc. (the "Employer") merged the Forestdale, Inc. Money Purchase Plan Trust into the Forestdale, Inc. Cash or Deferred Plan & Trust (the "Plan"). The following brief description and summary of major Plan provisions provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a 401(k) type of defined contribution plan. All eligible full-time employees of the Employer who are at least 21 years of age with at least twelve months of service and who meet certain other requirements are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year participants may elect to have a percentage or dollar amount deducted on a pre-tax or Roth basis from their compensation, as defined by the Plan document. Participants may elect to increase, decrease or suspend their contributions according to procedures established by the Employer. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a rate of 3% unless they affirmatively opt out. Participants who have attained age 50 before the Plan year-end are eligible to make catch-up contributions up to the statutorily permitted amounts. There is an annual dollar limit as to the amount that can be contributed on a pre-tax or Roth basis into the Plan which is determined by the Internal Revenue Service ("IRS").

At the Employer's sole discretion, the Employer may make matching contributions on behalf of each participant in any specific percentage of the participants' elective deferrals. Participants who have completed less than 12 months of service, are not eligible for the matching contribution. In addition to the matching contribution, the Employer may make a discretionary contribution. The Employer discretionary contribution for each eligible participant is based on a share of how much compensation he or she received during the year and the compensation received by all other eligible participants' who have completed at least 12 months of service.

Participant Accounts

Each participant's account is credited with the Employer and participant contributions and the investment earnings thereon. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant accounts transactions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

Vesting

A participant is fully vested in their own contributions at all times. Furthermore, the account value of contributions is fully vested when a participant reaches age 65 or if a participant becomes disabled or is deceased, or if the Plan terminates.

Vesting (continued)

Participants' interest in the Employer matching contribution account and Employer discretionary contribution account will vest based on their years of vesting service, which is obtained after completing 1,000 hours of credited service each year, in accordance with the following schedule:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
Less than Two Years	0%
Two Years but less than Three Years	25%
Three Years but less than Four Years	50%
Four Years but less than Five Years	75%
Five Years or More	100%

Forfeitures

In the event that a participant terminates before becoming fully vested in his or her account balance, the non-vested portion of the participants' account balances will be forfeited as of the termination date. Forfeitures of terminated non-vested accounts will be used to reduce future Employer contributions made to the Plan or used to pay any administrative expenses of the Plan. At December 31, 2024 and 2023, unapplied forfeitures totaled \$47,022 and \$42,373. During 2024, Employer contributions were reduced by \$154,011 and no amounts were used to reduce administrative expenses from forfeited non-vested accounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participants' accounts and bear interest equal to 1% above the prime rate at the time of the approval of the loan. Loans are repaid through payroll deductions over a period of up to five years unless the loan was made to acquire a residence, in which case, the loan can be repaid over a period greater than five years, however such loan must be approved by the Plan administrator.

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared on the modified cash basis, which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”). Under this basis, investment income and contributions are recognized when received and expenses are recognized when paid, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP. Management has determined that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

Use of Estimates

Management makes certain estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivables from participants are measured at their unpaid principal balance.

Fair Value of Financial Instruments

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

Investments in mutual funds and the money market fund are valued at the net asset value of shares held by the Plan at year end as determined by quoted market prices. Purchases and sales of investments are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Other Income – Revenue Sharing

During 2024, the Plan received shareholder servicing fees of \$46,799 which may be used to offset eligible Plan expenses or to allocate to participants.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses for maintaining the Plan are paid by the Employer and are excluded from these financial statements. Administrative fees for transaction charges are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 9, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

4. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

5. Tax Status

The Plan adopted a standardized prototype plan which received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401(a) of the Internal Revenue Code (the "Code"), and that any employer adopting this prototype plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is being operated in compliance with the applicable sections of the Code.

5. Tax Status (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

The money market investment is managed by Charles Schwab Trust Bank, the custodian of the Plan, as defined by the Plan document. Accordingly, these transactions are considered exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA and are reflected in the statements of net assets available for benefits as notes receivable from participants.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

7. Prohibited Transactions

During the 2023 Plan year, the Employer failed to remit to the Plan certain participants' contributions within the period described by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer has calculated and remitted lost earnings of \$5 in November 2024 for the delinquent participant contributions of \$2,184.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
