## Independent Auditor's Report

To the Participants and Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of the Texas Organ Sharing Alliance 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

### ***Opinion***

### Notes to the Financial Statements December 31, 2024 and 2023

---

#### **Note 1 – Plan Description**

The following description of the Texas Organ Sharing Alliance 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and the Plan Document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Texas Organ Sharing Alliance (the “Company”) from the first date of service. The Plan commenced effective January 1, 1977, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”). The Plan was amended and restated effective August 15, 2024, to comply with the latest rules and regulations.

#### ***Plan Custodians and Trustee***

The Plan’s assets are held by Principal Life Insurance Company (“Principal”), Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Trustee”), and Principal Global Investors Trust Company (collectively, the “Custodians”). Among other duties, the Custodians receive contributions, hold and invest fund assets in accordance with the directions of participants, and make disbursements as directed by the Company. An affiliate of the Trustee provides recordkeeping services for the Plan.

#### ***Eligibility and Plan Entrance Date***

Certain employees are not eligible to participate in the Plan, including leased, independent contractors, part-time, temporary, and seasonal employees who are regularly scheduled to work less than 1,000 hours of service. All other employees of the Company become eligible to participate in the Plan upon reaching the age of 21 and completing six months of service. Eligible employees may enter the Plan on the first day of the first and seventh months of the Plan year after satisfying the eligibility requirements.

#### ***Participant Contributions***

Participants may elect to contribute, on a before-tax or Roth basis, up to 100% of their eligible compensation, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

#### ***Employer Contributions***

The Plan provides for the following Employer contributions:

- a) A discretionary matching contribution of 100% of the first 5% of eligible compensation contributed by the participant. Discretionary matching contributions totaled \$447,534 for 2024.
- b) A nonelective discretionary contribution of 5% of eligible compensation for all participants. Nonelective discretionary contributions totaled \$630,696 for 2024.

Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

### Note 1 – Plan Description (continued)

#### *Participant Accounts*

Each participant account is credited with the participant's contributions, Employer matching contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Participant-Directed Investments*

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The options vary in types of investments, rates of return, and investment risk.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Employer matching and discretionary non-elective contributions, and related earnings are vested over a four-year period as follows:

Less than 2	0%
2	25%
3	75%
4	100%

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at Prime rate, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

#### *Payment of Benefits*

Upon termination of service due to death, disability, or retirement, a participant receives a lump sum amount equal to the value of the participant's vested account balance. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their account in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59½.

#### *Forfeited Accounts*

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,186 and \$36,746 respectively. These accounts will be used to reduce future Employer contributions and to pay administrative expenses. Also, in 2024, Employer contributions were reduced by \$37,288 from forfeited nonvested accounts and \$75 were used to pay administrative expenses.

#### **Note 2 – Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

##### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

##### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

##### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Administrative Expenses***

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- **Level 1** – Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Pooled Separate Accounts** – Valued using the NAV of units held by the Plan at year-end as provided by Principal. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or unfunded commitments. Redemption frequency is immediate.
- **Common Collective Trusts** – Valued using the NAV provided by the fund administrator. NAV is used as a practical expedient to estimate fair value. Although the NAV’s unit prices are quoted on a private market that is not active, the unit prices are based on underlying investments that are traded on an active market (market approach). There are also no restrictions on the NAV price or its equivalent. Participant transactions may occur daily, there are no unfunded commitments, and redemption frequency is immediate. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Note 5 – Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by the Custodians. These include shares of mutual funds and units of pooled separate accounts or common collective trusts. These transactions qualify as party-in-interest transactions as defined by ERISA; such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees, charged by each investment fund, under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### **Note 7 – Tax Status**

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by Principal. The IRS has determined and informed Principal by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, it is not currently the subject of any active audits.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
