### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

#### 1. DESCRIPTION OF PLAN

The following description of the VIA 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan sponsored by VIA Visually Impaired Advancement (the Plan Sponsor and Plan Administrator) with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code. The Plan is funded by employee contributions and discretionary employer profit sharing contributions and covers substantially all eligible employees of the Plan Sponsor. The assets of the Plan are maintained in accounts held by Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA and CREF). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Eligibility**

Employees of the Plan Sponsor are eligible to participate in the Plan after completing one year of service, as defined, and attaining the age of 21. Eligible employees may elect to become participants on the first day of the month immediately following their completion of the eligibility requirement.

##### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, up to the Internal Revenue Service maximum allowed contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan Sponsor may make discretionary profit sharing or matching contributions at the option of the Board of Directors. Contributions are subject to certain limitations. The Plan Sponsor matched 100% of employee contributions up to 4.9% and 4.0% of eligible compensation for the years ended December 31, 2024 and 2023, respectively. Discretionary matching contributions amounted to \$70,000 and \$60,274 for the years ended December 31, 2024 and 2023, respectively.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contributions, (b) Plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Investment Options**

Participants direct the investment of their elective deferrals and discretionary profit sharing contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are vested immediately in their contributions and earnings/losses thereon. Participants are vested in the Plan Sponsor's profit sharing and matching contributions plus actual earnings/(losses) as set forth in the following table:

### **Forfeitures**

Forfeitures of non-vested account balances may be used to pay Plan expenses. Remaining forfeitures will be used to reduce employer contributions. There were no forfeitures used for the years ended December 31, 2024 and 2023.

### **Payment of Benefits**

Upon termination of service due to death, disability, retirement or separation of service, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over other allowed periods. Benefits are determined by the final value of the participant's account at the time of distribution. The normal retirement date is the date upon which a participant reaches age 65.

### **Hardship Withdrawals**

A participant may, under certain defined conditions, withdraw any part of his or her vested account attributable to his or her elective deferral contributions credited to his or her account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investment Valuation and Income Recognition**

The Plan invests in registered investment companies, pooled separate accounts, and fixed annuity contracts. Registered investment companies, pooled separate accounts and non-benefit responsive fixed annuity contracts are reported at fair value. Fully benefit responsive annuity contracts are stated at contract value as this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See note 4 for a discussion of fair value measurements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

### **Benefit Payments**

Benefit payments are recorded when paid.

### **Administrative Expenses**

Certain administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are paid by the Plan and are included in net appreciation in fair value of investments.

### **Income Taxes**

The Plan is exempt from federal income tax under Section 401(k) of the Internal Revenue Code (the Code). The Plan is required to operate in conformity with the Code in order to maintain its tax exempt status for Plan participants. The Plan obtained its latest determination letter on April 2, 2012, in which, the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

### **Estimates**

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. CERTIFIED INFORMATION

Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA and CREF) have certified to the completeness and accuracy of those investments reflected on the statements of net assets available for benefits at December 31, 2024 and 2023, the accompanying schedule of assets (held at end of year), and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, as follows:

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP, are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The value of fixed annuity contracts is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

*CREF registered investment companies:* Valued daily at unit values using quoted market values or values obtained from independent pricing services.

*TIAA registered investment companies (including mutual funds):* Registered investment companies include mutual funds, which are valued at the net asset value of shares held at year-end based on quoted market prices in active markets.

*TIAA fixed annuity contract:* This non-benefit responsive contract has its value calculated based on discounted cash flows using risk-adjusted discount rates. The plan administrator has been advised by TIAA and CREF that the contract value of the non-benefit responsive fixed annuity contracts approximates fair value.

*TIAA pooled separate account:* A separate account invested in real estate properties and real estate related investments that are valued using closing quoted prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the years ended December 31, 2024 and 2023, investments classified as Level 3 within the fair value hierarchy totaling \$46,467 and \$9,232, respectively, were purchased and investments totaling \$9,529 and \$11,829, respectively, were sold.

#### Fixed Annuity Contract

The TIAA Fixed Annuity Contract is a fixed-rate annuity contract. Contributions purchase a contractual or guaranteed amount of future benefits for the investing participant. The contracts guarantee principal and a minimum interest rate and provide the opportunity for additional amounts in excess of the guaranteed rate. TIAA maintains Plan contributions in separate accounts.

The Plan utilizes Retirement Annuity (RA) and Group Retirement Annuity (GRA) contracts with TIAA, which amounted to \$355,595 and \$308,358 at December 31, 2024 and 2023, respectively, and are included in the non-benefit responsive fixed annuity contract on the statements of net assets available for benefits. Under RA contract terms, lump-sum withdrawals are not available. All withdrawals and transfers from the account must be spread over 10 annual installments (over 9 years for withdrawals after termination of employment). Under GRA contracts, lump-sum withdrawals are available within 120 days of termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from the account must be spread over 10 annual installments (over 9 years for withdrawals after termination of employment).

For fixed annuity contracts, TIAA determines contract value, which approximates fair value, using two different methods; a discounted cash flow model and a theoretical transfer value. The discounted cash flow method is calculated using a risk-adjusted market discount rate which correlates closely with the Plan's fixed annuity interest rate. The interest rate associated with the Plan's Fixed Annuity Contract can range from 3% to 7% based on the current market environment. The theoretical transfer value method presumes that contributions into the annuity represent transactions between a willing buyer and seller, and therefore, establish a market.

The fixed annuity contracts guaranteed minimum returns are supported by the TIAA General Account portfolio, which invests primarily in U.S. debt instruments and investment grade corporate bonds; however, is also permitted to invest in higher risk securities, including but not limited to, sub-investment grade corporate bonds, common stock and real estate. The assets and earnings from this portfolio are used to pay the guaranteed interest rate associated with the annuity contracts, as well as future annuity payments.
