## **REPORT OF INDEPENDENT AUDITORS**

To the Participants and Administrator of the  
Boots Retail USA, Inc. 401(K) Plan and Trust

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Boots Retail USA, Inc. 401(K) Plan and Trust (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Boots Retail USA, Inc. 401(K) Plan and Trust’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – PLAN DESCRIPTION**

The following description of the Boots Retail USA, Inc. 401(K) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Agreement (the “Agreement”) for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan available to eligible employees of Boots Retail USA, Inc. (the “Company”). The employees of Aromatherapy Associates, Inc and Soap + Glory USA, LLC, which are related companies, are also eligible to participate in the plan. The Plan provides for contributions pursuant to Section 401(k) of the Internal Revenue Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Fidelity Investments Institutional Services Company is the record-keeper and Fidelity Management Trust Company (“Fidelity”) is the trustee of the Plan.

**Contributions**

Eligible employees may elect to defer eligible compensation on a 401(k) pre-tax basis, a Roth after-tax basis or a combination of both. Eligible employees may contribute between 1% and 90% of their eligible compensation, as defined by the Plan, subject to certain Internal Revenue Service (“IRS”) limitations. The Plan allows up to 100% of bonuses, as defined by the Plan, subject to certain IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various money market and mutual funds options. These funds include a variety of investment options with various objectives and degrees of financial risk.

The Plan uses a Safe Harbor Match formula. The Company Match is equal to 100% of the participant’s elective deferrals that do not exceed 4% of the participant’s compensation. In addition, the Company may choose to make a discretionary contribution on a uniform basis for all participants, which cannot exceed an additional 4% of compensation. The safe harbor contributions shall be determined each plan year. Matching contributions are made to participating employee accounts each payroll period.

**Eligibility**

All employees of the Company who have one month of service and are at least age twenty-one are eligible to participate in the Plan.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their deferral contributions, rollover contributions, and safe harbor matching employer contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the discretionary contribution after three years of credited service. In addition, participants automatically become fully vested in the Company's discretionary contribution accounts upon attaining their normal retirement date while in active service of the Company or upon termination of credited service as a result of death or disability.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The plan did not incur excess contributions for the years ended December 31, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The plan provides for two types of loans: a general-purpose loan and a primary residence loan. Only two outstanding loans are permitted at a time. Plan participants may obtain fixed-rate loans, generally for periods not to exceed five years, against their vested account balances provided that certain conditions are met. If the loan is for the purchase of a primary residence, provided that approval is granted by the Plan's trustees, the repayment period can extend up to ten years. The notes are secured by the balance in the participant's account and bear reasonable interest rates, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions. At December 31, 2024 and 2023, interest rates on outstanding participant loans receivable ranged from 4.25% to 6.5% per annum.

**Payment of Benefits**

On termination of service due to death, disability or retirement, the participant's account becomes fully vested and he or she may elect to receive either a lump-sum amount equal to the participant's vested interest, or annual installments over a number of years, as defined in the Plan or the Code. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also provides for in-service withdrawals by qualified participants.

An active participant may also elect to seek a hardship withdrawal, as defined in the Plan document, in certain cases of financial need.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment fees are Investment-related expenses are included in net appreciation in fair value of investments. Investment management and advisory fees are deducted from participants' accounts on a pro-rata basis. The Plan paid fees of \$57,495 and \$55,104 during the years ended December 31, 2024 and 2023, respectively, which are rendered by parties-in-interest. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Fees paid by Plan participants in 2024 were as follows:

- Loan check delivery - \$ 25 per check
- Initial Loan Setup - \$75 per loan
- Loan Maintenance Fee - \$25 annual fee/deducted quarterly
- Automated Minimum Required Distribution Service fee - \$25 for each distribution year

**Forfeitures**

At December 31, 2024 and 2023, forfeiture accounts totaled \$210 and \$1,144, respectively. The forfeiture accounts may include forfeitable amounts, uncashed participant checks and excess Company contributions. Forfeitures will be first used to pay administrative expenses, with remaining amounts being used to reduce future employer contributions. The Plan did use \$1,109 and \$0, forfeitures to offset expenses in 2024 and 2023, respectively.

**Summary of Plan Amendments**

Effective May 1, 2019, the Plan adopted an auto-enrollment provision whereby all newly eligible employees become automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. In addition, the Plan amended the service requirement from three months to one month. These provisions to the Plan are effective for employees hired after May 1, 2019.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Delinquent Contributions**

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company remitted any related lost earnings to the affected participants into the Boots Retail USA, Inc. 401(K) Plan and Trust.

**Subsequent Events**

Subsequent events were evaluated through September 18, 2025, which is the date the financial statements were available to be issued.

There were no material subsequent events or transactions that required recognition or disclosure in the financial statements.

**NOTE 3 – CERTIFIED INVESTMENT INFORMATION**

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, investment information and related activity certified as accurate and complete by a qualified institution need not be subjected to independent audit. The Plan administrator has obtained a certification from Fidelity Management Trust Company, as trustee of the Plan, that the following information included in the Plan's financial statements and supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as of December 31, 2024 and 2023
- Plan transactions related to investment income, securities transactions and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023
- Schedule H, line 4i – Schedule of Assets (held at end of year) as of December 31, 2024

Accordingly, at the request of the Plan administrator, the Plan's independent certified public accountants performed no procedures on investment information and related activity, other than to agree the information to the trust statements certified by the Plan's trustee and provided to them by the Plan administrator.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The fair value measurement under FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used in Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

*Level 2 Fair Value Measurements*

The fair value of corporate bonds and U.S. government securities are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer.

For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$27,864 and \$25,484 for the years ended December 31, 2024 and 2023, respectively. Cambridge Investment Research provides investment advisory services to the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment advisory services amounted to \$29,631 and \$29,621 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer's discretionary contributions. The complete provisions covering Plan termination are included in the Plan document, which is available to all participants.

**NOTE 7 – TAX STATUS**

The Plan received a favorable Letter of Determination from the Internal Revenue Service ("IRS") dated June 30, 2020, that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the
